#### 12. Small Area Disadvantaged Fund (for consultation/discussion)

Surrey County Council's Leader has invited all 11 local committees to bid against a £200k budget for projects to help small disadvantaged areas. Guidance on criteria and application forms are available to be returned to the Local Partnership Team **by 1 October 2010** so that all members can agree at the committee on **20 October 2010** which bid or bids to submit. Guidance includes preference being given to where partners have progressed localism and total place, and where wider partner and community involvement is demonstrated.

Committee members are aware that Sheerwater and Maybury is one of Surrey Strategic Partnership's four priority areas and there are a number of programmes of work in place. Bids from members for this area are not precluded, and other pockets of relative disadvantage include Lakeview prioritised by the Woking Partnership alongside Sheerwater and Maybury - Old Woking, and Barnsbury.

To date the Local Partnership Team is aware of a proposal being developed by the local member for Old Woking, and all members are reminded to promote and support applications for the fund for consideration at their next meeting. #### a. Woking Library

Woking Borough Council are currently developing and agreeing plans to remodel parts of the town centre, and as part of this, planning permission for the area around the Peacocks was granted on 15 June 2010.

Woking Borough Council have approached and are in discussion with Surrey County Council regarding options incorporating the area around Woking library. The planning application on the 15 June states that future stages of the town centre strategy could include remodelling the library area to enable a restaurant facing onto the town square.

If on preliminary feasibility work such a proposal looks likely to be explored further, it would require the provision of a newly formed entrance and face to the library along Gloucester Walk, whilst retaining overall floor space of Woking Library and retaining its location. A refit of the library to current county standards, and open consultation, including with the Local Committee would also be required.

#### b. Martyrs Lane Community Recycling Centre (CRC)

Surrey County Council's Planning & Regulatory Committee approved the revised planning application for the redevelopment of the Community Recycling Centre at Martyrs Lane, Woking on 18th June 2010.

The site is being redeveloped to provide residents with a modern, accessible and user-friendly facility. The improvements will include:

- A new split-level design to enable easy access to the recycling containers, eliminating the need for steps;
- Separate entrances for the public and HGVs to help alleviate queuing;
- Additional parking will also be created; increasing the number of spaces from 20 to 45.

Work is planned to start on the site on 12 July 2010. It was hoped that the site could have provided some sort of temporary service, but this has not been possible. As a consequence the site will have to be closed to the public for the duration of the works and members of the public will be directed to the nearest alternative sites at Lyne, near Chertsey and Slyfield, Guildford. To accommodate the extra demand, the Lyne and Guildford sites will remain open until 7:30 in the evening seven days per week up until the end of September. The works at Martyrs Lane are expected to take 22 weeks and be completed by mid December 2010.

#### c. Bus Review

Following consultations during the first stage of a countywide bus review (which included the eastern part of Woking), changes to the way buses are run in Surrey have been agreed to ensure services operate where they are needed most. These changes will be implemented from 28 August 2010.

As part of the wider Bus Review, the County Council is currently consulting schools and parents about the School Special services' future (public buses that serve particular secondary schools). Recommendations will be made to cabinet on 13 July 2010, and any changes to services will take place from summer 2011. All current services will run during the 2010/11 school year.
