PE 2. Small Disadvantaged Areas Fund

On 20 October 2010, the Local Committee agreed to put forward four bids to the Small Disadvantaged Areas Fund. The decision of the Panel was announced at the County Council meeting on 14 December 2010. The following three Woking bids were successful in being allocated funding:

Bid from Bishop David Brown School - Prevention of young people from becoming NEET (Not in education, employment or training) Applied for: £11,750 – awarded £11,750.

Internet based community radio station for Sheerwater and Maybury Applied for: £12,960 – awarded £10,000

Partnership for the Regeneration of Old Woking Applied for: £80,000 – awarded £36,000

The funding will be released in the next financial year, and must be spent by April 2012. The Local Committee will be kept informed of the outcomes of these projects.

a. Bus Passenger Information - Advance Notice re Elm Bridge

Elm Bridge in Kingfield Road will be closed for reconstruction for 6 months from 9th February 2011. Bus services will be altered.

- Arriva service 34 will not serve Westfield or Kingfield Green
- Arriva service 562 will be diverted via Westfield & Mayford
- Countryliner services 462/463 will be diverted via Mayford but will serve Rydens Way area and Kingfield Green.
- A special Shuttle bus will link Kingfield Green and Westfield with Mayford (change there for Guildford) and Woking Town Centre

There will be changes to routes, timetables and bus stop arrangements. The bus stops at the Leisure Centre entrance (Kingfield Green) will be temporarily closed

c. Residents Parking Permits

Following the countywide consultation on the cost of on street residents parking permits carried out during October 2010, the following has been agreed by the County Council's Cabinet Member for Transport:

- 1. £50 per year for the first residents parking permit
- 2. that any subsequent parking permits issued to the same household will be £75 (except Guildford where the existing £80 upper fee will remain)
- 3. that daily residents permits will be £2 each
- 4. that any replacement permits will be £15.

It is expected that applicants for permits will be charged the new fee from 1 March 2011.

d. Review of On-Street Pay and Display Parking Charges in Woking

The Local Committee (Woking) agreed a public consultation about changes to on street pay and display parking charges in Woking Borough at its meeting on 20 October 2010. This is currently out for public consultation until 27 February 2011. Any comments should be sent to:

e. Bus Review - Phase 2

Phase 2 of the Surrey County Council Bus Review looked at bus services in the western part of Woking, Surrey Heath and Tandridge. The three month consultation period on possible changes to bus routes ended on 31 January 2011.

Work will now begin to re-tender the routes subsidised by the County Council. Once this process is complete the Surrey County Council Cabinet will make the decision on which routes will be removed, retained, amended or enhanced, based on the budget available, for implementation in September 2011. After this decision, a timetabling and communications process will inform passengers about route and/or frequency changes in their area.

A summary of the feedback from the consultation and details of the revised services and the cost involved will be submitted to Surrey County Council's cabinet in June, the date for which has not yet been set.
