Summary

On 22 November 2016, Cabinet considered a range of savings proposals for the Special Educational Needs Budget for 2017/18. Savings of £10m were required for expenditure to remain within the level of available Dedicated Schools Grant (High Needs Block) funding.

The Cabinet resolved that "the approach to identifying and delivering £10m savings in SEND services in 2017/18, as described in paragraph 13 of the submitted report, be approved and final approval of the savings be delegated to the Assistant Director, Schools and Learning, the Leader of the Council and the Cabinet Member for Schools, Skills and Educational Achievement. (Any proposal that requires a public consultation will be referred to Cabinet)."

Since September 2016, officers have worked with a group of members of the Surrey Schools Forum to develop a range of proposals for savings, some of which were detailed in the Cabinet paper. Work in all savings areas has progressed and are ready for implementation. It is expected that the 2017/18 funding gap (originally $\pm 10m$) will largely be met by $\pm 9m$ of savings.

Any under or overspends on the Dedicated Schools Grant High Needs Block will be managed across the financial years, although this requires schools forum approval. Approval in principle to this approach will be sought from schools forum on 17 July.

Key to a more equitable process of resource allocation across SEND, is a review of service bandings and associated funding and more rigorous controls around ISPSB. The service requests approval from the Leader to undertake the banding review and implement the required ISPSB controls.

Summary of any financial implications

In order for expenditure in Special Educational Needs to be sustainable within the agreed level of DSG funding for the High Needs Block in 2017/18, a reduction of £9m is required.

A review of the service bandings and implementation of controls around the ISPSB, will potentially deliver further savings in 2017/18 and 2018/19 - amount to be determined following preliminary work during the review.
