7	ROAD SAFETY POLICY	<p>The Local Committee [Mole Valley] agreed:</p> <p>To endorse the draft road safety policies prior to their submission to Cabinet subject to the following comment:</p> <p>In the Setting Local Speed Limits Policy, Step 6, the Local Committee feel that they should be able to agree an alternative option not recommended by the Area Highways Manager and the decision should not be referred to the Cabinet Member for Transport, Highways and Environment.</p> <p>Reason for Decision: Local Committees are responsible for most highway and transport matters in their areas, including speed limits and road safety measures outside schools and were therefore invited to</p>

11	SPOOK HILL BUS CLEARWAY	<p>The Local Committee (Mole Valley) agreed:</p> <p>That a clearway is introduced at the existing southbound bus stop in Spook Hill, south of the junction with Holmesdale Road (opposite the shops), the restriction to be 7am until 7pm daily.</p> <p>Reasons for decision: To prevent obstruction of the bus stop by inconsiderate parking and allow penalty charge notices to be issued to offending vehicles.</p>
12	WEST STREET, DORKING	<p>The Local Committee (Mole Valley) agreed to:</p> <ul style="list-style-type: none"> (i) approve the proposal to widen the footways in West Street, Dorking, as shown in Annexes 1 and 2, for public consultation; and (ii) authorise delegation of authority to the Area Team Manager in consultation with the Chairman and Vice-Chairman of the Local Committee and the local Divisional Members to consider the results of the consultation and make a decision on whether or not to implement the proposal, subject to funding from developer contributions. <p>Reasons for decision: To progress the proposed footway improvements for West Street, Dorking and facilitate implementation before the 2014 Christmas embargo on highway works.</p>
