4 LEATHERHEAD TRINITY PRIMARY SCHOOL

Leatherhead Trinity Primary is a two-form entry (2FE) school operating across two sites in Leatherhead providing a total of 420 places plus a nursery and children's centre. 13 of the classrooms are located at the Woodvill Road site providing 390 places including a 30 place reception class. The remaining 30 place reception class is in a single classroom located at the Aperdele Road site.

5 TRUMPS GREEN INFANT SCHOOL, ENGLEFIELD GREEN

(Pages 9 - 14)

Trumps Green was a one-from entry infant school (90 places) which was reorganised in 2012 to a two-form entry infant school (180 places) an increase of 90 places. In September 2014 the school will reach the capacity of 180 places. In 2013 Phase 1 of the project delivered an initial 60 places. The school requires an additional classroom, group room and associated toilets to be able to accommodate the final 30 places of the expansion.
