<b>6a</b>	PETITION RESPONSE: REQUEST FOR PEDESTRIAN CROSSING ON HURST ROAD (EXECUTIVE FUNCTION)	The Local Committee resolved to:  <b>(i) Fund</b> a feasibility study for a zebra or pelican crossing on the A3050 Hurst Road, West Molesey, outside the new Hurst Park Primary School, in view of an anticipated reduction in the number of pedestrians needing to cross the road at this location, <b>subject to the decision at Item 13, whereby normal practice would be for it to be funded from the local Member’s share of the highways budget.</b>  Reason: to identify whether a crossing in this location would be feasible, should funding for the crossing become available and its implementation be agreed.
