That the county council’s intention to introduce the proposals in Annex 1 is formally advertised, and subject to statutory consultation.</li> <li>ii. That if necessary, adjustments can be made to the proposals by the parking team manager in consultation with the chairman, vice-chairman and county councillor prior to advertisement.</li> <li>iii. That if no objections are received when the proposals are advertised, the traffic regulation orders are made.</li> <li>iv. That if there are unresolved objections, they are dealt with in accordance with the county council’s scheme of delegation by the parking team manager, in consultation with the chairman/vice chairman of the committee and the appropriate county councillor.</li> <li>v. That if necessary the parking team manager will report the objections back to the local committee for resolution.</li> <li>vi.
