# 8 A25 GODSTONE ROAD, BLETCHINGLEY SPEED LIMIT REVIEW (EXECUTIVE FUNCTION)

The speed limit on the A25 Godstone Road in Bletchingley was reduced from 50mph to 30mph in 2012. Concerns have been expressed by Surrey Police that a section of the 30mph speed limit is not effective. Therefore, a speed limit assessment has been carried out following the process set out in Surrey's policy "Setting Local Speed Limits". As a result of this assessment it is proposed that the existing 30mph speed limit in a section of Godstone Road and also in the un-named service roads fronting Chevington Villas and Sunnybank Villas, be increased to 40mph.

This report seeks approval for the changes to the speed limit in accordance with Surrey's policy.

# 9 FARLEIGH ROAD WARLINGHAM PERMISSION FOR REMOVAL OF SPEED CUSHIONS (EXECUTIVE FUNCTION)

Traffic calming measures in Farleigh Road, Warlingham between the junctions of the B269 Limpsfield Road and Sunnybank consist of a series of speed cushions and raised tables. # 13/18 APOLOGIES FOR ABSENCE [Item 1]

# 14/18 MINUTES OF PREVIOUS MEETING [Item 2]

The minutes from the previous meeting on the 20 April 2018 were agreed as a true record and signed by the Chairman.

# 16/18 PETITIONS [Item 4]

**Declarations of Interest: None** 

Officers attending: Zena Curry, Area Highways Manager

The lead petitioner Mr John Fairclough, Chairman of Charters Village Residents Association presented the petition. He told the committee that concerns regarding speed on this road were first raised by FAST (Felcourt Against Speeding Traffic in 2012, and a petition was brought to the Local Committee in 2014 requesting traffic calming measures on the road. Due to the elderly people leaving at Charters Village they often struggle with crossing

the road to the bus stop and it is of great concern that the speeds are too fast, there needs to be a physical change in order to make drivers reduce their speeds. He suggested that painting hatching to reduce the width of the road may reduce the speeds on this road.

The Area Highways Officer, thanked the lead petitioner for their attendance and for the work they had done on their petition and for considering lower cost options. For comparison purposes for average speeds, the calculation does not include the speeds above the 85<sup>th</sup> percentile. The Area Highways Manager was aware that work was being done to look at the accessibility of bus stops and she would look into this bus stop to see where it is placed on the programme.

# **Members Discussion- Key Points**

The following points were raised:

- The Divisional Member confirmed she would support any speed reductions on this road, not just for Charters Village but for all residents in the area. Whilst she appreciated the budget constraints of the Committee, she asked if she could use some of her Member Highway Fund to install a sign warning drivers to look out for elderly people.
- Would all residents to sign the petition set up by a SCC Member for fairer funding in Surrey. Funding for Highways for Surrey from central Government was £11million lower compared with neighbouring Counties. Should the petition reach 100,000 signatures will be debated in the House of Commons.
- Concerns over the pavement from Charters Village to the bus stop and whether the road is gritted during the winter. The Officer advised she would also look into the gritting of the road and also the pavement programme.
- Whether the developer could be asked to fund improvements. The Officer advised that the layout and speeds of the road would have been taken into consideration when the when planning permission granted. Mrs Lesley Steeds confirmed she was aware that the S106 funding was very small for this site but she had spoken to the Director of the Village and £5000 was previously ring fenced for if improvements were required. She was aware that a planning application was put forward for a further 36 units which would mean CIL funding could be available.

# 17/18 FORMAL PUBLIC QUESTIONS [Item 5]

One formal public question had been received. The response was provided in the supplementary papers.

Cllr Nicole Morrigan attended on behalf of Caterham Valley Parish Council. She felt there had been a misunderstanding in the response as the request was for a pelican crossing where a button needed to be pushed and not a re phasing of the lights.

# **Members Discussion - Key Points**

The following points were raised:

- The Divisional Member, Mr David Lee agreed that the request would not be to stop the flow of traffic. He would like to have a discussion with officers regarding a box junction/keep clear.
- Would the Parish would be willing to put in any of their own funds in order to move a scheme forward. The Parish Councillor confirmed she would discuss at a council meeting to see if this was possible.

The Officer confirmed she would look into the proposal for a push button crossing if it could be part funded. Although this would not be a full feasibility study which would take into consideration full cost it would be a broad figure to base a discussion for joint funding on.

The Officer introduced the item explaining that this document monitors progress against the decisions that the Local Committee has made.

# **Member Discussion - Key Points**

The following points were raised:

- Mr Chris Botten offered to speak with the District to assist with releasing the funds from S106 for a crossing point on Banstead Road.
- The 'keep left' signs in Blindley Heath near the request for a crossing were still missing.
- Concern that the speed table in Dormansland was desperately needed and the Parish have offered £12,500 towards the scheme. The Area Highways Manager advised that there is not the current level of funding required for this scheme however it remains on the list should further funding become available.

 The Rook Lane scheme update is missing from the end of the Banstead Road update. The Area Highways Manager confirmed that it had not been forgotten and apologised as appeared to be an admin error from the tracker. Mr Botten, Cllr Cannon and the Area Highways Manager would meet outside of the meeting to discuss the scheme further.

The Committee agreed that the two items marked as closed, the on street parking enforcement report and the Farleigh road crossing point be removed from the tracker as complete.

# 20/18 ALLEGED PUBLIC RIGHTS OF WAY BETWEEN BLUEHOUSE LANE AND SILKHAM ROAD, OXTED (OTHER COUNTY COUNCIL FUNCTION) [Item 8]

**Declaration of Interest:** None

Officer attending: Debbie Prismall, Senior Countryside Access Officer

# **Public Speakers:**

Mrs Jackie Wren spoke in support of the application, and made the following points:

- This was a popular path with a variety of users such as school children, dog walkers, runners and those enjoying the countryside.
- 70 residents gave evidence that they had used the paths, some of which for 40 years.
- It provided beautiful walks and enjoyed by many local residents.

Mr Berryman spoke in objection as the land owner and farmer of the field L-N. He made the following points:

- He bought the land in 2012, and confirmed when purchased with the County Council that there was no right of way across the land.
- Shortly after buying the farm, he cleared the land and erected fences all around the field to keep his livestock safe. Mr Berryman stated that before the land may have looked unused but since 2012 it has been part of his farm.
- As he does not live on the site he cannot always tell people that the land is private but when he does he is often met with hostility.
- A young calf was hurt and killed and he suspected that a dog being walked across the land may have frightened the cows and the calf was pushed into the fence.

Ms Katie Lamb (representing Mr Charlie Tory and Oxted Residential Ltd) spoke in objection and made the following points:

- The report does not give a balanced view.
- The fences had been regularly cut and damaged so people were trespassing on the land.
- The user evidence forms are not credible as many of those were not listed on the electoral roll or prepared to provide evidence in an appeal hearing.
- The applicant is part of a political group, OLRG who are against development in Oxted so wish to bring the application forward to stop development in the local area.
- Mr Tory had been unable to attend due to personal reasons, and officers had declined the request to defer the decision.

The applicant Mr Peter Giles took the opportunity to respond to the objections raised. He made the following points:

- For the middle field to be cleared by the farmer, machinery would have been required to enter at point L and therefore fencing would not have been erected at this time.
- Should a planning permission be given for a development the footpath could be diverted, so to stop any building work would not be a reason for the application.
- The objectors raise assertions that local residents are lying on their forms and not following the Countryside code. Regarding the land registry details these did not give information of those who were renting property.

The Officer responded to the points raised. She stated that from those who completed the user evidence forms, 10 were interviewed by officers. The county council is bound by legislation not to consider matters of safety or convenience when considering an alleged right of way application. The County Council had deferred this decision from the March meeting as the objector submitted a statement which had to be investigated by officers, and advice from the legal department at Surrey was sought. As the decision had already been deferred once and all notified of this June date on 1 February, officers considered that those wishing to speak had sufficient notice of the timing of the meeting, and had been advised that a statement could be read out on their behalf if they were unable to attend in person. The Officer reiterated that if Members decided on the evidence to make an order this decision would be the start of the legal process. There would be a further 6 week consultation period for objections to be raised before being submitted to the Secretary of State for a possible public inquiry, where an inspector would determine the case.

# **Members Discussion: Key Points**

- Members agreed they felt great sympathy for the farmer and his situation.
- Members noted they were bound by the legislation to consider whether the public had acquired rights over the past 20 years and they

did not consider that they had sufficient legal ground to overturn the officer's recommendations in this regard.

#### Resolution

The matter was put to the vote with a show of hands.

Members in favour of recommendations (i) and (ii): 10 Members opposed to recommendations (i) and (ii): 0 Members abstaining: 0

The Local Committee (Tandridge) AGREED that:

- (i) Public Footpath rights are recognised over the routes shown on Drawing no. 3/1/31/H11a as:
  - a) Claimed footpath no. 612 between points A A1 B C D E L M K N F
  - b) Claimed footpath no. 613 between points G H D and E I I1 J
  - c) Claimed footpath no. 614 between points H C and B I

and that a MMO under sections 53 and 57 of the Wildlife and Countryside Act 1981 be made to modify the Definitive Map and Statement for Surrey.

(ii) In the event of the County Council being directed to make a MMO by the Secretary of State following an appeal by the claimant, the County Council as surveying authority will adopt a neutral stance at any Public Inquiry or Hearing, making all the evidence available to help the inspector determine the case.

## Reasons for recommendation

The County Council has a duty under Section 53 of the Wildlife and Countryside Act 1981 (WCA1981) to modify the Definitive Map and Statement (DMS) if it discovers evidence which on balance supports a modification.

# 21/18 OXTED CHALKPIT, CHALKPIT LANE, OXTED (DECISION - SERVICE MONITORING AND ISSUES OF LOCAL CONCERN) [Item 9]

As the Chairman is a member of the SCC Planning and Regulatory Committee, which is due to consider the issues around the Chalkpit in the near future, she handed over to the Vice- Chairman and left the room for the duration of this item.

# Petition: Public Questions, Statements: None

The Vice-Chairman welcomed Woldingham Parish Council to the meeting, and thanked them for attending for this item. The Vice-Chairman reminded Members that as this is a current planning application they must be mindful of the questions asked of the Officer as she will not be able to express an opinion only be able to respond to questions of fact. The Local Committee has no status in respect of the determination of the application, and consideration of the merits or otherwise are solely a matter for the Planning and Regulatory Committee.

The Officer introduced the report, stating that the application for a ROMP is to modernise the planning conditions attached to the permission for the quarry and therefore cannot be refused. The quarry operators have permission to operate there.

There has been delay hearing the item at the Planning and Regulatory Committee as further evidence is sought from the applicant as to the impact of their operation. Whilst the time taken to agree this is regrettable, SCC need to ensure that the decision made does not affect the asset value of the site nor future economic viability.

# **Members Discussion- Key Points**

The following points were raised:

- Mr Cameron McIntosh, Divisional Member expressed that he does appreciate the frustrations of the local residents but also understands the complex constraints that the county council are bound by, as they have to work within the set guidelines set by law. There are currently no conditions in place to limit the number of vehicle movements, following the Environment Agency's decision to increase the amount of permitted infilling, and he is working hard to ensure that there is something in place to limit the local impact on residents.
- Whether the Environment Agency consult with SCC before agreeing to double the tonnage. The Officer confirmed that they did not, however nor were they obliged to.
- Concerns were raised that the counters were not in place to monitor and deal with what had been imposed on local residents and Surrey.
- Members were frustrated that the Environment Agency had determined this without consultation, and urged the MP to do more to both encourage the EA to reconsider this decision, and to take forward the wider issues around ROMP legislation in parliament
- In relation to recommendation ii, members asked how the width restrictor would improve the matter. The Officer advised that at the moment there is no physical width restrictor, only a sign which local residents state is being ignored as lorries travel down from The Ridge. Should a restrictor be put in place SCC would need to ensure it is a restriction that can be objectively defended at an enquiry. Whilst there is no evidence to suggest they are lorries travelling to the quarry, if they are indeed travelling to the quarry by that route, they are in breach of the conditions of the Traffic Regulation Order.
- The Committee were advised by the Chairman of Woldingham Residents Association that the signs at the top of Chalkpit Lane advising of a width restriction had been turned around. The Area

Highways Manager advised that she would send someone to the site and rectify.

#### Resolution

The Local Committee (Tandridge):

- (i) NOTED the contents of the report.
- (ii) AGREED to add a feasibility study to the Integrated Transport Schemes (ITS) list for consideration for future funding. The feasibility study would investigate the possibility of installing a physical width restriction on Chalkpit Lane between the chalkpit entrance and The Ridge.

The Area Highway Manager advised that the culvert on Bones Lane needed to be reinforced and therefore would not currently meet the criteria for the major projects budget so Divisional Members asked to use their allocation to maintain it.

# 24/18 ON STREET PARKING ENFORCEMENT UPDATE (SERVICE MONITORING AND ISSUES OF LOCAL CONCERN) [Item 12]

The Parking Team Manager advised that unfortunately an officer from Reigate and Banstead Borough Council was not able to attend the meeting. The current agency agreements for on- street parking enforcement will end on the 31 December 2018. The Surrey County Council Cabinet Member, Colin Kemp is currently in discussion with Tandridge District Council Officers to discuss future arrangements.

# Members discussion- Key points

- Mr Chris Botten advised that his motion to Tandridge District Council
  of no confidence in the current arrangements had passed
  unanimously. He felt new arrangements need to meet local need.
- A question was raised with regards to the number of visits and tickets issues which would suggest the way enforcement officers carry out their routes, appeared to not be most effective. This lead to the feeling that many residents would take the risk that they would not be ticketed and could park where they liked as unlikely to be caught.
- An additional recommendation was proposed by Chris Botten ad seconded by Michael Cooper.

# Resolution

The Local Committee (Tandridge):

- (ii) AGREED to express their concerns at the lack of flexibility and responsiveness to local need of the current on street parking enforcement arrangements, and resolves to endorse the District Councils motion of no confidence.

# **SUMMARY OF ISSUE:**

The speed limit on the A25 Godstone Road in Bletchingley was reduced from 50mph to 30mph in 2012 and engineering measures were installed to support the reduced speed limit. A speed limit assessment was carried out to investigate the effectiveness of the speed limit change, following the process set out in Surrey's policy "Setting Local Speed Limits". As a result of this assessment it is proposed that the existing 30mph speed limit in a section of Godstone Road and also in the un-named service roads, be increased to 40mph. This report seeks approval for the changes to the speed limit in accordance with Surrey's policy.

The report has been deferred from the meeting on 9 December 2016 pending completion of the residential development in Knights Way. It was deferred for a second time at the meeting 22 June 2018, pending gathering of additional information.

# **RECOMMENDATIONS:**

# The Local Committee (Tandridge) is asked to:

- (i) Note the results of the speed limit assessment undertaken;
  - a. Agree that, based upon the evidence, the speed limit be increased from 30mph to 40mph in the section of the A25, Godstone Road between the existing 30mph speed limit terminal signs in line with the property boundary between 14 Sunnybank Villas and Waterhouse Villa and a point 15m north-east of the north-eastern building line of the property Avalon; in the un-named service road fronting the properties Laburnums, Moorings, Dormers and Longacre; and in the un-named service road fronting the properties Somerstone, Pennyacre, Tonbridge and Waterhouse Villa and nos. 9 14 Sunnybank Villas, in accordance with Surrey's policy "Setting Local Speed Limits";
  - b. Or refer the decision whether to increase the speed limit in the section of the A25 Godstone Road detailed above to the Cabinet Member responsible for road safety.

- (ii) Authorise the advertisement of a notice in accordance with the Road Traffic Regulation Act 1984, the effect of which will be to implement the proposed speed limit change, revoke any existing traffic orders necessary to implement the change, and, subject to no objections being upheld, that the order be made:
- (iii)Authorise delegation of authority to the Area Highway Manager in consultation with the Chairman, who is also the local divisional Member and the Vice-Chairman of the Local Committee to resolve any objections received in connection with the proposal.

# **REASONS FOR RECOMMENDATIONS:**

To enable a change in the speed limit on the A25 Godstone Road and un-named service roads, in accordance with Surrey's policy "Setting Local Speed Limits". The previous speed limit reduction from 50mph to 30mph with supporting engineering measures has been shown to be ineffective. If a speed limit is set too low and is ignored then this can result in the majority of drivers criminalising themselves and can bring the system of speed limits into disrepute.

# 1. INTRODUCTION AND BACKGROUND:

- 1.1 In November 2012 a speed limit order was made to decrease the 50mph speed limit on the A25 Godstone Road in Bletchingley and the un-named service roads fronting Chevington Villas and Sunnybank Villas from 50mph to 30mph. This order was made following agreement by Tandridge Local Committee at their meeting in December 2011 that the speed limit be reduced. The speed limit policy in force in 2011 did not support a speed limit reduction to 30mph by signs alone. However supporting engineering measures of road markings and coloured surfacing to support the new speed limit were implemented as part of the scheme.
- 1.2 Surrey's policy for determining speed limits was updated in July 2014. The aim of Surrey County Council is to set speed limits that are successful in managing vehicle speeds and are appropriate to the main use of the road. The policy states that after a scheme is implemented, surveys should be carried out to check whether the scheme has been successful in reducing vehicle speeds towards compliance with the new lower speed limit. If the scheme has not been successful in reducing vehicle speeds then a further report should be brought to the Local Committee. Consideration should either be given to any further engineering measures that may be possible to encourage greater compliance with the speed limit or alternatively the new lower speed limit could be removed and the road returned to the original or different higher speed limit. It should be noted that some forms of traffic calming will not be appropriate on major routes with large traffic flows and heavy vehicles such as the A25.
- 1.3 A speed survey to assess the effectiveness of the speed limit reduction, implemented in 2012 was carried out in July 2016 the A25 Godstone Road. The existing speed limits are shown in **Annex 1**.
- 1.4 The policy also states that the length of road over which a speed limit change is being considered should be at least 600m. This is to ensure against too

- many speed limit changes that could be confusing to the motorist within a short stretch of road. However is some cases a slightly shorter length may be suitable where the existing highway or roadside feature provides a natural threshold which may complement a change in speed limit.
- 1.5 Dragons teeth road markings and red surfacing with a 30mph roundel were implemented when the speed limit order was made in December 2012.
- 1.6 A report recommending a reduction in the speed limit on the A25 Godstone Road in Bletchingley was considered by Tandridge Local Committee at their meeting on 23 September 2016. At that meeting Officers were asked to carry out consultation with affected residents. The results of this consultation are outlined in section 4 of this report.

# 2. ANALYSIS:

- 2.1 A seven day automatic survey of vehicle speeds was carried out during July 2016 on Godstone Road. This survey was carried out before the utility works in Godstone Road commenced. The location of the speed survey is shown in Annex 1.
- 2.2 A Speed Detection Radar (SDR) survey to measure vehicle speeds was carried out by the Police between 31 January 2018 and 7 February 2018. The location of this survey is shown in **Annex 1**.
- 2.3 The results of both surveys show that the dragons teeth road markings, coloured surfacing and 30mph roundel that were implemented in 2012 have not resulted in changing driver behaviour and reducing vehicles speeds as much as had been hoped. It is acknowledged that mean speeds have reduced from the 44.1mph mean speed measured in 2011. However they have not reduced to a level that is required for a 30mph speed limit.
  - Existing mean speeds have been compared with the new speed limit. The speed limit policy sets thresholds below which speed limits can be changed by signs alone. For a rural village speed limit change to 40mph, the threshold is set at 46mph. If the measured existing mean vehicles speeds are above the threshold then a lower speed limit cannot be implemented without consideration of supporting engineering measures.
- 2.4 Table 1 records the results of the speed survey, compares these with the current limit and the proposed limit and states whether they comply with the policy to change a speed limit by signs alone.

A plan detailing the proposed new limit is attached as **Annex 2**.

- 2.5 It should be noted that as previously it is also proposed that the un-named service roads fronting Chevington Villas and Sunnybank Villas be included as part of the speed limit order.
- 2.6 The proposed 40mph speed limit in Godstone Road will slow westbound traffic on the approach to Bletchingley, acting as a buffer between the 50mph and the 30mph sections of Godstone Road.
- 2.7 The length of the proposed 40mph speed limit is approximately 400m. It is acknowledged that this is a shorter length than 600m as stated in the policy "Setting Local Speed Limits". However the northern boundary of Sunnybank Villas provides a natural threshold that complements the change in speed limit
- 2.8 Recorded personal injury collisions on the roads under consideration have been investigated. During the 3 year period between March 2015 and February 2018, the latest period for which data is available, there have been no reported personal injury collisions.

# 3. OPTIONS:

## **3.1 OPTION 1**

Increase the speed limit of the following roads from 30mph to 40mph to comply with Surrey's speed limit policy:

A25, Godstone Road between the existing 30mph speed limit terminal signs in line with the property boundary between 14 Sunnybank Villas and Waterhouse Villa and a point 15m north-east of the north-eastern building line of the property Avalon

The un-named service road fronting the properties Laburnums, Moorings, Dormers and Longacre

The un-named service road fronting the properties Somerstone, Pennyacre, Tonbridge and Waterhouse Villa and nos. 9 – 14 Sunnybank Villas

# **3.2 OPTION 2**

Members refer the decision as to whether to increase the speed limit of the following roads from 30mph to 40mph to comply with Surrey's speed limit policy to the Cabinet Member responsible for road safety:

A25, Godstone Road between the existing 30mph speed limit terminal signs in line with the property boundary between 14 Sunnybank Villas and Waterhouse Villa and a point 15m north-east of the north-eastern building line of the property Avalon

The un-named service road fronting the properties Laburnums, Moorings, Dormers and Longacre

The un-named service road fronting the properties Somerstone, Pennyacre, Tonbridge and Waterhouse Villa and nos. 9 – 14 Sunnybank Villas

# **4. CONSULTATIONS:**

# Residents

- 4.1 In October 2016 a total of 54 letters and questionnaires were delivered to residents of the A25 Godstone Road, Bletchingley between Candlestick Cottage and Waterhouse Villa.
- 4.2 Copies of the consultation letter and questionnaire are attached as **Annex 3** 39 responses have been received giving a response rate of 72%.
- 4.3 The results of the questionnaire are summarised as follows:
  - 13% AGREED with the proposal to change the speed limit from 30mph to 40mph (5 responses)
  - 87% DISAGREED with the proposal to change the speed limit from 30mph to 40mph (34 responses)

Table 2 below gives a summary breakdown of the comments made on the questionnaires returned

It should be noted that some residents made several comments on their questionnaires and some residents made no comments.

# **Tandridge District Councillors**

- 4.4 A copy of the letter and questionnaire was forwarded to the three Tandridge District Councillors for the Bletchingley and Nutfield Ward. All three Councillors had similar comments which are summarised below:
  - Speed limit was decreased to address a genuine issue affecting the residents of that part of Bletchingley
  - Concerns about increased traffic speeds if the speed limit is increased to 40mph
  - Reduce speed limit on 50mph section of A25 between Bletchingley & Godstone to 40mph
  - Defer decision on speed limit until after development at Knights Garden Centre site complete
  - Concerns about lack of enforcement of current speed limit

#### **Parish Councils**

- 4.5 Bletchingley Parish Council was consulted, and Godstone Parish Council contacted Officers, both Parish Councils had similar comments which are summarised below:
  - Consider additional traffic calming measures
  - Carry out a speed survey of 50mph section of A25 between Godstone
     & Bletchingley
  - Defer a decision until both development at Knights Garden Centre site, and additional car parking site in Godstone have been completed

#### **Police**

4.6 Consultation has been carried out with Surrey Police, who fully support the proposed speed limit increase as set out in Option 1.

# 5. FINANCIAL AND VALUE FOR MONEY IMPLICATIONS:

- 5.1The cost of changing any speed limit includes legal advertisement costs associated with the statutory process, together with the costs of design and implementation.
- 5.2The cost of these works will be in the region of £12,000. If the Committee support Option 1 as set out in paragraph 3.1, it is suggested that the works be added to ITS schemes list to be prioritised for funding in 2019/20.

# 9. CONCLUSION AND RECOMMENDATIONS:

- 9.1 This report sets out the speed limit assessment conducted on the A25 Godstone Road. It is recommended that Option 1 is implemented, in accordance with Surrey's Speed Limit Policy, as set out in paragraph 3.1.
- 9.2 The recommendations have been made based upon existing policy, and following consultation with residents, Tandridge District Councillors, Bletchingley Parish Council and Surrey Police.

# 10. WHAT HAPPENS NEXT:

- 10.1Subject to approval and funding being allocated from the 2019/20 ITS budget, the proposal to make a Speed Limit Order is advertised in the local press during 2019/20. Following the making of the Order, the contractor is instructed to install the necessary signing.
- 10.2In line with Surrey's Policy "Setting Local Speed Limits", Officers will monitor this change in speed limit. Should the increased speed limit prove not effective, it may be necessary to bring a further report to the Local Committee, and the speed limit may need to be changed.





Traffic calming measures in Farleigh Road, Warlingham between the junctions of the B269 Limpsfield Road and Sunnybank consist of a series of speed cushions and raised tables. Requests have been received for the removal of the existing speed cushions along this section of Farleigh Road, Warlingham to co-ordinate with proposed Severe Weather Resurfacing Works (with the raised tables remaining).

Speed surveys would need to be undertaken and consultation carried out with the frontagers directly affected by the proposals to remove the existing speed cushion as well as Warlingham Village Primary School, the Police, other emergency services and the County's Road Safety Team before final approval is given to the removal of the speed cushions on Farleigh Road, Warlingham between the junction of the B269 Limpsfield Road and Sunnybank.

### **RECOMMENDATIONS:**

#### The Local Committee (Tandridge) is asked to:

- (i) Approve the removal of the existing speed cushion traffic calming in Farleigh Road between the junctions of B269 Limpsfield Road and Sunnybank, to be carried out when resurfacing works are undertaken in this road as part of the Severe Weather Resurfacing Works, subject to the outcome of consultation results;
- (ii) Authorise delegated authority be given to the Local Committee Chairman, Vice-Chairman and divisional Member, together with the Area Team Manager, to consider the results of the consultation and make a final decision as to whether to proceed with the removal of the speed cushions;
- (iii) Note that if speeds and/or road casualties increase following the removal of the existing speed cushions, there is currently no funding available in the foreseeable future to design and reinstate any traffic calming measures in order to reduce vehicle speeds.

#### **REASONS FOR RECOMMENDATIONS:**

To enable consultation on the removal of existing traffic calming in the form of speed cushions, when the resurfacing works are carried out as part of the Severe Weather Resurfacing Works, in accordance with the wishes of local residents, the Divisional Member, District Councillor and the Parish Council. Following the removal of the speed cushions, speed surveys will be carried out to assess the impact that their removal has had on vehicle speeds.

#### 1. INTRODUCTION AND BACKGROUND:

- 1.1 The Farleigh Road area traffic calming scheme was implemented about 18 years ago using mainly developer funding from the then new Sainsbury store on Limpsfield Road. The scheme consists of a series of speed cushions and table top road humps and was intended to reduce vehicle speeds and road casualties.
- 1.2 This scheme has been largely successful, particularly the section of Farleigh Road between the junctions of the B269 Limpsfield Road and Sunnybank, where there have been no reported personal injury collisions since 2004.
- 1.3 The section of Farleigh Road between the junctions of the B269 Limpsfield Road and Sunnybank are to be resurfaced in this financial year, as part of the Severe Weather Resurfacing Works. This work will result in the existing traffic calming measures having to be removed and rebuilt. However, recently requests have been received to remove the speed cushions in this section of Farleigh Road, because it has been suggested that the existing on street parking already acts to slow vehicle speeds and that the existing cushions require frequent maintenance. This proposal is supported by the Divisional Member and the resurfacing works provide an opportunity to remove the existing speed cushions. Annex 1 is a location plan showing the speed cushions that are proposed to be removed as part of the resurfacing works. It is proposed that the existing table top road humps will remain for the following reasons;
  - One table top road hump is located outside Warlingham Village Primary School, where parking is restricted at the beginning and at the end of the school day.
  - A second table top road hump is located on an informal crossing point just to the north of the junction with The Meadows.
  - The third table top road hump is located at the entrance to Farleigh Road close to the junction with the B269 Limpsfield Road and is located on a section of Farleigh Road where there are double yellow lines.
- 1.4 In 2010 when Sunnybank was resurfaced the speed cushions within this road, which was part of the original area scheme, were removed on a trial basis to

see what effect their removal would have on the traffic speeds. Traffic speeds were monitored before and after resurfacing to gauge the effect of the removal of the speed cushions, and average speeds were found to have increased by between 2 and 3mph. It was noted that on-street parking had a large influence on reducing traffic speeds in Sunnybank. In July 2010 Tandridge Local Committee agreed to make permanent the removal of the speed cushions.

1.5 In 2013 a similar request to remove the traffic calming as part of resurfacing work was received for the section of Farleigh Road between the junctions of Sunnybank and Harrow Road. However, during consultation objections to their removal were received from Surrey Police, on the basis that there was no evidence that their removal would not have a detrimental impact on vehicle speeds or casualties. As a result, alternative traffic calming measures were installed on this section of Farleigh Road. It should be noted that should similar objections be received by Surrey Police regarding the removal of the existing speed cushions in Farleigh Road, (between the junctions of the B269 Limpsfield Road and Sunnybank), there is no funding available to design and install alternative traffic calming measures.

#### 2. ANALYSIS:

- 2.1 Farleigh Road (between the B269 Limpsfield Road and Sunnybank) is programmed for resurfacing in this current financial year as part of the Severe Weather Resurfacing Works. This provides an opportunity to remove the speed cushions on this section of Farleigh Road. Speed surveys would need to be carried out before and after the removal of the traffic calming to monitor the impact on speeds.
- 2.2 Consultation will need to be carried out with frontagers, Warlingham Village Primary School which is located on this section of Farleigh Road, the emergency services and other stakeholders regarding the proposed removal of the existing speed cushions. The outcome of the consultation will inform the Local Committee Chairman, Vice Chairman and Divisional member, together with the Area Highways Manager to make a final decision on whether or not to remove the existing speed cushions on Farleigh Road, Warlingham (between the B269 Limpsfield Road and Sunnybank).
- 2.3 The existing table top road humps are currently supported by residents and therefore it is not proposed to remove these at the present time, although it is proposed to remove the speed cushions.
- 2.4 There have been no recorded personal injury collisions on Farleigh Road between B269 Limpsfield Road and Sunny Bank over the 5 year period July 2013 to end of June 2018.
- 2.5 It should be noted that unlike in previous years where, following consultation alternative forms of traffic calming have been installed on Farleigh Road. Therefore is no funding available to carry out such works.

#### 3. OPTIONS:

#### 3.1 Option 1:

Subject to the outcome of consultation, remove the existing speed cushions in Farleigh Road, between B269 Limpsfield Road and Sunnybank when the resurfacing work is carried out as part of the Severe Weather Resurfacing Works.

### 3.2 Option 2:

Do nothing. The speed cushions will be reconstructed as part of the Severe Weather Resurfacing Works.

#### 4. CONSULTATIONS:

4.1 No formal consultation has been carried out to date. Consultation will need to be carried out with the frontagers directly affected by any proposed removal of the speed cushions in Farleigh Road (between the junction with B269 Limpsfield Road and Sunnybank), and with the Police and other emergency services. The views of the County's Road Safety Team will also be sought.

#### 5. FINANCIAL AND VALUE FOR MONEY IMPLICATIONS:

- 5.1The cost of the removal of the speed cushions in Farleigh Road between B269 Limpsfield Road and Sunnybank, would be carried out as part of the Severe Weather Resurfacing Works.
- 5.2Speed surveys will be carried out by the South East Area Team to assess existing vehicle speeds on Farleigh Road, between B269 Limpsfield and Sunnybank. Consultation on the removal of the speed cushions will also be carried out by the South East Area team.
- 5.3It should be noted that if an increase in traffic speeds and personal injury collisions results from the removal of the speed cushions, there would be a costs associated with having the speed cushions or alternative measures reinstated. However, there is no funding available at the present time or in the foreseeable future to undertake such work.

#### **6. WIDER IMPLICATIONS:**

- 6.1 Removal of the existing speed cushions in Farleigh Road, between the junctions of B269 Limpsfield Road and Sunnybank, could result in increased speeds and therefore increasing pressure on Police resources to carry out speed enforcement.
- 6.2 At present, there have been no recorded personal injury collisions on this section of Farleigh Road since 2004. The removal of the existing speed cushions could increase vehicle speeds, resulting in an increase in the number of personal injury collisions.

### 9. CONCLUSION AND RECOMMENDATIONS:

- 9.1 Requests have been received for the removal of the speed cushions in Farleigh Road, Warlingham between the junctions with the B269 Limpsfield Road and Sunnybank.
- 9.2 Speed surveys would need to be carried out before and after the removal of the speed cushions.
- 9.3 Consultation regarding the proposals to remove the speed cushions would need to be carried out with the frontagers directly affected, as well as Warlingham Village Primary School, the Police, other emergency services and the County's Road Safety Team.
- 9.4 Subject to the results of the consultation, it is recommended that works to remove the existing speed cushions in Farleigh Road between B269 Limpsfield Road and Sunnybank, be carried out when resurfacing works are undertaken as part of the Severe Weather Resurfacing Works. To ensure the co-ordination of these works, it is recommended that delegated authority be given to the Local Committee Chairman, Vice-Chairman and divisional Member, together with the Area Team Manager, to consider the results of the consultation and make a final decision as to whether or not to proceed with the removal of the speed cushions.
- 9.5 It should be noted that, unlike previous years, should concerns be raised that following the removal of the speed cushions vehicle speeds and personal injury collisions have increased, there is no funding available at the present time or in the foreseeable future for additional traffic calming measures to be installed.

#### **10. WHAT HAPPENS NEXT:**

10.1 Subject to Local Committee approval, speed surveys will be carried out in Farleigh Road, between the junction of the B269 Limpsfield Road and Sunnybank, to assess the existing vehicle speeds along this section of Farleigh Road. Consultation will be carried out with the frontagers directly affected by the proposals, the Police and other emergency services and the County's Road Safety Team, regarding the proposals to remove the speed cushions. The results of the public consultation will be considered by the Local Committee Chairman, Vice-Chairman and divisional Member and a final decision made on whether to proceed with the removal of the speed cushions on this section of Farleigh Road when the resurfacing work is carried out as part of the Severe Weather Resurfacing Works.

### **SUMMARY OF ISSUE:**

To inform the Local Committee on the progress of the 2018/19 Integrated Transport and highways revenue maintenance programmes in Tandridge, as well as other projects that are not funded through the Local Committee such as the Severe Weather Recovery Programme, the Caterham Masterplan, the M23 Smart Motorway project and the centrally funded maintenance.

#### **RECOMMENDATIONS:**

The Local Committee (Tandridge) is asked to note the contents of this report.

#### **REASONS FOR RECOMMENDATIONS:**

Programmes of work have been agreed in consultation with the Committee. The Committee is asked to note the progress of the Integrated Transport Scheme programme and revenue maintenance expenditure. As well as the work that is being carried out on the Severe Weather Recovery Programme, the M23 Smart Motorway project and the centrally funded maintenance schemes.

### 1. INTRODUCTION AND BACKGROUND:

- 1.1 In December 2017, Tandridge Local Committee agreed a programme of capital Integrated Transport Schemes (ITS) for 2018/19 to be funded from the Local Committee's devolved budget.
- 1.2 In March 2018, Tandridge Local Committee agreed a revenue maintenance expenditure for 2018/19, to be funded from the Local Committee's devolved budget, following the approval of the 2018/19 budget by full Council on 6 February 2018. Where it was agreed that the revenue allocation to Local Committees be increased, and a member Local Highways Fund be introduced.
- 1.3 In addition to the Local Committee's devolved budget, countywide budgets are used to fund major maintenance (Operation Horizon), drainage works and

other capital highway schemes. Countywide revenue budgets are used to carry out both reactive and routine planned maintenance works.

1.4 Developer contributions can also be used in Tandridge to fund either wholly or in part, highway improvement schemes to mitigate the impact of developments on the highway network.

#### 2. ANALYSIS:

#### 2.1 Local Committee finance

The Tandridge Local Committee have delegated highway budgets for the current Financial Year 2018-19 as follows:

Capital: £36,363Revenue: £168,182Total: £204,545

In addition to the above Council has approved an allocation of £7,500 per county member to address highway issues in their divisions. Guidance on uses for this funding has been provided to divisional members.

Highway officers within the local area office are also continuing to look for other sources of funding for schemes that have been identified within the Integrated Transport Scheme Programme. As a result funding has been secured from Section 106 developer funding for improvements to pedestrian crossing facilities on Banstead Road, Caterham outside Le Personne retirement housing.

The budgets delegated to Local Committee are in addition to budgets allocated at County level to cover various major highways maintenance and improvement schemes, including footway/carriageway resurfacing, the maintenance of highway structures including bridges, culverts and embankments, and the maintenance of safety barriers.

#### 2.2 Local Committee capital works programme

Progress on the approved Local Committee funded capital programme of highway works in Tandridge is set out in **Annex 1**. It also provides an update on schemes being progressed using developer contributions, as well as those being progressed by the Road Safety Team and the Parking Review.

### 2.3 Local Committee revenue works programme

Progress on the approved Local Committee revenue works programme is set out in **Annex 2**. An update on the Member Local Highways Fund is also provided.

#### 2.4 Parking

An update on the parking review is provided in **Annex 1**.

#### Other highway related matters

#### 2.5 Customer services

The total number of enquiries received for the six months between January and June 2018 is 91,245 an average of 15,208 per month. This is a 40% increase on the number received during the same period in 2017 and reflects the huge effect of the severe weather and subsequent defects.

For Tandridge specifically, 10,135 enquiries have been received since January of which 3,662 (36%) were directed to the local area office for action, of these 95% have been resolved. This response rate is slightly higher than the countywide average of 92%.

**Table 1** below shows the number of enquiries received between January-June 2018 compared to the number received during the same period in 2017.

During the first 6 months of 2018, Highways received 162 stage 1 complaints (down 18% from 2017), of which 15 were for the Tandridge area. In addition two have been escalated to stage 2 of the complaints process, where the service was found not to be at fault.

#### 2.6 Severe weather recovery program

A first list of roads included within the severe weather recovery programme has been published on Surrey County Council's website. This list consists of over 100 roads across the county and can be found here;

Subject to road space being available, work on these roads should be completed over the next few months and all of these roads have been put forward by local members or the local highway teams.

#### 2.7 Winter gritting routes update

The Cold Weather Plan sets out the Winter Service for treating the highway in order to prevent ice from forming (precautionary salting), melt ice and snow that has already formed (post salting), and removal of snow in a snow event. As in previous years, members will be sent an electronic copy of the 2018-19 Cold Weather Plan along with links to revised 2018-19 gritting routes prior to the commencement of the Winter Season.

County Councillors can request and pay for new grit bins, or extension of use of an existing grit bin, by contacting the Maintenance Engineer, who will advise.

### 2.7 Major Schemes

Following the adoption of the Caterham Masterplan as a Supplementary Planning Document (SPD), Surrey County Council's South East Area highways team have been working with Tandridge District Council and other stakeholders to progress the proposals within the Masterplan document.

Highways England are continuing works to improve the busy 18km (11 miles) stretch of the M23 between junction 8 near Merstham and junction 10 near Copthorne by upgrading it to an "all lane running" (ALR) smart motorway.

These works began in March 2018 and are expected to be completed by early 2020. These works will result in;

- An additional lane for traffic increasing capacity to reduce congestion.
- More technology on the road to manage incidents.
- More reliable journeys.

#### 2.8 Centrally funded maintenance

The Operation Horizon Team programmes of major maintenance works for 2018-19 for the Tandridge area, which is in addition to the winter recovery programme works, are now published on Surrey County Council's website here:

Major maintenance works being carried out in the Tandridge District within this financial year includes carriageway resurfacing work on Broadbridge Lane in Smallfield and pavement resurfacing in Hillbury Road, Warlingham.

### 2.9 Road Safety

The Road Safety Working Group meets every 6 months to review personal injury collision data provided by Surrey Police. The Road Safety Working Group is attended by Surrey County Council Road Safety Engineers, Surrey County Council Highway Engineers and Surrey Police. An update on road safety schemes that have been identified by the Road Safety Working Group and are being progressed by the Road Safety Team is provided in **Annex 1**.

#### 2.10 Passenger Transport

There are no Integrated Transport Schemes that directly contribute to improvements in passenger transport.

However the provision of improved pedestrian crossing facilities in Banstead Road, Caterham which is a scheme being funded through developer contributions, will help to improve pedestrian access to local bus stops. The feasibility report for this scheme is complete and consultation with the local member and district councillor has been carried out. Developer contributions for this scheme have been released by Tandridge District Council to Surrey Highways, and consultation with residents as well as detailed design work will continue shortly.

2.11 Other key information, strategy and policy development

No additional information at present.

#### 3. OPTIONS:

3.1 No options to consider at this stage. Officers will revert to the Chairman, Vice Chairman and Divisional Member or indeed the Committee as appropriate, whenever preferred options need to be identified.

#### 4. CONSULTATIONS:

4.1 Not applicable at this stage. Officers will consult the Chairman, Vice Chairman and Divisional members as appropriate in the delivery of work programmes.

Section 106 funding was collected from the Oak Grove (Oaklands Hospital) site to provide improvements to pedestrian crossing facilities in the vicinity of the development. A meeting was held with the divisional Member at the time Cllr Orrick to look at a number of locations where improvements to pedestrian crossing facilities have been requested. Following the meeting the provision of a pedestrian crossing facility in Banstead Road has been designed and the divisional Member (Cllr Botten) and former District Councillor (Cllr Webster) consulted on the propsed crossing. Funding in order to carry out the detailed design and construction of this scheme has been transferred from Tandridge District Council, therefore this work will be carried out shortly.

**Project:** High Street, Dormansland

**Detail:** Pedestrian Crossing Points **Division:** Lingfield

### **Progress:**

The table below summarises the work carried out by the revenue maintenance gang between April and July 2018 inclusive, by work type and division. Requests for work are received from county and district members, parish councils, residents and other road users. The demand for work exceeds the capacity of the gang to carry it out so work is prioritised, with safety issues and county member requests being given the highest priority. The revenue maintenance gang is also used to carry out local works in conjunction with the grass cutting lane closures on high speed roads.

### 2. Member Local Highways Fund

In addition to the revenue maintenance budget, each county member has an allocation of £7,500 to address highway issues in their divisions. A maximum contribution of £2,500 can be spent on any individual project.

It was agreed that the Member Local Highways Fund is managed by the Tandridge Maintenance Engineer on members' behalf. Members have been working with the Tandridge Maintenance Engineer to agree what they wish to fund and these works are now being progressed. Members should agree with the Maintenance Engineer by the end of September 2018 at the very latest how they wish to spend any unallocated funding to ensure there is sufficient time for the work to be priced, ordered and implemented before the end of the financial year. The type of works being funded to date include road markings and signs, and minor patching. Members have also requested that funding be transferred to parish councils so they can carry out minor highway works in their areas. The parish councils have been asked to provide match funding where possible.
