20. Apologies for Absence

Councillor Richard Chatterjee (LB Croydon) and Councillor Sean Fitzsimons (LB Croydon) were in attendance online but were not in the meeting.

21. Declarations of Interest

22. Minutes

23. Proposed Engagement on Changes to Renal Inpatient Services Appendix A in South West London and Surrey

The Committee had before it a report by James Blythe, South West London (SWL) Integrated Care Systems (ICS) Specialised SRO and Maggie Lam, Deputy Director for Urgent Emergency Care (UEC) & Cancer, SWL, ICS. Mr Blythe was joined in making the presentation to the Committee by Dr Ginny Quan (NHS Trust), Prof Debasish Banarjee (NHS Trust), and Mr Stephen Webb SWL, ICS.

The purpose of the discussion with JHOSC was:

1. To present the proposal and supporting information to the SW London and Surrey JHOSC for discussion.
2. To seek the JHOSC's support to proceed with engagement on the basis laid out (taking into account any considerations raised by members of the JHOSC)

In July 2020, as part of the Improving Healthcare Together (IHT) programme, South West London and Surrey Heartlands CCGs approved the option for the consolidation of six acute services from the current Epsom and St Helier hospitals (ESTH) to a new Specialist Emergency Care Hospital (SECH) at the Sutton Hospital site, with the retention of District Hospital services at both Epsom and St Helier. As part of this, it was intended that renal (kidney) inpatient care would move from St Helier to the SECH.

During the consultation, renal physicians from both ESTH and St George's University Hospitals Hospital (SGUH) responded to the consultation to propose that instead of moving the inpatient renal care to the SECH, inpatient renal care at ESTH and SGH could be consolidated into a new single unit at SGH. The rationale for consolidating the inpatient renal care at a new unit at SGH was to bring about greater quality, sustainability, teaching and research within renal care across SWL and Surrey. Co-location of renal inpatient care alongside co-dependent services such as interventional radiology, vascular access surgery and transplantation surgery at SGH had clear benefits to both patients and to the services.

ESTH and SGUH developed a proposal in line with the clinical input to the IHT process. In December 2020, it was agreed by commissioners that a "renal variant option" be considered as part of the overall Outline Business Case (OBC) for the SECH. In January 2021, a separate OBC for the development of a new renal unit at

SGH was included in the main Building Your Future Hospital OBC, taking into account the entirety of the plans for the SECH and the existing Epsom and St Helier hospitals.

Following a meeting of the NHS Joint Investment Committee in May 2021, outline approval for the funding for the preferred option had been given. This was necessary for the team to proceed to JHOSC for discussion and public engagement. During discussion on the matter, Members raised questions around travel times, costs and public transport options. Members also raised concerns relating to the data sources used to generate the population totals with some members feeling the changes in the report were significantly underestimated. Questions were raised regarding patient capacity forecasting for the new hospital in St. George’s, and clarity was required on expanding the Day Care Surgery. Members suggested that further work on demographics and understanding patients’ needs and demands, was required. Members noted that there needed to be minimised disruption to services and treatments, particularly for the elderly and that greater references to the role of social care services needed to be included. Members asked for clarity on how the development of new pathways to expand services will be managed over the next 5-10 years. There was concern as to whether the engagement needs of hard-to-reach populations/groups (the disabled, the elderly, as well as the homeless) was being met. There was concern over access for visitors (family and friends) relied on public transport.

After discussion the committee agreed to support proceeding with engagement on the basis laid out (taking into account any considerations raised by members of the JHOSC)
