#### 1/21 APOLOGIES FOR ABSENCE [Item 1]

Apologies were received from Cllr Catherine Sayers.

#### 2/21 MINUTES OF PREVIOUS MEETING [Item 2]

The minutes of the meeting held on 12 February 2021 were agreed as a correct record.

#### 3/21 DECLARATIONS OF INTEREST [Item 3]

There were no declarations of interest made.

#### 4/21 PETITIONS [Item 4]

Two petitions were received for Sunnybanks and Stafford Road.

Sunnybanks

**Declarations of Interest: None** 

Officer attending: Zena Curry, Highway Engagement and Commissioning Manager

Petitions, Public Questions, Statements: One petition as detailed.

Perry Chotai presented his petition to the Committee. He had collected 64 signatures for the petition which was to avoid death and injury. He stated that cars travel at speeds and use it as a cut road. He thanked officers but felt the response was unacceptable.

Member discussion - key points

The Divisional Member was disappointed this was the first time she was made aware of issues but she was happy to help find a way forward.

Parking on the road slowed traffic, but as the parking was one side, cars drove down the other at speed to get through. Parking on both sides (with gaps) might provide an interim solution.

Residents opinions had changed and traffic calming was now wanted.

The Highway Engagement and Commissioning Manager outlined that previous traffic calming had been removed at the request of residents, but road safety was taken extremely seriously. The Committee always had more requests than could be delivered so they needed to be prioritised and there were currently over 30 projects on the Integrated Transport Scheme List (ITS).

The Chairman noted that opinion seemed to have changed and noted that further work would be undertaken with residents, ward members and the Divisional Member

Stafford Road

**Declarations of Interest:** None

Officer attending: Zena Curry, Highway Engagement and Commissioning Manager

Petitions, Public Questions, Statements: One petition as detailed.

Councillor Alun Jones presented the petition on Stafford Road, in particular outside the flats. These are now general needs accommodation with 25 of a parking space per flat so most parking is on street. He had been engaging with Tandridge District Council on finding a solution using additional land. There have been accidents and pets killed. The issues were speeding, double parking and the road width, so a holistic solution was required.

Member discussion -key points

The Divisional Member confirmed the issue had come up many times, with efforts to resolve significant issues.

Flooding was exacerbated by the speeding cars going through standing water.

Issues around reporting did not reflect the gravity of the situation.

The neighbourhood engagement meeting approach was welcomed.

Traffic calming planned in Croydon Road might impact on Stafford Road, so a wider 20mph zone (including Croydon Road, Station Avenue and Stafford Road) was suggested.

Resident led speed watch might also be considered

The Highway Engagement and Commissioning Manager responded to the points raised. Unfortunately, damage only accidents are not recorded by the

police and are not taken into consideration. Issues about flooding and drainage can be brought into the neighbourhood engagement meeting so colleagues leading on those issues will be there.

The Road Safety Manager advised looking at www.crashmap.co.uk to see how many collisions had resulted in injury. Investment was prioritised for those with a history of these. He was in favour of 20mph schemes but they needed to work which might mean additional traffic calming measures so council money was not wasted. He advised that it might be possible to include Station Avenue as part of the 20mph area for little extra cost.

The report was noted and detail will be provided of a Neighbourhood Engagement Meeting with all parties in January.

The questions asked and the answers given were published in the supplementary agenda.

1 - To offer one bend sign is unacceptable and the police state they cannot do anything until the speed limit is reduced.

The Highway Engagement and Commissioning Manager confirmed they had visited the site and one sign was not to imply there were not other bends, but an interim measure to give warning of that hazard.

2 - Answer to question doesn't match what is on website. How does change control happen, where any changes show. Did 30 odd pothole reports but only 10 deemed repairing will they be repaired.

The Highway Engagement Manager confirmed the Horizon programme is a centrally funded programme and the budget is not delegated to this local committee. The maps with the data are regularly updated. She agreed to find out about the particular roads from the assets team. She also confirmed that the pothole won't be urgently fixed unless the defect meets the intervention level.

#### 7/21 TANDRIDGE PARKING REVIEW [Item 7]

**Declarations of Interest:** None

Officer attending: Rikki Hill, The Parking Project and Enforcement Team Leader

#### Petitions, Public Questions, Statements: None

The Parking Project and Enforcement Team Leader introduced the report.

Member discussion - key points

Coulsdon Road proposals – what could be done about parking by non residents in St Michaels Road . Too late to add anything new for this review but can look at adding it to the next review. Have to bear in mind the impact on surrounding roads.

The map for Ivy Mill Lane in Godstone doesn't show as an agenda item. The Parking Project and Enforcement Project Team Leader confirmed this was a mistake and it will be included in the advertisement process.

The Local Committee (Tandridge) agreed that:

- the proposed changes to on-street parking restrictions in Tandridge as described in annex 1 and shown in the drawings in annex 2 are approved.
- (ii) if necessary, minor adjustments can be made to the proposed changes by the parking project & enforcement team leader in consultation with the chairman/vice-chairman and relevant county councillor prior to formal advertisement and statutory consultation.
- (iii) the intention of the county council to make orders, under the relevant parts of the Road Traffic Regulation Act 1984, to make the proposed amendments to the waiting and on street parking restrictions in Tandridge is advertised and that if no objections are maintained, the orders are made.
- (iv) if there are unresolved objections, they will be dealt with in accordance with the county council's scheme of delegation by the parking & traffic enforcement manager, in consultation with the chairman/vice chairman of this committee and the appropriate county councillor, after which the orders will be made.
- (v) the parking team is authorised to carry out a consolidation of the traffic regulation orders, once these latest amendments have been made, and to carry out consolidations in future when necessary.

#### **REASONS FOR DECISION:**

Changes to the highway network, the built environment and society mean that parking behaviour changes and consequently it is necessary for a highway authority to carry out regular reviews of waiting and parking restrictions on the highway network. The changes to parking controls and restrictions will make a positive impact towards:-

- Road safety
- Access for emergency vehicles
- Access for refuse vehicles
- Easing traffic congestion
- Controlling parking
- Improving parking amenity

## 8/21 SMALLFIELD PEDESTRIAN ACCESSIBILITY AND SAFETY SCHEME [Item 8]

**Declarations of Interest: None**

The Road Safety Manager introduced the report.

Member discussion -key points

The Divisional Member confirmed she was very keen on the project and hoped the committee would support it.

The Local Committee (Tandridge) agreed that

- (i) The scheme proposals as presented within Appendix A should proceed to detailed design and implementation incorporating some minor changes resulting from the public consultation described in section 2.
- (ii) Proceeding with the scheme will be subject to the successful conclusion of the lease of part of a Burstow School playing field to the parish council to create an off-street parking facility upon which the highway scheme will depend.
- (iii) Authorise the advertisement of the relevant notices in accordance with the Road Traffic Regulation Act 1984, the effect of which will be to implement the proposed traffic restrictions, traffic calming and formal crossings, and subject to no objections being upheld, that the orders be made.
- (iv) Authorise delegation of authority to the Highway Engagement & Commissioning Manager in consultation with the Chairman, Vice-Chairman of the Local Committee and the relevant local divisional member to resolve any objections received in connection with the proposals

#### **REASON FOR DECISION:**

The proposed highway measures would help to reduce risk of collisions and improve the highway infrastructure to encourage more walking, cycling and push scooting to school and to the shops and services in the centre of Smallfield. The proposals would also help reduce congestion and driver frustration on Wheelers Lane and Redehall Road in the centre of Smallfield.

#### 9/21 DECISION TRACKER (FOR INFORMATION) [Item 9]

A member requested the feasibility study for the zebra crossing on Westhall Road, Warlingham needs to be added back on. The feasibility study to be done this year with funding next year if it goes ahead.

The decision tracker was noted.

#### 10/21 FORWARD PLAN [Item 10]

A member asked about the position re grit bins. The Highway Engagement and Commissioning Manager responded that a lot of information was provided in the earlier written question. The member said that he would speak to the county councillor and chairman of the parish councillor. The local committee chairman confirmed grit bins were outside of this meeting. The county councillor advised he had anticipated this with the chairman of the parish councillor and will take it on board.

A member asked whether the Highways budget for 2023 should be included and the ITS list and can it have a report back on the Sunnybank petition issue and why is Smallfield Pedestrian

Safety and Accessibility

Scheme on it. The officer apologised and confirmed Smallfield Pedestrian Safety and Accessibility

Scheme will be taken off and will add feeding back on the Sunnybank engagement meeting.

#### **SUMMARY OF ISSUE:**

This report seeks approval of a programme of highway works for Tandridge funded from the Local Committee's delegated capital and revenue budgets.

#### **RECOMMENDATIONS:**

#### The Local Committee (Tandridge) is asked to:

#### General

- (i) Note that, subject to approval by cabinet, the Local Committee's devolved highways budget for capital works in 2022/23 is £537,034.
- (ii) Agree that, subject to approval by cabinet, the devolved capital budget for highway works be used to progress both capital improvement schemes and member capital allocation as detailed in section 1.
- (iii) Authorise that the Highway Engagement & Commissioning Manager in consultation with county members to be able to reallocate budget to reserve schemes should there be a need to change the programme.
- (iv) Authorise that the Highways Engagement and Commissioning Manager in consultation with county members, be able to allocate any additional funding for schemes, in accordance with any guidance issued surrounding that funding.

#### Capital Improvement Schemes

- (v) Agree that, subject to approval by cabinet, the capital improvement schemes allocation for Tandridge be used to progress the Major Integrated Transport Schemes programme set out in Annex 1.
- (vi) Authorise that the Highways Engagement and Commissioning Manager be able to vire money between the schemes agreed in Annex 1, if required.
- (vii) Agree that Highways Engagement and Commissioning Manager, in line with the Scheme of Delegation, is able to progress any scheme from the Major Integrated Transport Schemes programme, including consultation and statutory advertisement that may be required under the Road Traffic Regulation Act 1984, for completion of those schemes. Where it is agreed

that a scheme will not be progressed, this will be reported back to the appropriate county member.

#### Member Capital Allocation

(viii) Note that, subject to approval by cabinet, £50,000 is allocated to each divisional member. Up to £15,000 of this could be allocated to minor ITS, or all £50,000 could be used on capital maintenance (recommended option). The schemes are to be proposed by county members in consultation with the Stakeholder Engagement Officer.

#### Revenue Maintenance

- (ix) Note that the members, subject to approval by cabinet, will continue to receive a Member Local Highways Fund (revenue) allocation of £7,500 per county member to address highway issues in their division; and
- (x) Agree that each county member allocates £6,000 of their Member Local Highways Fund allocation to be pooled to commission a revenue maintenance gang.
- (xi) Agree that revenue works are to be managed by the Highway Maintenance team on behalf of and in consultation with county members.

#### REASONS FOR RECOMMENDATIONS:

To agree, subject to approval by cabinet, a programme of highways works in Tandridge for 2022/23, funded from budgets available to enable schemes and works to progress.

#### 1. INTRODUCTION AND BACKGROUND:

- 1.1 It is proposed that, subject to approval by cabinet, Tandridge receives a devolved capital budget for major ITS, of £237,034 for their top major ITS priorities. Each county member will also have £50,000 of county member Capital Allocation, that could have up to £15,000 used for minor ITS or all £50,000 on capital maintenance (recommended option).
- 1.2 It is also proposed, subject to approval by cabinet, as per the current approach, that £6,000 of the £7,500 revenue funding per county member could be pooled across members for a cost-effective revenue maintenance gang.
- 1.3 The proposed major ITS Forward Programme for 2022/23 has been prioritised using the county council's CASEE scoring process (as guidance for members) and is in Annex 1 of this report.
- 1.4 **Capital:** Subject to approval by cabinet, the Tandridge Local Committee's budget for capital works for 2022/23 is £537,034 with £237,034 for major ITS improvement schemes and £300,000 for county member Capital Allocation.

- 1.5 The Stakeholder Engagement Officer will assist county members to ensure the best use of the county member Capital Allocation and enable commissioning to the Highway Maintenance team.
- 1.6 **Revenue:** Subject to approval by cabinet, county members will continue to receive an allocation of £7,500 per county member to address maintenance issues in their division.
- 1.7 Table 1 summarises the various funding streams together with the budgets, subject to approval by cabinet, for 2022/23. It also refers to the relevant parts of the report which set out how it is proposed to allocate this funding and the recommendations relating to each funding stream. However, budgets require approval by full council and are therefore subject to change.

- 1.8 It is proposed, subject to approval by cabinet, that delegated authority be given to the Highway Engagement & Commissioning Manager to enable the highways programme to be delivered in a flexible and timely manner.
- 1.9 In addition to the Local Committee's devolved budget, there are Countywide capital budgets which are used to fund major maintenance (Operation Horizon), surface treatment schemes, footway schemes, drainage works and safety barrier schemes.
- 1.10 Countywide revenue budgets are used to carry out both reactive and routine maintenance works. The maintenance team manages a centrally funded revenue budget to carry out drainage investigation and small repairs locally.
- 1.11 The Road Safety Team manages a small Countywide budget to implement small safety schemes which are prioritised by the collision savings they provide. They also hold a small budget for the maintenance of Vehicle Activated Signs and Wig Wag signs at school crossing patrol sites.
- 1.12 It is proposed, subject to approval by cabinet, that the Road Safety Team have two additional countywide budgets to address the highest priority backlog of www.surreycc.gov.uk/tandridge

Road Safety Outside Schools and Road Safety schemes. Subject to approval by cabinet, suitable schemes from the current ITS list will be put forward for consideration for this central funding. If a scheme on the Major ITS Forward Programme is prioritised for this Road Safety funding, then it is proposed, subject to approval by cabinet, to progress schemes on the reserve Major ITS list shown in Annex 1.

- 1.13 Contributions collected from developers through S106 agreements or Community Infrastructure Contributions (CIL) can be used to fund, either wholly or in part, highway improvement schemes which mitigate the impact of developments on the highway network.
- 1.14 This report sets out the proposed programme of highway works for Tandridge.

#### 2. ANALYSIS:

#### **Major Integrated Transport Schemes (ITS)**

- 2.1 The Major Integrated Transport Schemes (ITS) budget aims to improve the highway network for all users, in line with the objectives set out in the Local Transport Plan.
- 2.2 The Major Integrated Transport Schemes (ITS) budget, subject to approval by cabinet, is £237,034 and is to be used to progress capital improvement schemes. The proposed Major ITS Forward Programme, subject to approval by cabinet, to be delivered from this budget is shown in Annex 1.
- 2.3 Subject to approval by cabinet, it is proposed to change the Major Integrated Transport Schemes (ITS) Forward Programme from what was previously agreed at the Local Committee meeting held on 12th February 2021. **Annex 1** sets out the proposed ITS forward programme for 2022/23.
- 2.4 It is proposed that the Highways Engagement and Commissioning Manager be able to vire money between the schemes agreed in Annex 1.
- 2.5 It is proposed that the Highways Engagement and Commissioning Manager, in line with the Scheme of Delegation, is able to progress any scheme from the Integrated Transport Schemes programme, including consultation and statutory advertisement that may be required under the Road Traffic Regulation Act 1984, for completion of those schemes. Where it is agreed that a scheme will not be progressed, this will be reported back to the appropriate county member.

#### **County Member Capital Allocation**

- 2.6 The capital maintenance budget is used to carry out capital maintenance works that would not prioritise highly under the Countywide prioritisation process for capital maintenance, but the condition of which are of local concern.
- 2.7 It is proposed, subject to cabinet approval, that each county member be allocated £50,000 to spend in their divisions, which should be sufficient to progress either one larger or two small capital maintenance schemes. However, subject to cabinet approval, up to £15,000 of the £50,000 available

to each divisional member could also be used to fund a minor ITS scheme such as the installation of dropped kerbs. It is proposed that the schemes to be progressed will be identified by the county members in consultation with the Stakeholder Engagement Officer and commissioned to the appropriate team.

#### Members Local Highway Fund (Revenue)

2.8 Members will continue to receive, subject to cabinet approval, an allocation of £7,500 per county member to address highway issues in their divisions, subject to budget confirmation. It is proposed that the Member Local Highways Fund be managed by the Highway Maintenance team on county members' behalf.

#### 3. OPTIONS:

3.1 The Local Committee is being asked to approve a forward programme of highway works for Tandridge, subject to approval by cabinet, as set out in this report.

#### 4. CONSULTATIONS:

- 4.1 The proposed Major Integrated Transport Schemes (ITS) Forward Programme has been previously consulted on as part of the approval of the Forward Programme at the Tandridge Local Committee on 12th February 2021.
- 4.2 Appropriate consultation will be carried out as part of the delivery of the works programme.

#### 5. FINANCIAL AND VALUE FOR MONEY IMPLICATIONS:

- 5.1 The highways budget for Tandridge for capital works in 2022/23, subject to approval by cabinet is £537,034.
- 5.2 The highways budget for Tandridge is used to fund works which are a priority to the local community. A number of virements are in place or suggested to enable the budget to be managed, so as to enable the programme to be delivered in a flexible and timely manner.

#### 6. EQUALITIES AND DIVERSITY IMPLICATIONS:

6.1 It is an objective of Surrey Highways to treat all users of the public highway equally and with understanding.
