3 CONSULTATION ON ADMISSION ARRANGEMENTS FOR COMMUNITY AND VOLUNTARY CONTROLLED SCHOOLS FOR SEPTEMBER 2024

The local authority must consult on any changes it wishes to make to the admission arrangements for community and voluntary controlled schools for 2024. Consultation must run for at least six weeks between 1 October 2022 and 31 January 2023 and admission arrangements for 2024 must be determined by 28 February 2023. This report seeks authorisation to proceed to consultation on the schools listed.
