SUBJECT: ADOPTION OF THE CHARTER FOR FAMILIES BEREAVED

THROUGH PUBLIC TRAGEDY

#### **SUMMARY OF ISSUE:**

Current processes following major incidents can compound and prolong the impact of a tragic event on bereaved families and/or survivors.

#### **RECOMMENDATIONS:**

It is recommended that the Cabinet Member approves the adoption of The Charter for Families Bereaved through Public Tragedy.

#### **REASON FOR RECOMMENDATIONS:**

Signing up to the Charter for Families Bereaved through Public Tragedy will provide additional assurance to our communities should an event happen within Surrey.

#### **DETAILS:**

#### The need for a Charter:

- The need for the charter has arisen from Public Inquiries from recent major incidents, for example the Grenfell Tower tragedy and Manchester Arena Bombing, which are consistently suggesting that there is more that could be done to support families following large-scale tragedies or disasters, particularly where there is loss of life, or the distress caused to those affected is severe and likely to have a lifelong impact.
- 2. The framework that currently exists to investigate the tragic circumstances behind incidents such as the Hillsborough disaster and the Grenfell Tower fire, is complex and will often involve multiple agencies. Families can face an enormous challenge in understanding the roles of various agencies and to participate meaningfully in the numerous legal or investigative procedures. They must do this at the same time as coming to terms with what has happened to them. This is likely to be overwhelming and to add to the suffering of bereaved families and/or survivors.

- 3. A recurring theme from the feedback received from families during investigations, such as that into the Hillsborough disaster, is that without support and recognition from public sector bodies these processes can compound and prolong the impact of a tragic event.
- 4. Signing up to the Charter for Families Bereaved through Public Tragedy will provide additional assurance to our communities should a similar event happen within Surrey and ensures leaders of public bodies deliver the particular changes needed within their organisation to make the behaviours described in the charter a reality in practice.
- 5. Adoption of the charter will align Surrey Fire and Rescue Service with partner Fire and Rescue Services (FRS) within the 4F group (Kent, East and West Sussex FRSs), The National Police Chiefs Council (NPCC), The Crown Prosecution Service (CPS) and other UK Fire and Rescue Services. The National Fire Chiefs Council (NFCC) are recommending all FRSs across the UK adopt the charter.
- 6. When an organisation has signed up to the charter, it should declare this fact publicly.

#### **CONSULTATION:**

7. The Charter for Families Bereaved through Public Tragedy has been shared with the Cabinet Member for Communities and Community Safety.

#### **Section 151 Officer Commentary**

- 10. Although significant progress has been made to improve the Council's financial position, the financial environment remains challenging. The UK is experiencing the highest levels of inflation for decades, putting significant pressure on the cost of delivering our services. Coupled with continued increasing demand and fixed Government funding this requires an increased focus on financial management to ensure we can continue to deliver services within available funding.
- 11. In addition to these immediate challenges, the medium-term financial outlook beyond 2022/23 remains uncertain. With no clarity on central government funding in the medium term, our working assumption is that financial resources will continue to be constrained, as they have been for the majority

of the past decade. This places an onus on the Council to continue to consider issues of financial sustainability as a priority in order to ensure stable provision of services in the medium term.

12. There are no financial implications associated with adopting the Charter, and as such the Section 151 Officer supports the recommendation.

#### **Legal Implications – Monitoring Officer**

13. Whilst there is no legal obligation to sign up to the charter it demonstrates the organisational ambition to act at all times in the public interest.



# SFRS adoption of the Charter for Families Bereaved through Public Tragedy

28 February 202

# **Background**

The Charter for Families Bereaved through Public Tragedy comes from the Hillsborough Disaster and is about preventing a repeat of the problems that families faced during the Inquiry. The charter asks organisations to commit to learning lessons from Hillsborough and its aftermath to ensure the perspective of bereaved families is not lost in any future public tragedies.

This was reinforced during the Kerslake Arena Review following the Manchester Arena bombings in May 2017. A recommendation was made that the leaders of public bodies support the proposal contained in the Hillsborough report by signing up to a 'Charter for Families Bereaved through Public Tragedy.'

Wider adoption and application of the charter again featured in feedback from representatives for bereaved families during the Grenfell Tower Inquiry. The National Fire Chiefs Council (NFCC) are recommending all Fire and Rescue Services across the UK adopt the charter.

## The need for a Charter

The framework that currently exists to investigate the tragic circumstances behind incidents such as the Hillsborough disaster and the Grenfell Tower fire, is complex and will often involve multiple agencies. Families can face an enormous challenge in understanding the roles of various agencies and to participate meaningfully in the numerous legal or investigative procedures.
