SUBJECT: SEND Capital Programme Phase 4: Proposal to expand Woodfield

School onto a Special School Satellite Site at Carrington School

ORGANISATION STRATEGY PRIORITY AREA: Tackling Health Inequality,

Empowering Communities, Enabling a Greener Future

SUMMARY OF ISSUE:

Under section 14 of the Education Act 1996 and section 27 part 3 of the Children and Families Act 2014, Local Authorities have a statutory duty to ensure that:

- 1. There are sufficient schools for primary and secondary education in their areas.
- 2. As the local authority they keep under review the educational provision for children and young people who have additional needs and disabilities (SEND).

Surrey's latest sufficiency modelling projections to 2031-2032, which are based on the previous three year's trends from academic years 2019-2020 to 2021-2022, indicate significant growth in the total number of pupils with Education, Health and Care Plans (EHCPs) resident in Surrey over the forecast period. This projected growth is expected to reach its peak in 2026/27 and 2027/28, before reducing slightly thereafter. By 2031/32, the total number of Surrey EHCP pupils in National Curriculum Years (NCY) 0-14 (age 4-19 years), is projected to be almost 1,700 higher than the 2021-22 total (from 10,536 to 12,228).

Secondary age projections show significantly increasing demand for specialist places across Surrey, from 2,432 places in 2021-2022 which is expected to peak at 3,166 places in 2027-2028, before slightly declining to 2,864 in 2031-2032 (remaining 432 above the number of places in 2021-2022). This represents a 30% increase in demand for specialist school places over that 6-year period and is equivalent to over 700 places. The number of pupils expected to need a specialist placement with a designation of Moderate Learning Difficulties (MLD) (known locally as Learning and Additional Needs (LAN)) shows a similar pattern, increasing from 623 in 2021-22 to peak at 844 in 2027-2028. This represents a 35% increase in demand for specialist school places over that 6-year period and is equivalent to over 200 places with a specialist school designation of MLD.

Surrey's existing state-maintained specialist education estate, which as of academic year 2022/23 includes specialist school places in 51 SEN Units in mainstream schools and in 25 Specialist Schools, has around 4,000 places across all year groups and is at approximately 97% occupancy.

Surrey has a legal duty to manage its state-maintained specialist education estate efficiently. This means ensuring the availability of specialist school places that are appropriately matched to need types, phases of education and geographic location so that all of Surrey's statutory school age children with an Education Health and Care Plan (EHCP) that require a full-time specialist school placement in either a mainstream SEN Unit or specialist school have a named placement, ready for the beginning of the next academic year.

Increased demand for specialist school places over the past 5 years has created sustained reliance on high-cost independent school places to ensure all pupils are able to access a suitable full-time education. The Council's priority is to further reduce reliance on the independent sector, but most importantly ensure local children and young people with additional needs and disabilities who require specialist school placements can have their educational needs met rooted in their local communities and better connected to local support services.

Surrey's Capital Programme is expanding and improving the specialist education estate at pace in order to ensure local children with additional needs and disabilities who require a specialist school placement can have their education needs met close to home and within state-maintained provision wherever possible.

Between 2019 and 2023 Cabinet approved the strategies and capital investment of c£260m for four phases of the Special Educational Needs and Disabilities (SEND) and the Alternative Provision (AP) Capital Programme. With this investment the programme is aiming to deliver 2,440 permanent additional specialist school places in Surrey between 2019-2026 to create capacity for 5,760 state-maintained specialist places by 2030/31.

Aligning with the needs identified through updated 10-year SEND sufficiency modelling and local strategy, the expansion of local state maintained specialist provision is reducing the need for new Non-Maintained Independent (NMI) places to be commissioned.

Prior to the start of Surrey's capital investment, lack of sufficiency and high rates of NMI placements were a major contribution to the accumulation of Dedicated Schools Grant High Needs Block deficit, and equally the investment and development now being delivered and proposed is critical to the return to a financially sustainable position.

A table detailing the proposal below is attached as **Annex 1**.

Proposal: to permanently expand Woodfield School onto a specialist school satellite site at Carrington School, creating 40 additional specialist school places for pupils aged 11-16 years with Moderate Learning Difficulties (MLD)¹ and co-occurring needs.

The proposal requires Surrey County Council to follow the statutory process outlined in the DfE guidance "Making significant changes ('Prescribed Alterations') to Maintained Schools," because it fits into the categories below:

-

¹ The term Moderate Learning Difficulties (MLD) is used to describe the DfE school designation. This is known locally in Surrey as Learning and Additional Needs (LAN).

- The proposals are adding new or expanding existing Special Educational Needs Provision
- Expansion onto an additional site ("or satellite site")

RECOMMENDATIONS:

It is recommended that:

The Cabinet Member for Education and Learning determines the statutory notices published thereby bringing into effect the formal commencement of the proposal to:

 Expand Woodfield School onto a Specialist Satellite site at Carrington School from September 2023

The Cabinet Member for Education and Learning may:

- 1. reject a proposal
- 2. approve a proposal without modification
- 3. approve a proposal with modifications, having consulted the Local Authority and/or Governing Body (as appropriate)
- 4. approve a proposal, with or without modification subject to certain conditions (such as the granting of planning permission) being met.

REASON FOR RECOMMENDATIONS:

The proposal referenced in this paper is aligned with the SEND Capital Programmes aims to deliver 2,440 permanent additional specialist school places in Surrey between 2019-2026 to create capacity for 5,760 state-maintained specialist places by 2030/31.

The Cabinet Member for Education and Learning's approvals and recommendations completes the statutory process in accordance with the DfE guidance "Making significant changes ('Prescribed Alterations') to Maintained Schools."

DETAILS:

Demand for Specialist Places

- The demand for specialist places for children and young people with SEND
 has increased significantly over the last 5 years, and this in turn has
 increased Surrey's sustained reliance on the independent sector to ensure all
 pupils with Education, Health and Care Plans (EHCPs) who require a
 specialist school placement are able to access suitable full-time education.
- Surrey's state-maintained specialist provision is full, and we are expanding this provision at pace to ensure children and young people can have their education needs met close to home and within state-maintained provision wherever possible.

- 3. The Council's Capital Programme forms one important aspect of Surrey's Additional Needs Strategy and Transformation Programme which aims to improve outcomes for children with additional needs and disabilities and embed financially sustainable practices to work within the level of funding available. Prior to SCC entering into a Safety Valve Agreement with the DfE, the Council's High Needs Block was projected to reach a deficit of £118m at the end of 21/22.
- 4. The Council's Safety Valve Agreement with the DfE (March 2022), which aims to eliminate the council's Dedicated Schools Grant High Needs Block (DSG HNB) deficit, includes a condition to deliver an ambitious Capital programme that will improve the long-term sufficiency of statemaintained specialist educational provision that meets the needs of communities across Surrey.
- 5. There has been significant investment in additional state-maintained specialist school places in Surrey over the past four years to enable children and young people to be educated locally to their families. Our strong partnerships with local specialist and mainstream schools have enabled this to happen alongside robust forecasting of demand to understand what the profile of need will look like county-wide over the coming years.
- 6. The Capital Programme is aligned with Surrey's Community Vision 2030, and Surrey County Council's Cabinet endorsed new Inclusion and Additional Needs Strategy 2023-2026, which sets out the ambition that all Surrey's children and young people with additional needs and disabilities are enabled to lead their best life.
- 7. **Annex 2** details the delivery tranches for 2023-2026 and committed projects under the SEND Capital Programme which will complete the long-term expansion of Surrey's state-maintained specialist education estate.
- 8. Cabinet has approved the delegation of authority to Lead Cabinet Members for Education and Learning, Resources and Land & Property to allocate resources from approved budgets required for individual committed projects. This follows endorsement for individual schemes by Surrey's Capital Programme Panel where quality assurance, due-diligence and financial assurance are rigorously assessed to ensure the proposals meet the objectives of the Capital strategy. Projects that do not meet these benchmarks and/or officer scrutiny will not be progressed.
- 9. Surrey aspires for all schools to strengthen their inclusion offer to all children and young people, so that all children and young people can be educated locally, wherever possible. The introduction of new or expanded SEN units in mainstream schools enables this inclusive offer, therefore being of benefit to families, the local authority, and the school populations. This is in line with the Strategy Inclusion and Additional Needs Strategy 2023-26, which defines the Council's strategic priorities to ensure all children have the opportunity to attend a school local to them so that they can learn, grow and develop in their community. Local strategy includes the adopted county-wide commitment to root children in their local communities and ensure no one is left behind.
- 10. Woodfield School is a community school where the Cabinet Member decision is required for significant changes to maintained schools.

Key Outcomes and benefits for children, young people and families:

- 11. The provision of additional specialist places will support the county-wide inclusion plan as well as increasing the availability of places for children and young people with additional needs and disabilities to access in the county.
- 12. Children and young people with additional needs and disabilities can access the help and support they need to thrive and achieve within their local communities. They can go to local education provision that meets their needs, access services and play an active role in the community close to where they live.
- 13. Equity for all children, young people and their families by enabling access to the same level of high-quality support wherever they live in Surrey. We have a good, shared understanding of our children and young people who have additional needs and disabilities in Surrey and our support offer matches their identified needs.
- 14. Expanding Surrey's specialist provision aligns with the Next Steps programme and strategy for post-16 to create local further education and employment pathways such as apprenticeships and supported internships. This enables young people who have additional needs and disabilities to make a successful transition to adulthood and secure employment.
- 15. Capacity created locally will also ensure SEND home to school transport times are reduced in line with Department for Education recommendations, improving congestion and traffic flow around the county.
- 16. Increasing capacity in the Specialist Education Estate is essential to Surrey delivering a sustainable High Needs Block. Achievement of cost containment targets aligned with SCC's Safety Valve Agreement with the DfE that results in an in-year balance in the DSG HNB by 2029/30 allows Surrey to continue to deliver services and support for children, young people, and families, whilst remaining financially sustainable.

CONSULTATION:

- 17. An informal consultation was published from 21 February to 31 March 2023 and further statutory notices were published from 19 April to 19 May 2023. All consultation documents are available at www.surreysays.co.uk. The full statutory notices are also attached as **Annex 3** of this report.
- 18. The consultation analysis for the proposal is attached as **Annex 4**.

RISK MANAGEMENT AND IMPLICATIONS:

19. Sufficiency data requires close monitoring and frequent ratification to ensure projected demand for learners with EHCPs is up to date and accurate. This guarantees an appropriate availability of specialist school places, which are aligned to need, phase of education and geographical location. Latest sufficiency modelling demonstrated a clear need for the additional and changed specialist provision that the proposal will create.

- 20. The Local Authority needs to be satisfied that the appropriate fair and open local consultation and or representation has been conducted and that the proposer has given full consideration to all responses received. To ensure that this is the case the consultation and decision-making processes are quality assured.
- 21. Surrey County Council has worked closely with the school to ensure that parents, carers and young people know about the consultation proposals and have had sufficient opportunity to share their views through a number of channels including public and stakeholder meetings, written responses, email correspondence and online response forms.

Financial and value for money implications:

- 22. The capital project is part of Phase 4 of the SEND Capital Programme agreed by Surrey County Council Cabinet on 25 January 2022.
- 23. The capital investment for the project was approved under the 2023/24 delivery tranche by Surrey County Council Cabinet on 28 March 2023. The re-purposing and refurbishment work at Woodfield School is planned to be completed by winter 2024. Refurbishment of existing space to provide temporary accommodation for pupils starting in September 2023 will be completed in August 2023.
- 24. The projected revenue benefits and associated projected cost containment comes from the reduced unit cost of a placement within a Surrey maintained school compared to a Non-Maintained Independent setting. As part of the wider Additional Needs and Disabilities Transformation Programme, places created and filled such as this contribute to reducing Surrey's High Needs Block annual deficit.

Section 151 Officer commentary:

25. Significant progress has been made in recent years to improve the Council's financial resilience and the financial management capabilities across the organisation. Whilst this has built a stronger financial base from which to deliver our services, the increased cost of living, global financial uncertainty, high inflation and government policy changes mean we continue to face

- challenges to our financial position. This requires an increased focus on financial management to protect service delivery, a continuation of the need to be forward looking in the medium term, as well as the delivery of the efficiencies to achieve a balanced budget position each year.
- 26. In addition to these immediate challenges, the medium-term financial outlook beyond 2023/24 remains uncertain. With no clarity on central government funding in the medium term, our working assumption is that financial resources will continue to be constrained, as they have been for the majority of the past decade. This places an onus on the Council to continue to consider issues of financial sustainability as a priority, in order to ensure the stable provision of services in the medium term.
- 27. The recommendations within this paper support the expansion of SEN provision in Surrey to meet demand and deliver financial sustainability in line with the DfE Safety Valve agreement. The Section 151 Officer therefore supports the proposal.

Legal implications – Monitoring Officer:

- 28. Section 13 of the Education Act 1996 places a general duty on the Council to secure that efficient primary and secondary education is available to meet the needs (including special educational needs) of the population in its area. In doing so, the Council is required to contribute to the spiritual, moral, mental and physical development of the community.
- 29. Section 14 of the Education Act 1996 places a duty on the Council to secure that sufficient schools for providing primary and secondary education are available in its area.
- 30. Section 27 Children and Families Act 2014 places a duty on the local authority to keep under review the educational provision for children and young people who have special educational needs and or a disability.
- 31. The local authority has published statutory notices thereby bringing into effect the formal commencement of the proposal prior to the consultation stage in accordance with statutory requirements. The notices were published between 19 April 2023 and 19 May 2023.
- 32. In considering this Report, the Cabinet Lead Member for Education and Learning must give due regard to the results of the informal consultation as set out in the report and the response of the Service to the consultation comments and conscientiously take these matters into account when making a final decision.

Corporate Parenting/Looked After Children implications:

- 35. The creation of additional specialist places directly supports both the Surrey Corporate Parenting Strategy and the Additional Needs and Disabilities Strategy 2023-2026.
- 36. The proposal would provide increased provision for pupils who need a specialist placement in a mainstream school in Surrey, thereby ensuring that those who are Looked After and/ or who have additional needs and disabilities are closer to home, more connected to local communities and support services.

Safeguarding responsibilities for vulnerable children and adults' implications:

- 37. Safeguarding vulnerable children is a high priority in all Surrey schools. Schools have considerable expertise in safeguarding vulnerable children and adhere to robust procedures. The schools will continue to apply good practise around safeguarding as they do currently. In addition, safeguarding is a key area for monitoring when Ofsted conducts inspections.
- 38. The creation of additional specialist school places closer to home supports highly effective joint agency monitoring to safeguard children, to reduce placement breakdown and increased demand on statutory care services.

Environmental sustainability implications:

- 39. The provision of education places closer to home will reduce the average journey times for learners with EHCPs and is aligned with the vision and aspirations of the Home to School Travel Assistance transformation programme.
- 40. The design philosophy is to create buildings that will support low energy consumption, reduce solar gain and promote natural ventilation. Any new infrastructure will be built to the local planning authority's adopted core planning strategy.

WHAT HAPPENS NEXT:

- 41. Subject to the Cabinet Member determination, Surrey County Council and the Governing Body will proceed to implement the proposal to expand Woodfield School onto a satellite site at Carrington School
- 42. The significant change will be implemented from 1 September 2023.

Introduction

This document outlines a proposal to permanently expand Woodfield School onto a specialist school satellite site at Carrington School, creating 40 additional specialist school places for pupils aged 11-16 years with Moderate Learning Difficulties (MLD)¹ and co-occurring needs. All pupils will have an Education, Health and Care Plan (EHCP).

Proposal

Surrey County Council, in partnership with the Governing Body of Woodfield School, Carrington School and South East Surrey Schools Education Trust, is proposing to expand Woodfield School to create 40 additional places. The 40 place expansion will be provided on a specialist school satellite site at Carrington School. This would expand Woodfield School from 180 places to 220 places. All pupils will be on roll at Woodfield School and have an Education, Health and Care Plan (EHCP) that names Woodfield School satellite site at Carrington School as the appropriate placement to meet their individual needs.

Table 1 shows the proposed timeline for the changes to take place on 1 September 2023. Dates and steps in the timeline may change based on the outcome of this consultation.

¹ The term Moderate Learning Difficulties (MLD) is used to describe the DfE school designation. This is known locally in Surrey as Learning and Additional Needs (LAN).

It is proposed that:

- 1. The expansion on the new site will be for up to 40 pupils with Moderate Learning Difficulties (MLD) and co-occurring needs from Year 7-11.
- 2. The main intake point will be at Year 7 key stage transfer and, where there are spaces and demand, new pupils may be accepted in the school in other year groups.
- 3. When full, there will be 5 classes of 8 pupils aged 11-16 years old across key stages 3 and 4 at the Woodfield School Specialist School Satellite Site at Carrington School. Pupils will be grouped according to age, individual needs and learning styles.
- 4. There are no sixth form places proposed at the Woodfield School Specialist School Satellite Site at Carrington School. There are a broad range of options available at key stage 5 and these will be discussed regularly at Annual Reviews leading up to transition.
- 5. Pupils who attend the satellite site at Carrington will be on roll at Woodfield School with the Woodfield School Satellite Site at Carrington School named in Section I of the Education Health and Care Plan (EHCP).

Admissions processes remain the same as the main site at Woodfield School. Further details on the admissions process for SEND specialist provision in Surrey can be found on the Surrey Local Offer website. The webpage Choosing a school place for a child with an EHCP describes how to apply for a specialist school place.

Background

Woodfield School currently provides specialist education for pupils aged 11-19 years with a capacity of 180 planned places. Woodfield School is still growing after expanding in September 2022 from 120 to 180 planned places (160 across Year 7 to Year 11 and 20 places across the sixth form). As of April 2023 there are currently 158 pupils on roll at the school, growing to 180 by September 2023. **Table 2** shows the break down per Year Group as of academic year 2022/23. The school has a 'Good' OFSTED rating from its most recent inspection in October 2022.

Carrington School is an Academy within the South East Surrey Education Trust. It is a 7 form entry Secondary School in the borough of Reigate and Banstead with a published admission number (PAN) of 210 in Year 7. There are 1050 places across all year groups.

School Vision and Curriculum

The satellite site is an expansion of Woodfield School and therefore the school vision remains that of Woodfield School.

Woodfield School's mission is: Preparing pupils for adulthood: Developing learners that are happy, successful and increasing in independence.

The school aims to do this by:

- Creating a safe, happy and vibrant learning community
- Valuing and respecting all who work within it
- Celebrating all effort and achievement
- Empowering students to realise their full potential

Empowering students to persevere and develop into independent, young citizens
 The school's Values are:

- Supporting and caring
- Belonging and worth
- Fairness
- Respect
- Fulfilling potential
- Developing independence and a 'can do' attitude.

The expansion of Woodfield School on a satellite site at Woodfield at Carrington aims:

- To strengthen Woodfield and Carrington Schools' inclusion offer to all children and young people, therefore being of benefit to local communities, the two school populations and the Local Authority.
- To enable better long-term outcomes for all of our students as they prepare for adulthood and future employment.
- To offer a unique learning environment for Woodfield School students who would benefit from a bespoke provision across both mainstream and specialist settings.
- For some Carrington School students to access specialist pastoral support provision and interventions.
- Students, staff and parents/carers across both schools will be able to benefit from the skill sets of the diverse range of staff expertise across Woodfield and Carrington schools.

Surrey County Council's ambition is that the introduction of more SEN Units and/or special school satellite sites in secondary schools would be an opportunity for schools to strengthen local partnerships and their inclusion offer to all children and young people; therefore being of benefit to local communities, the school populations and the local authority.

The Woodfield School satellite site will provide for pupils with moderate learning difficulties and co-occurring needs, broadly in line with the current offer at Woodfield School. There will be opportunity to access inclusion and where possible, parts of the curriculum at Carrington School.

The additional places are for pupils who will be on roll at Woodfield School and who would be based at the satellite at Carrington. The leadership and Governance of Woodfield School will be across the two sites and therefore there will be opportunities for all pupils to benefit from shared resources across the two sites.

Current Special Educational Needs provision at Woodfield School

Woodfield School currently provides specialist education for pupils aged 11-19 years. The school has a 'Good' OFSTED rating from its most recent inspection in October 2022. It provides highly specialist teaching and support for students with Education, Health and Care Plans (EHCPs) with moderate learning difficulties and a range of co-occurring additional needs and disabilities. Woodfield is recognised nationally (Alex Timpson ARC Attachment Award 2021) for its systemic Trauma Informed and Therapeutic Approach, supporting pupils to learn to manage their own needs and access learning with increasing confidence and independence. The Trauma Informed

and Therapeutic Approach will be fundamental to the pedagogy of the proposed collaboration and to the vision of the right provision at the right time, with pupils supported across the two schools working together to meet their very individual needs.

Pupils with moderate learning difficulties have much greater difficulty than their peers in acquiring basic literacy and numeracy skills and in understanding subject-specific concepts. They may also have associated speech and language delay, low self-esteem, low levels of concentration and under-developed social skills. Many of the pupils attending Woodfield School have additional needs and disabilities including communication and interaction needs, medical needs, sensory, or emotional needs resulting in complex learning needs. The school enables pupils to realise their personal potential by creating a safe, happy and vibrant learning community where all effort and achievement is celebrated, where pupils are empowered to persevere and develop independence and through valuing and respecting all who form part of the wider school community.

Current Additional Needs and Disabilities provision at Carrington School

Carrington School provides education for pupils aged 11-16 years where the focus is upon delivering high quality learning opportunities that engage all students and ensures they can acquire the knowledge needed for each stage of their education and help them gain the qualifications they need to see them onto the post-16 courses and into the future career of their choice. The opportunities within and beyond the school curriculum are both rich and diverse. Not only do the school run the traditional sports, choirs and performance-style clubs, but enable all students to choose an enrichment activity as part of Carrington School's Excellence Programme (within curriculum time) to help them find and develop their talents. Encouraging students to try new things, to be involved, to work as a team and with students from other year groups to build that sense of togetherness.

Carrington School has a Director of Inclusion (SENCo, Special Educational Needs Coordinator) that manages and oversees additional support and interventions, in liaison with the Senior Leadership Team (SLT), Home School Link Worker (HSLW), Heads of Year, Heads of Department, Heads of Faculty and teachers to ensure that additional support is carefully planned, monitored and reviewed for impact on learning. The Learning Support (LS) Faculty work with students in and out of the classroom. The focus is on Quality First Teaching (QTF, Level 1) for all students; and there is a recognition that Targeted (Level 2) and Specialist (Level 3) support for a number of students will be needed for some students. These interventions take place on a rolling programme; are time bound and well-structured; and carefully monitored for impact.

What will be provided through the Specialist School Satellite Site?

The new satellite site would be staffed and managed by Woodfield School and provide 40 places for pupils aged 11-16 years with identified moderate learning difficulties and co-occurring needs.

These would be pupils on roll at Woodfield School who, in agreement with parents and carers, would also benefit from the enhanced learning and social opportunities that Carrington School can provide. The aim is for the expansion to utilise space on the Carrington site to provide specialist facilities to support learning for both Woodfield and Carrington students.

What do we want to achieve?

Surrey's SEND Capital Programme is aligned with Surrey's Community Vision 2030, and Surrey County Council's Cabinet endorsed new Inclusion and Additional Needs Strategy 2023-2026, which sets out the ambition that all Surrey's children and young people with additional needs and disabilities are enabled to lead their best life.

There has been significant investment in additional state-maintained specialist school places in Surrey over the past four years to enable children and young people to be educated locally to their families and home communities. Our strong partnerships with local specialist and mainstream schools have enabled this to happen alongside robust forecasting of demand to understand what the profile of need will look like county-wide over the coming years.

Between 2019 and 2022 Cabinet approved the strategies and capital investment for four phases of the Special Educational Needs and Disabilities (SEND) Capital Programme. On 31 January 2023 Cabinet approved the refreshed Capital Medium Term Financial Strategy which provides £202m for SEND Capital against committed and planned projects in 2023-2026 delivery tranches. With this investment the programme is aiming to deliver at least 2,440 permanent additional specialist school places in Surrey between 2019-2026 to create capacity for 5,760 state maintained specialist places to meet projected demand for up to 6,000 specialist places in total by 2030/31.

As of academic year 2022/23, Surrey's state-maintained specialist education estate has been increased by approximately 800 places, from around 3,320 in 2019 when the Capital programme started to around 4,000 places now. These specialist school places are almost full, noting that new places are being phased in and some of the existing accommodation needs to be re-provided as it is not fit for purpose.

Our ambition is that the introduction of more specialist school satellite sites in mainstream secondary schools would be an opportunity for schools to strengthen local partnerships and their inclusion offer to all children and young people, therefore being of benefit to pupils, the schools' communities and the local authority.

The specialist school satellite site at Carrington School will provide for pupils with moderate learning difficulties and co-occurring additional needs and disabilities, broadly in line with the current offer at Woodfield School. The total capacity at the satellite site will be 40 places. The proposed expansion of Woodfield School on a Satellite Site at Carrington School will:

- Enable the students attending the satellite site at Carrington to access supported mainstream accredited curriculum and specialist approaches to both learning and emotional wellbeing.
- Provide wider access and opportunities to more diverse routes around pathways to adulthood.

- Offer Continued Professional Development (CPD) training opportunities for staff across both sites.
- Provide additional nurturing opportunities through collaboration between the two schools for pupils who need a more individual, personalised approach to access their learning from the mainstream site.
- Provide an integrated environment so that pupils gain a sense of their own social identity and access to a peer group so they feel a greater sense of self and belonging.
- Provide an improved learning environment for all pupils by repurposing, refurbishing and adapting existing space and a new building to re-provide space needed at Carrington School.

Reasons for expanding the school on a satellite site


Demand for specialist school places in Surrey

Surrey County Council has identified a long-term sufficiency gap for additional specialist places across Surrey. Demand for specialist provision in the South East of Surrey for secondary age pupils with moderate learning difficulties (MLD) and co-occurring needs is high. As a result, other specialist provision in the local area is already operating at or above capacity. The provision of an additional 40 places will help support local families who would otherwise have to travel further afield for their child to receive an appropriate full-time education.

The proposed expansion of Woodfield School into a specialist school satellite site at Carrington School will increase availability of specialist places that are matched appropriately to need-type, phases of education and geographic location, as well as reduce home to school journey times and associated costs.

Graph 1 shows a forecast 32% increase in demand for Moderate Learning Difficulties (known locally as Learning and Additional Needs) designated specialist school places from 2022/23 to 2026/27. This is equivalent to circa 50 additional places.

Key Outcomes and Benefits

Expanding high quality and sustainable specialist school provision for Surrey resident secondary age pupils will provide the following benefits as stated in the <u>SEND Capital Programme 2023 2024</u> <u>Delivery Tranche</u> report to Cabinet on 28 March 2023:

- 1. Benefits realisation ensures Surrey's maintained specialist education provision is fit for purpose and creates additional employment/supported internship opportunities for residents around areas of expansion.
- Children, young people, and families can access the same level of high-quality support
 wherever they live in Surrey. We have a good, shared understanding of our children and
 young people who have additional needs and disabilities in Surrey and our support offer
 matches their identified needs.
- 3. Expanding Surrey's specialist provision aligns with the Preparation for Adulthood programme and strategy for post-16 to create local further education and employment pathways such as apprenticeships and supported internships. This enables young people who have additional needs and disabilities to make a successful transition to adulthood and secure employment.
- 4. Capacity created locally will also make certain that SEND home to school transport distance and costs are reduced so that pupils attend their closest most appropriate school with shorter journey times. Opportunities for developing independent travel skills can be maximised as a result of children and young people being educated closer to home. This will also address local congestion around school sites as well as traffic flow around the county, which will be of benefit to Surrey's Green Agenda.
- 5. The approved remodification and expansion programme will ensure that additional places are matched appropriately to need type, phases of education and geographic locations.

Implementation Plan

Finance and Resourcing

Revenue income: Woodfield School will receive £10,000 for each planned place commissioned (40 places) and will also receive a "Top up" sum for each pupil on roll at the school. This is determined against individual pupils' needs. Top up rates are reviewed annually by the Local Authority.

Lease agreements between Woodfield School and South East Surrey Schools Education Trust (SESSET) will determine arrangements to transfer any funds for admin, utility and running costs at the site at Carrington School.

Leadership, Governance and Staffing

The Leadership and Governance of the satellite site remains with the Governing Body of Woodfield School. Staff will be employed by Woodfield School, and the Headteacher and

Governing Body will be responsible for recruiting and managing staff at the satellite site at Carrington School. Woodfield School is a community school. There will be opportunities for shared training and development across Woodfield School and Carrington School.

Capital planning and buildings

The Capital project is part of SEND Capital Programme's 2023/24 delivery tranche approved by Surrey County Council's Cabinet on 28 March 2023.

Carrington School is 3 miles from Woodfield School and therefore the satellite site is in the same area as Woodfield School with both schools located in Redhill. A feasibility study is due to be completed in May 2023 and will inform the technical approach to refurbish and repurpose existing space at Carrington School to accommodate the satellite site for Woodfield School and re-provide additional space at Carrington School. The scheduled date for delivery of the project is August 2024. The feasibility study includes arrangements for temporary accommodation at Carrington School in the school year 2023/24 while the building project is in progress.

Growth Model

It is proposed that there will be 8 additional places available in September 2023, which is the proposed first year of opening in temporary accommodation at Carrington School. The table below shows how the specialist school satellite will grow from September 2023 to full capacity in September 2026. The growth model may change depending on timescales and the outcome of the property feasibility study. The main intake point will be key stage transfer in Year 7, although, where there are spaces and demand, new children may be accepted into the school in other year groups.

Impacts

The associated documentation was published on the Surrey County Council 'Surrey Says' website. Interested parties were invited to return responses to the consultation via an online form or alternatively email or post responses.
- 3. The consultation analysis is published at www.surreysays.co.uk on the Statutory Notice webpage alongside this document.

Key points from the consultation responses:

- 50 people responded to the consultation.
- 52% (26) of respondents agreed with the proposal, 32% (16) disagreed and 16% (8) didn't know how they felt about the proposal.
- 68% (34) of respondents left comments regarding the proposal.
- The theme with the highest prevalence in the comments was questions about funding, resources, provision and staffing.

Questions raised during the informal consultation period are addressed in this document and a Question and Answer document published alongside this Statutory Notice.

- 4. Statutory Notice is now open for a four-week period from Wednesday 19 April 2023 and concludes on Friday 19 May 2023.
- 5. The publication of Notices is when the local authority formally states that it intends to implement the proposed changes. Consultation Analysis – Proposal to expand Woodfield School onto a Specialist School Satellite site at Carrington School

Introduction

This report is an analysis of responses gathered on the proposal to expand Woodfield School onto a Specialist School Satellite site at Carrington School.

Surrey County Council published an informal consultation from 21 February 2023 to 31 March 2023.

Part 1 of this paper is an analysis of the responses received during the informal consultation notice period and Part 2 is an analysis of the responses during the Statutory Notice period. The summary and key points give a summary of the findings from both consultations. This paper will be submitted to the Lead Cabinet Member for Education and Learning for consideration to determine the statutory notices on 27 June 2023.

Consultation Summary

The aim of the consultation was to seek views on the proposal from all interested parties, particularly from pupils and their families who attend both Woodfield School and Carrington School, pupils and their families who may attend the schools in the future, and the views of the local community.

The informal consultation was open from 21 February 2023 to 31 March 2023. The associated documentation was published on the Surrey County Council 'Surrey Says' website and circulated to local stakeholders. Interested parties were invited to return responses to the consultation via an online form or alternatively email or post responses.

A public meeting was held on 14 March 2023.

The Statutory Notices were published from 19 April 2023 to 19 May 2023. The associated documentation was published on the Surrey County Council 'Surrey Says' website and circulated to local stakeholders. The notices were also published in the Surrey Mirror on 20 April. Interested parties were invited to return responses to the consultation via an online form or alternatively email or post responses.

An Equality Impact Assessment (EIA) is in progress and has been informed by responses to the informal consultation period. The Equality Impact Assessment will continue throughout the statutory notice period and will be submitted with papers at the Cabinet Member for Education and Learning Meeting.

Key points from the consultation responses:

- 1. There were **50** responses to the informal consultation and **7** responses during the statutory notice period.
- 2. **52%** of respondents to informal consultation **agreed** with the proposal, 32% (16) disagreed and 16% (8) didn't know how they felt about the proposal.
- 3. 100% of respondents to the statutory notices agreed with the proposal.
- 4. The theme with the highest prevalence in the responses to the informal consultation was questions about funding, resources, provision and staffing.


5. The comments left during the statutory notices centred on the positive impact on inclusion and pupils attending the schools.

Part 1 - Informal Consultation

Quantitative Analysis

In total, there were 50 responses to the consultation. 52% (36) of respondents agreed with the proposal, 32% (16) of respondents disagreed with the proposal and 16% (8) of respondents stated they didn't know.

The chart below shows the category respondents selected to show their relationship to the school. Due to a technical difficulty some respondents did not have the ability to select parent/carer of a child attending Woodfield or parent/carer of a child attending Carrington. Therefore some respondents who selected A parent/carer of a child attending another local school may be parents of a child at Woodfield or Carrington.



Percentage who agreed/disagreed/didn't know by individual groups

There were 19 responders who selected parent/carer of a pupil attending Carrington School – 38%

5 agreed with the proposal, 9 disagreed with the proposal and 5 didn't know.

There were 19 responders who selected either parent/carer of a pupil attending another local school (24%) or parent/carer of a pupil who may attend the school in the future (14%)

10 agreed with the proposal, 6 disagreed with the proposal and 3 didn't know.

There were 11 responses from staff members at the school, staff member at another school and other links to the school.

10 agreed with the proposal and 1 disagreed with the proposal.

Qualitative Analysis

Respondents had the opportunity to add comments at the end of the survey. Out of the 50 responses received, 34 comments were made on the proposal. These comments were broadly themed and then separated into 8 possible tags. Each response could have more than one tag attached. The overall frequency of each of the tags provides an indicator of respondent's main concerns regarding the proposal.

Key themes from the consultation

Positive impacts

Need for more specialist provision

21% (7) of respondents commented on the need for more specialist provision with one comment stating there is a "need for this school and more schools like it" and another comment emphasising the "desperate need for more specialist spaces, both primary and secondary." At least two respondents highlighted the need for more places closer to home stating that the "current local specialist provisions are not sufficient for the calculated number of SEND children" and leave parents/carers "with no choice but to cross county borders and take well needed spaces from other SEND children."

"this is expansion is hopefully the beginning of some well overdue provision for these children"

"It would allow more with children with a MLD to be educated in their local area/community."

"Our vulnerable children need a safe, suitable and nurturing provision to achieve their full potential"

"As the Headteacher of a mainstream school, we have a number of children with specialist on their EHCP but they are unable to find a placement. This would really benefit the children who require specialist support"

For students/pupils

18% (6) of total responses observed that the proposal would have a positive impact on students and that "children at Carrington would benefit from this and the extra understanding and support" of the satellite site. One commenter highlighted that the "sharing of specialist teaching expertise" would be an "additional advantage for all professionals" and "excellent for all students." 3 respondents spoke of the inclusive experience that the proposal would bring about for all students, with one commenter stating that "there is too much segregation for people with disabilities" and that mainstream pupils would benefit in being "more aware of children with additional needs."

Another respondent reflected that it would be a "great lesson of acceptance and understanding for the Carrington School students but shouldn't be at the expense of the Woodfield students." A further two respondents commented on the positive impact that the "sharing of specialist teaching expertise" would have and that "Carrington School has a good reputation for looking after SENS (sic) pupils and parents."

"For students at the satellite to have representation in a mainstream school only serves for a more inclusive experience without forgoing specific support"

"As a parent who has visited Woodfield previously I know the school to be a wonderfully gentle and loving environment, I believe Carrington could improve on this"

"Anything to assist specialist school learning is a positive thing for the area"

Negative Impacts

Inclusion/integration concerns

Of the 50 comments made, 29% (10) respondents felt that the Woodfield satellite site at Carrington School could have a negative impact on the inclusion and integration of some students. One respondent wanted to "ensure the Carrington School is briefed and ensures to the best of their ability that children attending there are accepting of the kids there." One respondent felt that parents would choose a specialist provision "due to the fact they would not cope with mainstream and the possible bullying that would take place" they were also concerned resources could be taken from the current Woodfield site.

Some respondents felt that the proposal hadn't gone far enough to explain "how the children of Woodfield are going to integrate with the children at Carrington for example will they be sharing the same communal areas, canteen, library, sports facilities etc" and that more thought was needed on "how Woodfield children would be included in Carrington."

"I don't understand why you would want to place these children on the grounds if another secondary school where either they have the potential to cause disruption at the Carrington or they are still treated and views differently by the children at Carrington"

Some respondents misinterpreted parts of the proposal and worried that pupils at the satellite site would be wearing the Woodfield School uniform and be seen as different from other pupils

on the site at Carrington. They also worried that the proposal meant moving pupils who are currently at Woodfield School to the satellite site.

For students/pupils

32% (11) of total respondents voiced concerns that the proposal would have a negative impact upon the students, specifically pupils at Carrington school and the availability of staff and resources. Several commenters felt that Carrington School was already "stretching it's resources" and "cannot cope with its own students, let alone anyone else's with special learning needs."

Three respondents referred to the impact of the Carrington School's previous Ofsted inspection and the efforts required to strengthen its position whilst embedding the satellite site students "could result in the school slowing or even regressing back to where it was several years ago." At least two comments left expressed fears that the additional pupils would have the "potential to cause disruption" and display behaviours that would take staff away from teaching.

"I don't think that at the moment, the school has the infrastructure to accommodate additional numbers, with too much reliance already on substitute teachers."

"...we need to let the school start to work on to initially raise and build (it's) own education rating - they are just at the start of this journey and do not need further challenges..."

Parking and traffic

12% (4) of respondents reported concerns around parking and additional traffic to the area around the school, citing the need to incorporate a "safe drop off point." One comment highlighted that the current school traffic makes it "quite stressful and dangerous getting your child to the gate safely" and another pointed out that some students "may have anxiety and other needs that mean dropping off on a nearby road may not be acceptable."

"There is already a significant issue with inadequate parking...[...]...and with no local on-street parking available for overflow this has to be addressed if the school is to retain staff"

"...it is already difficult to get near the school in the mornings to be able to get the children in the door on time. I think that you would also have complaints from local residents about the increased number of cars at these times"

Questions and ideas

Funding, resources, provision and staffing

47% (16) respondents had further questions regarding how the satellite site would be funded, staffed and what type of provision was being offered. 3 people commented on what they felt was a lack of space to accommodate more students with one person suggesting that "children with MLDs may well need more space and a less crowded/noisy environment than the one experienced by children at Carrington School." Another commenter felt that there was little information available to indicate "where these new students will be taught as space must be limited already" and wished to "know more on how this will effect current students attending Carrington School."

Several respondents queried "where the budget for these additional places will come from" and voiced concerns around "increasing capacity of the school which is already under pressure to offer services."

Within the 16 comments, 2 were concerned with the impact on staffing and wanted to know if "any of the teachers (now or in future) from Carrington are to be utilised by the satellite school" and "if teachers from Woodfield are at Carrington teaching then surely that will take them away from teaching the children at Woodfield?" Other respondents wanted further information on the type of provision that was being offered and of "what ability the children will be on that satellite site"

"If resources at the Carrington are going to shared then I can see this causing a lot of timetabling problems and making the school busier at lunch and break times when there is already competition for space and use of the canteen etc"

"Will the new EHCP intake be using all the facilities/clubs etc?"

Benefits to Carrington school/inclusion for students

18% (6) respondents wanted to know more information about what benefits the satellite site would bring to pupils at Carrington School and how satellite site students would be integrated into the mainstream population. One respondent wished to know "what benefits (financial or otherwise) will Carrington school gain from annually from having the satellite school on their grounds" whilst another asked if "the children all mix together or taught separately?"

There's little information on how this will affect the children at Carrington School, how will this benefit them. Will the Woodfield school pupils have access to Carrington facilities or be separate? More information is needed"

"I have a child at the Carrington school and would like to know how adding another 40 places for children (on roll at a different school) will impact the Carrington school children.

"Thought needed on how Woodfield children would be included in Carrington. They would stand out in their different (more bright) coloured uniform."

"I don't know who would benefit here?? ECHP students possibly not as they are used to being in a provision for just those with EHCPs and what age would the students be?"

Some respondents misinterpreted parts of the proposal or had questions about the proposal. A Question and Answer document will be published alongside the statutory notices to clarify points mentioned in the comments above.

Public Meetings

An online public meeting was held on 14 March using MS Teams. There was a short presentation followed by a question and answer session for attendees.


9 people (not including school and Council staff) attended the meeting.

Part 2 – Statutory Notices

Quantitative Analysis

There were 7 responses to the consultation. 100% of respondents agreed with the proposal.

The chart below shows the distribution of responses to the consultation. Four respondents selected "A parent/carer of a child attending Carrington School". The other 3 respondents selected "Other link the school" and provided further information about their relationship to the schools i.e., teacher from another local school.



Qualitative Analysis

Respondents had the opportunity to add comments at the end of the survey. Out of 7 respondents, 5 left comments.

The comments left all fell under two main themes; the **positive impact on inclusion** and **the positive impact on pupils** attending the schools.

"Done well, the integration benefits pupils and staff at both schools and their understanding of the needs of other people."

"I feel that this would be a fantastic opportunity for both schools to collaborate and develop the delivery of the SEN offer..... I think it will also have a hugely positive impact on social, emotional, mental health of the pupils who do tend to struggle in a mainstream setting and have additional learning needs"

"I think this project can benefit Carrington students as well as Woodfield students enormously, it is really exciting. I am glad to see collaborative work going on between schools. Everyone benefits!"

Recommendations: what happens next?

The recommendation is that a report will be submitted to the Lead Cabinet Member for Education and Learning for consideration to determine the statutory notices at the decision meeting on 27 June 2023.



Pupils who may attend the school in the future

The expansion on the new site will be for up to 40 pupils with Moderate Learning Difficulties (MLD) and co-occurring needs from Year 7-11 with an Education Health and Care Plan (EHCP) in Surrey.

Graph 1 shows a forecast 32% increase in demand for Moderate Learning Difficulties (known locally as Learning and Additional Needs) designated specialist school places from 2022/23 to 2026/27. This is equivalent to circa 50 additional places.

The Report to Surrey County Council on 28 March 2023 <u>SEND Capital Programme 2023 2024</u> <u>Delivery Tranche</u> outlines the delivery of additional specialist school places and intended benefits to surrey's children, young people and residents:

- 1. Benefits realisation ensures Surrey's maintained specialist education provision is fit for purpose and creates additional employment/supported internship opportunities for residents around areas of expansion.
- Children, young people, and families can access the same level of high-quality support
 wherever they live in Surrey. We have a good, shared understanding of our children and
 young people who have additional needs and disabilities in Surrey and our support offer
 matches their identified needs.
- 3. Expanding Surrey's specialist provision aligns with the Preparation for Adulthood programme and strategy for post-16 to create local further education and employment pathways such as apprenticeships and supported internships. This enables young people who have additional needs and disabilities to make a successful transition to adulthood and secure employment.
- 4. Capacity created locally will also make certain that SEND home to school transport distance and costs are reduced so that pupils attend their closest most appropriate school with shorter journey times. The permanent building expansion is due to be completed in September 2024 and will be subject to any relevant permissions. On the rare occasion that pupils at the Woodfield site would benefit from inclusion and access to specific GCSE offer then those pupils would be provided with a bespoke curriculum timetable and this would be in agreement with parents/carers and supporting professionals.
		The satellite leadership will liaise with Carrington School leadership to identify where there are opportunities for celebration/joint events.
8.	What is the benefit/impact of the satellite site for existing Carrington students?	Developing a sustainable offer to support pupils with Moderate Learning Difficulties (MLD) will benefit the whole school. The satellite centre is an expansion of Woodfield School and a partnership agreement between Woodfield School and Carrington School and South East Surrey Schools Education Trust, will include how the two schools will work together to benefit both schools. On the very rare occasion that a young person at Carrington School would benefit from the provision at the Woodfield Satellite centre, this will only be considered through significant liaison with parents/carers and the young people themselves and agreed via the Annual Review of the EHCP process with all relevant professionals - at which point the EHCP will be amended to reflect the change of placement.

		Staff at Carrington School will continue to support all pupils in the school. All staff will benefit from shared learning and resources available with the additional staff employed by Woodfield School at the satellite centre. 
