# TITLE: Speed Limit on the Sutton-Banstead stretch of A217 ("Mad-Mile") to 40mph with immediate effect

We the undersigned petition Surrey County Council to Limit the speed on the stretch of the road that connects Sutton to Banstead on the A217 to 40 mph both ways (Sutton - Banstead and Banstead - Sutton). This stretch has a current limit of 60mph which is often abused.

#### Justification:

The stretch of road from Sutton to Banstead on the A217 (often dubbed the "mad-mile") is a dual carriageway with a speed limit of 60 mph.

The speed limit on this road is often abused, with cars accelerating suddenly as they get to that stretch and some even "racing" against other cars, with no heed to other road users, and in some cases, pedestrians using the footpath along the south road (Sutton to Banstead).

This has recently led to severe accidents on that stretch, most of which could have been avoided if there was an imposed limit of 40 mph.

Also, there is no valid reason why this short stretch of road should allow a limit of 60 mph, when the rest of the A217 stretch has a limit of 40 mph.

This petition is to request the limit be reduced from 60 mph to 40 mph with immediate effect and to impose the limit with working speed-cameras.

It should take vehicles travelling along that stretch about 20 seconds longer to traverse that stretch, which seems justified considering the safety of other road users and pedestrians.



# **RESPONSE:**

Many thanks for raising your concerns over this stretch of road. Following previous recent representations made by local people and the Local Member Luke Bennett, the County Council Road Safety Team discussed this stretch at the 6 monthly Road Safety Working Group meeting for Reigate and Banstead in April. This meeting is hosted by the Road Safety Engineering team with attendees from the Highways Engagement and Commissioning Team and police road safety specialists.

Officers discussed and reviewed this site with reference to speed survey data that they had obtained (this is shown below for interest), and road casualty data (a summary of which can be seen via www.crashmap.co.uk). It was noted that there had been a history of collisions including some resulting in serious injury. As well as collisions on the link there are collisions at the junctions at either end. There are two crossing points (including one regularly used by golfers), and a shared pedestrian/cycle path on the east side. It was also noted that the rest of the A217 north and south of this stretch have a 40 mph limit, and that there is a longer term desire to provide signalised crossing facilities for use by the golfers (and other users of the public right of way). Taking all these factors into account it was concluded that the group would support the introduction of a lower 40 mph speed limit on this stretch. This would be preferred compared to a lower 50 mph limit due to the factors described above.

The County Council's Road Safety Engineering Team have already allocated their central road safety budget on other schemes across the county where there has been a history of collisions during the current financial year. Therefore, we would be able to tackle this stretch with our central budget to implement a lower 40 mph speed limit in the following financial year starting in April 2024. Once implemented we will undertake similar speed surveys to check on the success of the scheme and compliance with the new speed limit. This will inform on the need for any additional measures to manage speeds successfully on this stretch.

#### TITLE: Install a toucan crossing on the A325 at the junction with Water Lane, Farnham, Surrey - so pedestrians can cross safely

We the undersigned petition Surrey County Council to install a toucan crossing on both sides of the dual carriageway of the A325 at the north end of Water Lane where it meets the dual carriageway.

#### Justification:

Pedestrians walking from Badshot Lea and Weybourne into Farnham have to cross the dual carriage. The route is used by school children heading to Heath End School and workers on the local industrial estate and at Sainsburys. It also provides the flatfish route to the hospital for many with physical disabilities.

Crossing the dual carriage way from the Sainsburys side is particularly harrowing. The speed of the cars combined with the bend of the carriage makes it difficult for pedestrians. At this time of year (summer) the vegetation also makes visibility difficult.

Trying to cross the other carriage way is a challenge as cars speeding off the Shepard and Flock Roundabout have no reason to slow as there is no traffic entering the roundabout to slow them.

The Water Lane junction with the roundabout is schedule for refurbishment and that will include a Toucan crossing to take pedestrian across water lane. It makes sense to use this opportunity to install a crossing on the dual carriageway as well. It will save on cost and disruption.

# **RESPONSE:**

It is appreciated that this petition is requesting a new controlled Toucan crossing to be constructed at the A325 Farnborough Road at the same time as the B3208 Water Lane approach improvements.

The proposed scheme to the north of the A31 interchange Shepherd and Flock roundabout, Farnham, on the B3208 Water Lane approach to the Water Lane roundabout is now being progressed.

This scheme is being delivered as part of Project 1 Medium-Term Interventions within the Farnham Infrastructure Programme. The Programme's Medium-Term interventions is a list of approximately 100 projects compiled from stakeholder feedback, including the Programme's partners Waverley Borough Council and Farnham Town Council.

To support the prioritisation of the Medium-Term Interventions, a 2-stage sifting process has been carried out on all the projects taken forward. This assessment has considered the funding requirements, environmental impact, carbon impact, potential for modal shift and impact on local businesses in Farnham of each of the projects put forward. Each of the projects taken forward as part of the Medium-Term Interventions have been assessed to ensure they conform with the Farnham Neighbourhood Plan.

Following the sifting stage, in the medium-term interventions, the B3208 Water Lane approach was prioritised as it aligned with the Farnham Optimised Infrastructure Plan objectives to enhance mobility and connectivity, prioritise health, safety and wellbeing and

Waverley Borough Councils ambitions to deliver the strategic and local community infrastructure necessary to support growth.

The Water Lane roundabout was extensively discussed with Surrey County Council, Waverley Borough Council and Farnham Town Council officers and councillors (as project partners) and again at the Waverly Borough Council CIL Board, the A325 arm was not included as a priority as there was more concern over the capacity issues on the B3208.

Due to capacity issues and lack of lane discipline on the westbound approach on the B3208, the scheme will optimise the available carriageway space within the adopted public highway, enabling two lanes to turn left at the roundabout, and the new additional lane to go around the roundabout. Currently it has uncontrolled crossings, therefore in order to provide a safer crossing for pedestrians and cyclists a toucan crossing will be installed as part of these works.

The scheme will improve air quality through less idling traffic and enhance safety for both vehicular traffic and importantly active travel modes from residential areas towards the nearby Supermarket and retail opportunities, whilst encouraging active travel and contributing to the ongoing shift to Net Zero.

The A325 Farnborough Road currently has an uncontrolled crossing point for pedestrians/cyclists to access the Badshot Lea area towards Farnham Town Centre, north of the Water Lane Roundabout. There are many more requests for new crossings and other traffic safety schemes than could be delivered. Requests are considered for different programmes of work, dependent on scope and size of the request, and are prioritised for the limited resources and budgets available.

The scheme planned for the B3208 Water Lane is being delivered using prioritised external funding as a result of a successful Community Infrastructure Levy (CIL) bid to Waverley Borough Council and a portion of S106 (developer funded) monies.

County Councillors can nominate a traffic engineering scheme for consideration and prioritisation on to a centrally funded programme for delivery each financial year (the Countywide Integrated Transport Scheme (ITS) Programme). Each nominated scheme has a Technical Assessment to assist the prioritisation process, including assessing affordability and deliverability. This is a new process and limits the value of a scheme to £350k so that more communities have an opportunity to have a scheme progress locally to them, that no community is left behind.

The County Councillor for Farnham North, Cllr Catherine Powell, nominated a scheme for the 23/24 Countywide ITS Programme: "a new Toucan or Pedestrian Crossing on the north exit of the A325 Water Lane roundabout adjacent to Farnham Mill Lane". This proposed crossing is to the north of the Water Lane Roundabout on the A325 Farnborough Road, as requested in this petition. There are two County Councillors for the A325 Farnborough Road, with a boundary between Farnham Central and Farnham North divisions dividing the two directions of dual carriageway.

The Technical Assessment showed that there could be many potential benefits to this proposed scheme, as suggested in this petition, however there could be many challenges in deliverability of a crossing that would require the temporary and costly closure (including lane rental charges) of the A325 link to the A31 Shepherd and Flock roundabout to construct the works.

The Technical Assessment is carried out before any detailed design and before the position of any underground utility company services are known. However, the whole scheme budget

envelope, the amount of funding that could be needed to carry out feasibility/design/delivery/risk/contingency etc, was estimated at approximately £600k. As the scheme is likely to cost considerably more than the upper limit for this programme of work, £350k per scheme, this scheme was not prioritised for the 23/24 Countywide ITS Programme.


Therefore it is not possible to prioritise this requested second crossing, on the A325 Farnborough Road to the north of the Water Lane roundabout, above other requests received, at this time through the 23/24 Countywide ITS Programme, however larger schemes like this one could be prioritised and progress through other programmes of work, including if prioritised for the Surrey Infrastructure Plan programme of works.

The A325 Farnborough Road is also likely to be used as the diversion for when the crossing on B3208 Water Lane is constructed. It is unlikely that these two schemes can be delivered in this financial year (as the funding for the A325 arm has not been identified or allocated) along with significant disruption to the network during construction. Additionally, it is not currently prioritised on any available programme of work.


However, one programme of work available within the Surrey Infrastructure Plan is the Local Cycle and Walking Infrastructure Plans (LCWIP). This includes developing the LCWIP for Farnham and the wider Waverley Borough. LCWIPs are 10+ year strategic plan that sets out the conceptual plans and priorities for cycling and walking infrastructure to encourage more people to choose 'active travel' by cycling and walking more regularly and use the car less often. The LCWIP for Farnham has recently been completed. The A325 route is identified within this plan (route 37) to provide improved facilities for cyclists travelling between the Six Bells roundabout and Water Lane roundabout. Work is now underway to determine the prioritisation of routes from within the Farnham LCWIP for taking forward for further development over the long-term planning timeframe. The next stage of design and development of priority routes in this local area will include public consultation as we progress towards completing scheme designs and working to secure funding to deliver the infrastructure improvements.

In the meantime, requests for vegetation cut back are being programmed and the existing informal crossing point for pedestrians and cyclists can continue to be used.
