**SUBJECT:** Proposal to change the age range and extend the premises at St Paul's CofE Infant School, Tongham

**ORGANISATION STRATEGY PRIORITY AREA:** Tackling Health Inequality, Empowering Communities, Enabling a Greener Future

#### SUMMARY OF ISSUE:

As part of a wider strategy, Surrey County Council is seeking to provide a sustainable education landscape across the county.

Surrey County Council, in collaboration with the Governing Body of St Paul's CofE Infant School, are proposing to extend the school's age range, allowing them to become a 1FE primary school with a nursery for pupils aged 2-11 years. This would allow for a roll of 210 pupils across the school with 68 children in the nursery. Further building work will be required on the site of the school to provide appropriate accommodation for the additional pupils, which will be subject to planning permission.

The rationale behind this proposal is that it provides Surrey County Council with the opportunity to reorganise primary places in an area of Tongham by providing an all-through primary school, which will benefit the local community and provide opportunities for siblings in a family to attend the same school. It would also ease the transition made by children when transferring from Key Stage 1 to Key Stage 2, as pupils will have the opportunity to remain at St Paul's CofE Infant School instead of transferring to another school for their junior education.

The proposed change of age range allows St Paul's CofE Infant School to offer junior places. The increase in junior places in the Ash and Tongham planning area will then match the total number of Reception places available. This would improve the sustainability of the school.

#### **RECOMMENDATIONS:**

#### It is recommended that:

The Cabinet Member for Education and Learning determines the statutory notices published thereby bringing into effect the formal commencement of the proposal to change the age range and extend the premises at St Paul's CofE Infant School.

- 1. reject a proposal
- 2. approve a proposal without modification

3. approve a proposal with modifications, having consulted the LA and/or GB (as appropriate)

4. approve a proposal, with or without modification – subject to certain conditions (such as the granting of planning permission) being met.

#### **REASON FOR RECOMMENDATIONS:**

The proposal supports and delivers the Local Authority's statutory obligation to provide sufficient school places to meet demand and forms part of a reorganisation of primary places in Guildford and Waverley.

Implementing the proposal will:

- Allow pupils to transition through the school from Reception year, without the need to apply elsewhere, giving them and their families the reassurance of a continuity of educational provision
- Seek to enhance pupils' experiences, enabling higher standards of education to be provided
- Enable the school to deliver the curriculum in a continuous and coherent way, putting them in a stronger position to plan for both continuity and progression in learning
- Provide the opportunity to build partnerships with pupils, parents and families over a longer period of time
- Enable siblings to remain together during their primary education, rather than parents having to travel to two different schools
- Create a sustainable school to serve the local community

The Cabinet Member for Children, Families and Lifelong Learning's approvals and recommendations completes the statutory process in accordance with the DfE guidance "Making significant changes ('Prescribed Alterations') to Maintained Schools."

#### DETAILS:

- St Paul's CofE Infant School, Tongham is a voluntary controlled school and is situated in Tongham, within the borough of Guildford. At present, St Paul's CofE Infant School is a one-form entry (1FE) infant school for pupils aged 4-7 years, with a published admission number (PAN) of 30 and provides permanent accommodation for up to 90 pupils. The school is rated as "Good" by Ofsted in its last full inspection in September 2023.
- 2. Children currently leave St Paul's CofE Infant School at the end of Year 2 and parents make separate admission applications for Year 3 places. The admissions criteria for Walsh CofE Junior and Waverley Abbey Junior Schools currently list St Paul's CofE Infant as a feeder school. If this proposal goes ahead, these schools as academies, could make the decision to reduce their PAN.
- 3. The rationale behind this proposal is that it provides Surrey County Council with the opportunity to reorganise primary places in an area of Ash and Tongham by providing an all-through primary school, which will benefit the local community and provide opportunities for siblings in a family to attend the same school. It would also ease the transition made by children when transferring from Key Stage 1 to Key Stage 2, as pupils will have the opportunity to remain

at St Paul's CofE Infant School instead of transferring to another school for their junior education.

- 4. Historically, St Paul's Infant School is currently a formal feeder school for Walsh CofE Junior and Waverley Abbey Junior Schools. However, Walsh CofE Junior only offers 4 places and Waverley Abbey is over four miles away from St Paul's CofE Infant and therefore some distance from the homes of pupils, who tend to live near the infant school. St Paul's CofE Infant currently subsidise a school bus to take previous pupils to Waverley Abbey Junior and this results in circa £38,000 being pulled from the school budget each year.
- 5. For the purposes of education place planning, Surrey County Council produce pupil projections based on planning areas. Planning areas do not have geographical boundaries but are groups of schools which reflect the local geography, reasonable travel distances and existing pupil movement patterns.
- 6. **Table 2** below outlines the primary projections for the Ash and Tongham planning area. Housing permissions and trajectories received from boroughs and districts are combined with birth data and pupil movement trends to create projections.

- 7. The forecasts for Ash and Tongham do not demonstrate a need for additional Key Stage 2 places because the current trend is for pupils of St Paul's CofE Infant to be educated out of the planning area for Year 3, as there are no current places available.
- 8. **Table 3** outlines the residential primary projections for the Ash and Tongham wards including Ash South and Tongham, Ash Vale and Ash Wharf. As well as housing, birth and migration data, these forecasts show the number of pupils residing within the wards. The forecasts indicate a deficit of places compared to current PANs of up to over two forms of entry.

9. Should the proposal to expand the age range and premises of St Paul's CofE Infant School, Tongham be agreed, the deficits shown in Table 4 will change with the increase of the junior intake in the Ash and Tongham planning area.

- 10. Subject to the decision on this proposal and planning permission, building work will be required to the existing site at St Paul's CofE Infant School, Tongham to make it suitable for an additional 120 permanent pupils. This will involve adaptations and refurbishment to the interior of the existing accommodation and a new classroom block and school hall to increase classroom and resource space.
- 11. The proposal will enable St Paul's CofE Infant School to start providing Key Stage 2 places from September 2025. The Year 2 class for 2024/25 would transfer into the newly established Year 3 class in September 2025/26, and Key Stage 2 will increase incrementally each year as each new Reception cohort is admitted. St Paul's CofE Infant School would be operating as a full 1FE primary school from September 2028/29 onwards.

#### **CONSULTATION:**

- An informal consultation was published from 18 September to 5 November 2023 and further Statutory Notices were published from 24 November and concluded on 15 January 2024. All consultation documents are available at <u>www.surreysays.co.uk</u>. The full Statutory Notices are also attached as Annex 1 of this report.
- 13. During the Informal Consultation period, there were 246 responses to the consultation:
  - 91% of respondents agreed with the proposal
  - 6% of respondents disagreed with the proposal
  - 3% of respondents stated they didn't know
- 14. During the Statutory Notice period, there were 54 responses to the consultation:
  - 92% of respondents agreed with the proposal
  - 4% of respondents disagreed with the proposal
  - 4% of respondents said they didn't know
- 15. Of those agreeing with the proposal, the majority of respondents were parents/carers of pupils currently attending the school.

- 16. The main positive themes raised throughout both the informal consultation and statutory notices were that local residents felt that the school was a community asset, the expansion would meet demand for primary school places and that the expansion of the school from infant to primary will allow the continuation of primary education.
- 17. Negative themes included the impacts on primary places within other local schools, the disruption caused by building works and the impact on parking and traffic surrounding the school.
- 18. The full consultation analysis is attached as **Annex 2**.

#### **RISK MANAGEMENT AND IMPLICATIONS:**

- 19. There are design, planning and building risks associated with the project and a project risk register has been compiled, which is regularly updated. A contingency allowance appropriate to the scheme has been included within the project budget to mitigate for potential identified risks.
- 20. The Local Authority needs to be satisfied that the appropriate fair and open local consultation and or representation has been conducted and that the proposer has given full consideration to all responses received. To ensure that this is the case the consultation and decision-making processes are quality assured.

#### Financial and value for money implications:

- 21. The project will be funded from Surrey County Council's Basic Need Capital Programme (SBN) and the budget for this scheme is included in the approved Medium-Term Financial Strategy (MTFS).
- 22. The project will be subject to robust cost challenge and scrutiny to drive optimum value for money.
- 23. In situations where one school reduces its PAN and another increases its age range there tends to be a period of double funding. This occurs as funding is based on pupils on roll in the previous October. In order to reflect the increase in pupils the expanding school will be funded in the year of expansion for the consequential increase in pupils. Conversely, to avoid a sudden drop in funding, the school with reducing PAN remains funded at the numbers on roll at the previous October unless there is a specific ruling from the Department for Education (DfE) to do otherwise. Experience has indicated DfE are unlikely to support such a proposal.
- 24. As a result, the cost of that double funding will need to be met from the Dedicated Schools Grant growth fund within the schools block. Based on this scenario an estimate of £40k double funding will occur. This has no direct impact on the Council's General Fund.

#### Section 151 Officer commentary:

25. Significant progress has been made in recent years to improve the Council's financial resilience and the financial management capabilities across the

organisation. Whilst this has built a stronger financial base from which to deliver our services, the increased cost of living, global financial uncertainty, high inflation and government policy changes mean we continue to face challenges to our financial position. This requires an increased focus on financial management to protect service delivery, a continuation of the need to be forward looking in the medium term, as well as the delivery of the efficiencies to achieve a balanced budget position each year.

- 26. In addition to these immediate challenges, the medium-term financial outlook beyond 2023/24 remains uncertain. With no clarity on central government funding in the medium term, our working assumption is that financial resources will continue to be constrained, as they have been for the majority of the past decade. This places an onus on the Council to continue to consider issues of financial sustainability as a priority, in order to ensure the stable provision of services in the medium term.
- 27. Appropriate capacity within the Surrey maintained estate is a key element of ensuring sufficiency of school places in the right areas of the County. The Section 151 Officer therefore supports the proposal.

#### Legal implications – Monitoring Officer:

- 28. Section 13 of the Education Act 1996 places a general duty on the Council to secure that efficient primary and secondary education is available to meet the needs the population in its area. In doing so, the Council is required to contribute to the spiritual, moral, mental and physical development of the community.
- 29. Section 14 of the Education Act 1996 places a duty on the Council to secure that sufficient schools for providing primary and secondary education are available in its area.
- 30. The local authority has published statutory notices for increasing the capacity of St Paul's CofE Infant School, thereby bringing into effect the formal commencement of the proposal prior to the consultation stage in accordance with statutory requirements.
- 31. The Governing Body of St Paul's CofE Infant School have published statutory notices for expanding the age range of the school, thereby bringing into effect the formal commencement of the proposal prior to the consultation stage in accordance with statutory requirements.
- 32. In considering this Report, the Cabinet Lead Member for Education and Learning must give due regard to the results of the informal consultation as set out in the report and the response of the Service to the consultation comments and conscientiously take these matters into account when making a final decision.

#### Equalities and diversity:

33. The Equality Impact Assessment (EIA) for the proposal is attached to this report as **Annex 3**.

#### **Corporate Parenting/Looked After Children implications:**

35. This proposal would provide increased primary provision from Key Stage 2 in Ash and Tongham, which would be of benefit to the community served by the school, thereby ensuring that those who are Looked After Children can attend a school closer to home and be more connected to local communities and support services.

#### Safeguarding responsibilities for vulnerable children and adults' implications:

36. Safeguarding vulnerable children is a high priority in all Surrey schools. Schools have considerable expertise in safeguarding vulnerable children and adhere to robust procedures. The schools will continue to apply good practice around safeguarding as they do currently. In addition, safeguarding is a key area for monitoring when Ofsted conducts inspections.

#### **Environmental sustainability implications:**

- 37. The provision of Key Stage 2 places closer to home will reduce the average journey times for children and their families.
- 38. The design philosophy is to create buildings that will support low energy consumption, reduce solar gain and promote natural ventilation. Any new infrastructure will be built to the local planning authority's adopted core planning strategy.

#### WHAT HAPPENS NEXT:

- 39. Subject to the Cabinet Member determining the statutory notice, Surrey County Council and the Governing Body of St Paul's CofE Infant School, Tongham will proceed to implement the proposal. The school nursery provision will open 15th April 2024.
- 40. Subject to the Cabinet Member determining the statutory notice, Surrey County Council and the Governing Body of St Paul's CofE Infant School, Tongham will proceed to implement the proposal. The significant change to

change the age range from infant to primary will be implemented from 1 Sept 2025.

# Introduction

This paper outlines a proposal by the Governing Body of St Paul's CofE Infant School, to change the age range of St Paul's CofE Infant School from a one-form entry infant school to a one-form entry primary school with a nursery provision. The school premises would be extended to accommodate the additional junior aged children. The statutory process and timescales for the expansion are detailed below.

# Proposal

The Governing Body of St Paul's CofE Infant School are proposing to change the age range to accommodate ages 2-11 years, becoming a 1FE primary school with a nursery provision. This would allow for a roll of 210 pupils across the school and up to 68 children within the nursery.

The proposed change of age range would come into effect from September 2025 onwards.

# Background

- 5. St Paul's CofE Infant School is a voluntary controlled school. The school is situated in Tongham, within the borough of Guildford.
- At present, St Paul's CofE Infant School is a one-form entry infant school for pupils aged 4-7 years, with a published admission number (PAN) of 30 and provides permanent accommodation for up to 90 pupils. The school is rated as "Good" by Ofsted in its last full inspection in May 2018.
- Children currently leave St Paul's CofE Infant School at the end of Year 2 and parents make separate admission applications for Year 3 places. The admissions criteria for Waverley Abbey and Walsh CofE Junior Schools both currently list St Paul's CofE Infant School as a feeder school.
- 8. Pupils leaving St Paul's CofE Infant School are also able to seek Year 3 places at other junior schools or primary schools without a separate Year 3 intake, which can be offered subject to vacant places being available.
- St Paul's CofE Infant School currently subsidise a minibus to transport former pupils to and from Waverley Abbey CofE Junior School, due to it being 4.5 miles from the infant school site. This service is currently available for 4 years, the duration of the pupil's time at Waverley Abbey CofE Junior School.

# Rationale

- 10. This proposal provides Surrey County Council with the opportunity to re-organise primary places in an area of Ash and Tongham, by providing an all-through primary school which would benefit the local community and provide opportunities for siblings in a family to attend the same school. It would also ease the transition made by children when transferring from Key Stage 1 to Key Stage 2, as pupils would have the opportunity to remain at St Paul's CofE Infant School instead of transferring to another school for their junior education.
  - 11. Typically, pupils leaving St Paul's CofE Infant School have attended Waverley Abbey or Walsh CofE Junior schools.
  - 12. Waverley Abbey Junior School is over four miles away from St Paul's CofE Infant School and therefore some distance from the homes of pupils attending St Paul's, who tend to live near the infant school. St Paul's CofE Infant School currently subsidise minibuses to help local families travel to Waverley Abbey Junior School so that parents can have one drop off. Waverley Abbey Junior School also has four other feeder schools which rank above pupils on roll at St Paul's CofE Infant School. The total PAN of the four feeder schools is 120 which matches the Published Admissions Number (PAN) of Waverley Abbey Junior School.
  - 13. Walsh CofE Junior School's main feeder school is Walsh Memorial Infant School which has 60 places. Walsh CofE Junior School only has a PAN of 64 places resulting in only 4 potential places for pupils on roll at other schools, including St Paul's CofE Infant School.
  - 14. The proposed change of age range would allow St Paul's CofE Infant School to offer junior places. The increase in junior places in the Ash and Tongham planning area would equalise the total number of Reception places available. There are currently 240 Reception places in the planning area and the expansion at St Paul's CofE Infant School would mean that there would be a total of 248 Year 3 places. This would improve the sustainability of the school and allow pupils to attend schools nearer to where they live.



- 22. Should the proposal to change the age range of St Paul's CofE Infant School, Tongham be agreed, the deficits shown in **Table 4** would change with the increase of the junior intake in the Ash and Tongham planning area.
- 23. The proposal would enable St Paul's CofE Infant School to start providing Key Stage 2 places from September 2025. Implementing the proposals at St Paul's CofE Infant School would:

- Allow pupils to transition through the school from Reception year, without the need to apply elsewhere giving them and their families the reassurance of a continuity of educational provision.
- Seek to enhance pupils' experiences, enabling higher standards of education to be provided.
- Enable the school to deliver the curriculum in a continuous and coherent way, putting them in a stronger position to plan for both continuity and progression in learning.
- Provide the opportunity to build partnerships with pupils, parents, and families over a longer period of time.
- Enable siblings to remain together during their primary education, rather than parents having to travel to two different schools or nursery settings.
- Create a sustainable school to serve the local community.
- Enable the school to provide a joined-up approach for all children from 2 to 11 years old.
- Allow systems and processes to be streamlined, enabling the school to deploy resources across the nursery and school.

#### **Nursery provision**

- 24. By lowering the school age, the children attending the nursery would become pupils of the school, which supports more efficient governance and operational functions. This would continue to support the government's policy on providing 15 and 30 hours Funded Early Education for 2, 3 and 4 year olds in schools.
- 25. Currently there is one other school-based provision is this area. Locally, the most popular models of early years education include full day care and extended day pre-school provision. All providers report healthy occupancy and have limited spaces or are operating waiting lists, suggesting that there may be a continued demand for early years places.
- 26. The available data on 2 year old funding, which supports our most vulnerable children, suggests that there are many families in the surrounding Wards who are entitled to the funding but are not taking up a place. This may indicate demand for additional 2 year old places in Tongham and surrounding areas.
- 27. The school intends to offer school-based provision on a term time only basis, and this will be led by a qualified teacher. Therefore, offering a different model to most providers in the local area. The school propose that their funded early education offer for 2, 3 and 4 year olds, would complement the offer they have for children in Reception and provide a joined-up approach to early years education in the school.

# Will the proposal to lower the age range have any impact on the school's admission arrangements?

- 28. There are no planned changes to the Published Admission Number (PAN) of 30 at the school. Should the school extend their age range to become a primary school, it would remain at one-form of entry. Nor is it intended to change the admission criteria for the school as a result of this proposal.
- 29. It is proposed that the nursery would initially offer a maximum of 60 places for 2, 3 and 4 year olds (although this may change depending on the needs of the community and the number of families entitled to 30 funded hours).
- 30. Applications for the nursery would be made directly to the school with places to be allocated in line with a timescale and process to be agreed. As a voluntary controlled school, the nursery admissions policy would continue to be determined by the Local Authority, but no changes are intended as part of this proposal.
- 31. It should be noted that there is no automatic right for children attending the nursery to gain a Reception place at the school. The admissions criteria for community and voluntary controlled schools, along with other individual schools admissions criteria, in Surrey are published each year in the <u>schools admissions booklets</u>. Parents of children applying for a Reception place would need to apply in the normal way for admission to the school whether their child attends the nursery provision or not.

# **School Building Requirements**

- 32. A programme of building works at the school would be required to accommodate the additional pupils at Key Stage 2. The proposed works will improve the general fabric of the school buildings and enhance the learning experience for pupils, parents, and staff. Subject to the outcome of this consultation, further work will be required to the existing site to make it suitable for the additional 120 pupils. This would involve the creation of four new classrooms, a new school hall and ancillary space. Any works would be subject to the requirements for planning permission and building control. This would include a separate public consultation on the building proposals.
- 33. The school has sufficient playing field space to meet the curriculum for Key Stage 2 pupils.
- 34. No external building works would be required to accommodate the proposed nursery. Internal redecoration, refurbishment, and resourcing the environment would be completed prior to opening.
- 35. The programme of building works would be funded utilising basic need funding as well as S106 contributions from local housing developments to the school site.

# Consultations, approvals, and overall timescales

- 36. It is proposed that the nursery provision open from 15 April 2024 (at the start of the summer term).
- 37. It is proposed that the change of age range to allow Key Stage 2 provision and extension of premises to accommodate this commences from 1 September 2025.

- 38. The proposed changes require a period of consultation, the publication of Statutory Notices and the agreement of Surrey County Council's Cabinet Member for Education and Learning if the proposal is to proceed.
- 39. The first stage of consultation was open from 18 September 2023 to 5 November 2023. During this period Surrey County Council shared proposals with the wider professional network, schools (including headteachers and chairs of governors), unions, parent representatives, partner agencies and with the staff and parents of the school subject to the proposals. The associated documentation was published on Surrey County Council's 'Surrey Says' website and circulated to local stakeholders. Interested parties were invited to return responses to the consultation via an online form or alternatively email or post responses.

### Key points from the consultation responses:





# **Consultation Analysis (Informal and Statutory Notice period)** Proposed change of age range and extension of premises at St Paul's CofE Infant School, Tongham

### Introduction

This report is an analysis of responses gathered on the proposal to change the age range of St Paul's CofE Infant School from a one-form entry infant school to a one-form entry primary school and expand their premises to accommodate the additional children.

Surrey County Council published an informal consultation from 18 September 2023 to 5 November 2023.

Part 1 of this paper is an analysis of the responses received during the informal consultation notice period and Part 2 is an analysis of the responses during the Statutory Notice period. The summary and key points give a summary of the findings from both consultations. This paper will be submitted to the Lead Cabinet Member for Education and Learning for consideration to determine the statutory notices on insert date here.

The aim of the consultation was to seek views on the proposal from all interested parties, particularly from pupils and their families who attend St Paul's CofE Infant School, pupils and their families who may attend the school in the future, local schools and the local community.

The informal consultation was open from 18 September 2023 to 5 November 2023. The associated documentation was published on the Surrey County Council 'Surrey Says' website and circulated to local stakeholders. Interested parties were invited to return responses to the consultation via an online form or alternatively email or post responses.

A public meeting was held at the school on 4 October 2023.

The Statutory Notices were published from 24 November 2023 to 15 January 2024. The associated documentation was published on the Surrey County Council 'Surrey Says' website and circulated to local stakeholders. The notices were also published in the Farnham Herald on 23 November 2023, and the Surrey Advertiser on 24 November 2023. Interested parties were invited to return responses to the consultation via an online form or alternatively email or post responses.

An Equality Impact Assessment was completed throughout the informal consultation and statutory notice period. Responses to the consultations contribute to the Equality Impact Assessment which can be viewed with the papers for the Cabinet Member for Education and Learning Meeting on insert date here. Key points from the consultation responses:


- There was a significant margin of agreement with the proposal: 91% agreed, 6% disagreed
- 33% of all responses were from parents/carers of pupils currently attending the school
- Members of staff at St Paul's CofE Infant School all agreed with the proposal (5% of total respondents)
- Of those who disagreed with the proposal, 36% were residents living close/adjacent to the school, another 36% indicated they had an alternative link to the school. 14% were parents/carers of pupils currently attending the school

# Part 1 – Informal Consultation

# **Quantitative Analysis**

In total, there were 246 responses to the consultation. 91% of respondents agreed with the proposal, 6% of respondents disagreed with the proposal and 3% of respondents stated they didn't know.

All 246 respondents indicated their relationship with the school. The chart below shows the distribution of respondents to the consultation.

### **Qualitative Analysis**

Respondents had the opportunity to add comments at the end of the survey. Out of the 246 responses received, 132 comments were made on the proposal. These comments were broadly themed and then separated into 17 possible tags. Comments left in reply to free-text questions were tagged drawing on 17 possible tags. Each response could have more than one tag attached. The overall frequency of each of the tags provides an indicator of respondent's main concerns regarding the proposal.

### Key themes from the consultation

### **Positive impacts**

Respondents identified several positive impacts for both the expansion and lowering of age range. Many felt the proposal would "support the need in the community", describing it as an "amazing idea" and "great opportunity".

### **Continuation of Primary Education**

33% of the comments identified benefits with the continuation of Primary education, with the school being described as a "nurturing environment" and providing "exemplary care". One respondent felt the children "would really benefit from spending further years there", another stated, "There are many struggles moving on from St Paul's". It was also felt that the children would benefit from "continuing care from a staff that know and value them and their needs and strengths".

"Instead of having to go to Waverley Abbey or other Junior schools in the area (and therefore having to travel) they can continue to attend their local school with a natural progression to Ash Manor."

"The continuity of providing a whole primary education at St. Paul's would be extremely beneficial for the pupils"

"To attend one school until the age of 11 will be absolutely amazing"

#### Less travel and environmental factors

20% of responses observed that the proposal would have a positive impact on travel and environment in the local area, the potential of being able to walk to the school a recurring theme. One respondent stated, "the distances meant we could not walk to Waverley Abbey, so had to pay for the school bus which was hard to fund at times", and another felt transporting children to a further away Junior school was "ecologically unsound" and that the current situation "deprives them of meeting up with their friends outside of school". Another expressed their view that the expansion would decrease the amount of traffic utilising the roads each morning, "it has got to be good for transport issues locally" and stated that at this time the roads through Tongham are "atrocious".

"Less traffic - better for the environment, better for everyone!"

"Currently I can walk to collect, but I would not have this luxury when my child goes to a junior school as none are in walking distance" "able to walk to school; Keeping our carbon footprint down and keeping the local air cleaner for all who live here"

"It would be nice to able to walk to school"

#### Meeting demand for Primary places

44% of the comments mentioned a perceived current lack of Primary provision in the area, and that this matter could be alleviated by increasing the age range at St Paul's CofE Infant School. Many felt that the need in the area was becoming "desperate", and that with new houses being built and limited local Junior provision, an expansion is a "no-brainer". Commenting on the existing provision, one respondent stated, "There is no local junior school in Tongham and our eldest son has found the need to change school difficult", they also mentioned a lack of "natural continuation in the curriculum".

"Given the increase of families who have come to Ash and Tongham over the last 4 years due to the new developments, the need for another junior or primary school is needed now!"

"It is what the area is in desperate need of given more homes being built and an already lack of spaces in current schools"

"the present offering does not adequately provide for the number of children/demand as it stands"

"The expansion of the school will support the need in the community and allow a good and consistent education for local children"

#### Meeting need for EYS places

Similarly, 27% of comments reflected a feeling of necessity for early years places in the area, and that the reinstatement of a Nursery setting next to the school would be "amazing". The recent closure of provision has made it "harder to find nursery places" and some respondents felt there is now "a massive gap for nursery/early years care".

#### School Sustainability

4% of comments indicated that the proposal would have a positive impact on the school's sustainability, mentioning it "makes financial sense" and would "allow for a streamlining of resources and processes right across the school".

#### **Community Asset**

20% of responses described the school positively, with many using the word "asset". One respondent believes the proposal could "make a real difference to the lives of the children in the community", and another praised the school's "community focus".

"This would be an asset to the area whereby the present offering does not adequately provide for the number of children/demand as it stands"

"This would be a great asset to the local community, and all for much needed school places within the local area"

### **Negative Impacts**

Many respondents identified potentially negative impacts of the proposals, some expressed "concerns", while others stated there was "no requirement" and the proposal "shouldn't be getting the light of day".

### Size of school site

2% of the comments were in relation to the size of the school site, with the feeling that this factor, along with St Paul's CofE Infant School being one-form entry, would leave children underprepared for Secondary school. One respondent felt "a one form primary school seems quite small to be getting children ready for secondary school", and another felt that one-form might be too limited, allowing for "no movement to move children around into another class, or make further friendship groups".

"Concerns for children going from a one form primary school on to a large secondary"

### Demand in other areas for Primary places

5% of comments indicated that the proposal would have a negative impact on other local Primary provision. Words such as "adversely", "decimate" and "suffer" were used in relation to the budgets and numbers on roll of alternative schools nearby. One respondent stated "there are sufficient KS2 places locally, hence, no requirement for further places" and another that "there are many schools in the area that have spaces".

"There are a surplus of Key Stage 2 places in the area"

"There is evidence that there are too many school places available across Surrey and neighbouring counties, negating any need to expand a school permanently"

"There are sufficient KS2 places locally, hence, no requirement for further places"

### Disruption of building works and school noise

2% of comments demonstrated a concern regarding the potential impacts and disruption of building works, along with the general noise generated from a Primary School and Nursery. One respondent stated they wanted to know the "impact on the area of the building works" and another mentioned "continual noise" during drop off and pick up times, especially early in the morning due to the previous Nursery.

### Impact on other EYS provision

2% of comments identified potential negative repercussions for alternative early years provision in the local area. One respondent stated they "worry about the impact this will have on small private nurseries", while another felt the proposal would "have a negative effect on other local schools and nurseries pupil numbers".

"There are many preschool/nursery offers locally to meet need"

### Parking and traffic

17% of comments related to concerns surrounding parking and traffic in the area, some expressing frustration at the current situation and therefore feeling this would only be exacerbated by the proposal. One respondent felt that there "needs to be incentives for parents not driving and a better road plan i.e., zebra crossing" while another similarly suggested "parking for the school will need a lot of serious consideration". Several comments mentioned existing struggles with the Infant school, and that "residents have been verbally abused" whilst "many residents have complained to the school and the council and the police".

"traffic in and around the school can be tricky in the morning"

"The infrastructure of where the school is placed within a housing estate will not be able to deal with the traffic and parking"

"at times it can be unsafe for pedestrians due to the volume of cars"

### **Split Families**

3% of comments were concerned about the impact on families

#### Why not for 2024?

4% of comments felt that the proposal should be expedited for those children currently in the school's Year 2. One respondent felt "it would be better to bring forward the proposal" and another that "it would be ideal for there to be a Y3 available in 2024". One respondent stated their concern that the transition to a Junior school "may be confusing and distressing for the children".

"would love it to happen sooner"

### Ideas and innovation

Some comments offered suggestions for how the proposal could allow for the continuation of the current Year 2 children. This would involve the usage of the current Nursery site, and that "instead of filling this up with 2 nursery classes (2-3 and 3-4) start with only one nursery class at 3-4 for one year and use the other space to accommodate a Y3 classroom for the current Y2 class". Another suggestion was that the school "obtain a temporary classroom, such as a portacabin" to educate one class while the building works took place in the interim. There was also a suggestion regarding the parking situation, and that a "drop off system" could be implemented, specifically for "years 3-6 or 2-6 as they will usually have settled into the school by this time so could keep the traffic flowing".

### **Queries & Other Comments**

Some comments raised questions regarding the continuation of the existing school bus service transporting former pupils from St Paul's CofE Infant School to Waverley Abbey CofE Junior School. There were concerns from some respondents about potentially detrimental impacts on families whose elder children attended an alternative Primary school having been able to continue at St Paul's, whilst a younger child continued at the school. Other questions arose surrounding the continuation of the children's education into Secondary school, while others showed concern towards matters of staff recruitment and retention.

"Would the bus service continue to run to Waverley Abbey for the previous St Paul's students? This assists us greatly and it would be important to us that it does continue."

"Some parents will have older children at Waverley abbey and will want them to follow."

"the option of him staying on means he can't go there where his brother is, and I'm in a position of him then being parted from all his close friends if I chose to leave St Paul's and go with Waverley abbey"

"Nothing has been said (that I've read) about which secondary schools a St Paul's primary school would feed into"

"Currently this is clear and established for Waverley Abbey, so I'm curious as to which secondary schools our children would likely get places at if they attend St Paul's until year 6"

"current strain schools are under with recruitment and meeting needs of students - what is the plan to recruit and retain the necessary extra staff over these next few years?"

### **Public Meetings**

A public consultation drop-in session took place at St Paul's CofE Infant School on 4 October 2023. Roughly 50-60 people were in attendance, and themes arising from the public meeting reflected the themes from the responses to the consultation.



### Part 2 – Statutory Notices

### **Quantitative Analysis**

There were 54 responses to the consultation. Concerning the proposal to expand the age range at St Paul's CofE Infant School, 92% (50) of respondents agreed with the proposal, 4% (2) of respondents disagreed with the proposal and 4% (2) of respondents stated they didn't know. Meanwhile, concerning the proposal to lower the age range at St Paul's CofE Infant School to accommodate an on-site nursery from April 2024, 96% (52) of respondents agreed with the proposal and 4% (2) stated they didn't know.

All 54 respondents indicated their relationship with the school. The chart below shows the distribution of respondents to the consultation. The highest percentage of respondents (65%) indicated they are a parent/carer of a child attending St Paul's CofE Infant School.

### Key themes from the consultation

### **Positive impacts**

Respondents identified several positive impacts for both the expansion and lowering of age range, with one describing it as a "fantastic opportunity". Other responses stated the proposal was "essential" and felt it has "great potential" which would benefit "the children within the community as well as the parents".

### **Community Asset**

59% of the comments highlighted the positive impact this proposal could have on the community, citing the "excellent work" already being undertaken by the school, and that the school is "ideally located" to help meet an increasing need within the area. One respondent praised the Headteacher and staff, specifically their "exceptional record" and "clear vision for the future". Other respondents saw positive impacts for the community as a whole, one stated "we desperately need our children to get the education and services they need in their own community" and another felt that were the proposal to go ahead it would be "a really positive expansion for the village".

"extension of provision is much needed in the Tongham community"

"a big part of Tongham community and the extension plans will add so much more"

"a lovely little school"

### **Continuation of Primary Education**

56% of the comments felt the proposal would be beneficial for the children, with several comments using the word "settled" and stressing the importance of this in their children's education. One response highlighted the importance of preexisting relationships the children "already built with the members of staff", another stated there would be "huge benefit" and "continuity of care and education from age 2-11".

"will enhance the learning experience of local children"

"good quality education for local children"

### Less Travel

15% of the comments stated their belief that the proposal would have a positive impact on the area by reducing travel times. One respondent mentioned the difficulties they experience as a "working parent with 2 children" and the "next available school being a 10/15 minute drive". Similarly, one respondent stated the need to only travel to one school "would cut down on car use".

### Meeting demand for Primary places

44% of the comments emphasized a "need" within the community for further Primary school places, with one feeling the area "desperately" needs the expansion. Another respondent concurred, stating "Tongham village has expanded its occupancy and now needs to expand its infrastructure". Other comments described "great pressure" on existing school provision to meet increased demand, and "no other provision in the village" meant an expansion is "most definitely needed".

"much needed educational provision in the community and for the surrounding area"

"has been missing from the village for a long time"

### Meeting demand for EYS places

11% of comments identified a "need" for increased Early Years provision in the area, with one stating their belief that a lowering of age range would be a "welcome addition", and that it is "very much needed".

### **School Sustainability**

19% of comments felt the proposal would be positive for the school as a whole, with one stating it "secures the future of the school". Another felt the proposal is "the best thing to happen for this school", with others describing both a lowering and expansion of age range to be "excellent for the school".

#### **Negative impacts**

Some responses mentioned negative impacts and a belief that there is "no need" for an expansion of age range, one respondent argued it could set a precedent for "other infant schools to use the same argument" and that many have a Junior school located 4+ miles away. The main concerns surrounding the proposal stemmed from a worry of the impact it could have on alternative local provision, along with the resultant disruption of building work and further challenges arising from increased traffic and parking.

### Demand in other areas for Primary places

11% of comments felt the proposal would impact negatively on schools in the surrounding area. One stated the proposal, if agreed, would cause "pressure on other schools", and ultimately a "reduction in funding". Similarly, another respondent felt that an expansion would "have a detrimental impact on other local schools and bring further challenges around sustainability". They stated an existing "surplus" that is projected to continue moving forward, while another respondent requested that the local authority "carefully consider the implications on these schools who may be impacted by these proposals".

"I cannot support the move into Key Stage 2"

"extra provision here is not required"

### Disruption of building works and school noise/Traffic and parking

15% of comments indicated a concern in the local area regarding the disruption the proposal may cause, in terms of the building works generated on-site and increased daily traffic and parking issues resultant of both the lowering and expansion of age range. One respondent specifically stated their concerns about both "disruption of the building work and the provision of parking", while another requested the local authority ensure there is "sufficient parking" and due thought is given to "how drop off and pick up at the expanded school will work", suggesting "a drop off zone for older children", to attempt to lessen traffic around the school. Another respondent voiced an existing frustration at what they deem "inconsiderate" and "illegal" parking, therefore a need for "much clearer restrictions".

### **Recommendations: what happens next?**

The recommendations are that following the publication of this analysis document on <u>Surrey Says</u>, a final question and answer document will be published addressing the questions and comments that have been submitted during the statutory notice period. Both documents will be published on Surrey Says and can be accessed <u>Proposed change of age range and extension of premises at St Paul's CofE Infant School, Tongham - Surrey County Council - Citizen Space (surreysays.co.uk).</u>

Since the publication of the consultation analysis, a letter has been received from Andrew Steer, Head at William Cobbett Primary School. He has raised that he feels the expansion of age range for St Paul's to become a primary school is not necessary and it will be of detriment to other local schools. The correspondence advised that the outcome of the consultation was pre-determined as an initial meeting relating to the planning application took place in November 2023. Surrey County Council have responded to the concerns raised.

Following this, the proposal will continue to the next phase for a final decision taken by the Cabinet Member for Education and Learning at the decision meeting on 27 February 2024. 3

In agreement with the school's Headteacher and Governing Body, Surrey County Council is proposing that St Paul's CofE Infant School change the age range to accommodate ages 4-11 years, becoming a 1FE primary school with an attached nursery provision. This would allow for a roll of 210 pupils across the school. It is also proposed that the school lower their age range to accommodate a 60-place nursery provision, with the potential to rise to 68 dependent on the needs of the community.

- Pupils currently attending St Paul's CofE Infant School
- Staff at St Paul's CofE Infant School
- Parents and families of pupils currently attending St Paul's CofE Infant School or likely to attend the school in the future.




There are 87 pupils currently on roll at St Paul's CofE Infant School, with around 10.3% of pupils having an EHCP or undergoing assessment for an EHCP.

Graph 1 shows the predictions for the Borough of Guildford, it is anticipated that the number of children with an EHCP requiring a mainstream place will increase by 10% from 2021-22's latest figures (257) to a peak in 2024-25 (282), after which it will decrease and plateau from 2028-29 onwards.

## Graph 2: Forecast of demand for mainstream places from Year R to Year 6 for pupils with an EHCP in Waverley



Graph 2 shows the predictions for the Borough of Waverley, having previously peaked in 2020-21 (254) it is anticipated that the number of children with an EHCP requiring a mainstream place will continue to decline until reaching its lowest ebb in 2031-32 (181) at the end of the planning period; representing a decrease of 29%.

### Positive Impacts:

 The change of age range will positively impact pupils who have an EHCP and those students with additional learning needs as they will experience continuity in their education. Remaining in the same setting at the Key Stage Transfer mid-way through their primary education, will provide these pupils with consistency and stability that will assist with the identification and support of their needs.

 A school place that is closer to home will positively impact students, parents and carers who will have the opportunity to be part of a school community closer to home as well as reducing potential travel time for students and their families.

### Age including younger and older people

This proposal provides Surrey County Council with the opportunity to re-organise primary places in Ash & Tongham by providing an all-through primary school which will benefit the local community and provide opportunities for siblings in a family to attend the same school. It would also ease the transition made by children when transferring from Key Stage 1 to Key Stage 2, as pupils will have the opportunity to remain at St Paul's CofE Infant School instead of transferring to another school for their junior education.

Children currently leave St Paul's CofE Infant School at the end of Year 2 and parents make separate admission applications for Year 3 places. The admissions criteria for Waverley Abbey and Walsh CofE Junior Schools both currently list St Paul's as a feeder school. **Parents** are also able to seek Year 3 places at primary schools without a separate Year 3 intake, which can be offered subject to vacant places being available.

St Paul's CofE Infant School currently subsidise a minibus to transport former pupils to and from Waverley Abbey CofE Junior School, due to it being 4.5 miles from the infant school site. This service is currently available for 4 years, the duration of the pupil's time at Waverley Abbey CofE Junior School.

The proposed change of age range would allow St Paul's CofE Infant School to offer junior places. The increase in junior places in the Ash and Tongham planning area would equalise the total number of Reception places available; 240 Reception places against 248 Year 3 places. This would improve the sustainability of the school and allow pupils to attend schools nearer to where they live without negatively impacting pupil numbers at other primary schools across Ash, Tongham and Guildford as a whole.



### Map of Guildford



### <sup>3</sup> Proposal:

It is proposed that St Paul's CofE Infant School's age range is changed to accommodate ages 4-11, becoming a 1FE primary school. This would allow for a roll of 210 pupils across the school.

There is also a separate proposal that the school lowers their age range to accommodate a nursery on site (ages 2 to 4) from 15 April 2024 (start of the summer term). As such, the following document will separately cover both proposals.

Further building work will be required on the site of the school to provide appropriate accommodation for the additional pupils.

If the proposal to expand St Paul's to 210 places is successful, the admissions authorities of Waverley Abbey Junior School and Walsh CofE Junior School may opt to submit an in year variation request to the Office of the Schools Adjudicator to vary the admission arrangements for 2025, to remove St Paul's as a named feeder school.
