Overview of Adults Safeguarding Board

- Not yet statutory
- 42 Agencies represented
- Board has sub committees for working groups
 - Business Management Group
 - Serious Case Review Group
 - Quality and Audit
 - Policy & Procedures
 - Training
 - Delivers locally via four regional local safeguarding adult groups



Highlights of Year to March 2013

Built stronger awareness with professionals and public

Improved training and started developing multi agency competency framework (roll out this year)

Developed new Safeguarding CD for GP surgeries and similar venues

Newsletter published containing national news and resources

Launch of four new local groups to deliver strategic plan and link to local communities and agencies

"Living without fear" event raising awareness of safeguarding for people with learning disability

Board multi agency event on learning lessons from Winterbourne view (speakers included Serious Case Review report writer)

Board implemented an action plan around the Winterbourne View recommendations for keeping people with learning disability safe



Highlights of Year to March 2013

Taken learnings from key national serious case reviews and implemented actions to mprove protection of vulnerable adults


Developed a review process for Safeguarding incidents which are below the SCR threshold are disseminated and practices improved across agencies

Multi agency risk tool developed and rolled out


Developed new relationships around the changing health commissioning landscape






- •In 2012-13, 4104 alerts were received. This was an increase of 32% when compared to 2011-12. Across England, alerts increased by 19%.
- 865 safeguarding referrals were received in 2012-13 representing an increase of 6% when compared to 2011-12. Across England, referrals increased by 4%.
- 658 safeguarding referrals were completed in 2012-13 which was an increase of 3% over the previous year. Across England, completed referrals increased by 2%.






- 3% increase in the 85+ age group, following a 7% increase in the previous year.
- 5% decrease in the 18-64 age group, following a 2% decrease in the previous year.
- •65% of referrals were for people aged 65+. Across England this figure was 61%.







Location of Alleged Abuse %



- 3% increase in 'Own Home' to 33%. Across England this was 39%.
- 1% increase in 'Care Home' to 44%. Across England this was 36%.
