

## **Stoke Action Plan 2012-14**

#### **Stoke Action Plan**

This Stoke Action Plan originated as a result of residents' 'Planning for Real' project undertaken during 2011. As a part of this process, local people identified improvements that could be made in their community which they believed could increase community pride and opportunity, make everyone feel safer and healthier and enhance the local environment. Guildford Local Strategic Partnership (LSP) considered those suggestions and agreed to evaluate how statutory partners, local business and the voluntary sector might respond and where possible support the community to work towards achieving those aims.

The Action Plan sets out the proposed actions to be undertaken to address the priorities identified through the Planning for Real project under the following themes:

- Reduce crime and feel safer
- Improve work skills, training and education opportunities
- Improve the health and wellbeing of residents
- Improve community, leisure and recreation facilities
- Improve the environment
- > Improve traffic and transport
- Improve housing

Whilst the Action Plan specifies steps to be taken collectively and individually, partners have also agreed the following general principles to achieve the desired outcomes for Stoke and its residents:

- (1) Partners will make a long-term commitment to work together and join up/coordinate service provision to maximise benefits to Stoke.
- (2) Partners will ensure that senior level commitment to Stoke is reflected in plans, strategies and actions throughout their organisations.
- (3) To enable more to be achieved from existing resources, a clearer picture of what partners are doing in Stoke, including the voluntary and faith sectors, will be established.
- (4) Consultation data and intelligence will be shared, best use will be made of existing information and communication and engagement activities will be coordinated.

A key element to the successful delivery of the plan will be to network, strengthen and engage the local community, voluntary and faith groups to deliver improvements in Stoke. This could involve

- supporting the community to raise funds for projects, operate effectively and recruit volunteers
- holding networking meetings
- developing effective communication
- supporting the creation of volunteering opportunities

There is much valuable work already undertaken in the Stoke community. Partners will seek to raise awareness about existing services, assets, facilities, activities and events.
