SUBJECT: WOKING BOROUGHLOCAL TRANSPORT STRATEGY AND FORWARD PROGRAMME

AREA: WOKING

SUMMARY OF ISSUE:

This paper presents the outcomes of the development of Woking Borough Local Transport Strategy (LTS) and Forward Programme. It makes recommendations that the Committee approves the Local Transport Strategy and Forward Programme.

The county council is producing Local Transport Strategies and Forward Programmes for each district and borough in the county. The purpose of these strategies is to support the growth set out within district and borough local plans and provide a programme of transport infrastructure required to deliver this growth. They also provide an evidence base for future funding bids.

The strategies are 'live documents' which will be updated at regular intervals to ensure they remain relevant and current. They will become part of the Surrey Transport Plan.

They contain two main elements. The main document provides a commentary on the transport provision and transport problems in each district or borough. It also provides possible solutions to the identified problems.

Annex 1 contains a forward programme of transport infrastructure that we would like to see implemented in the district or borough, subject to funding. The programme would seek to address the problems identified in the main document of the strategy and mitigate the impact of future growth on the transport network.

RECOMMENDATIONS:

Woking Joint Committee is asked to:

(i) Approve the Woking Borough Local Transport Strategy and Forward Programme (see Annex 1), and its suggested objectives.

REASONS FOR RECOMMENDATIONS:

Delivering the Woking Borough Local Transport Strategy will support the county council's priorities to promote sustainable economic growth and secure investment in infrastructure. It also supports the borough council's vision to reduce the negative impacts of traffic. The Woking Borough Local Transport Strategy will benefit Surrey residents and businesses driving the economy, accommodating sustainable population growth and reducing impacts on the environment.

1. INTRODUCTION AND BACKGROUND:

- 1.1 The Surrey Transport Plan is the county's third Local Transport Plan (LTP3). It is a statutory document. The Woking Borough Local Transport Strategy and Forward Programme form part of the LTP3; both components are included as Annex 1 to this report.
- 1.2 The documents were prepared by Surrey County Council officers, working with Woking Borough Council officers. It has been subject to officer consultation in both the County Council and Borough Council.
- 1.3 The Woking Borough Local Transport Strategy and Forward Programme was taken to the Informal Woking Joint Committee on 22 July 2014. Members of the Committee were given the opportunity to give their comments, which could then be incorporated into the Transport Strategy and Forward Programme. Other engagement has included:
 - October 2012 Informal members' workshop
 - October 2012 Planners meeting
 - November 2013 Informal Joint Committee
 - April-May 2014 further officer engagement
 - 22 May 2 July 2014 public consultation
 - 22 July 2014 Informal Joint Committee, with members being invited to comment
 - August 2014 revisions made to document following consultation
 - 24 September 2014 Formal Joint Committee
- 1.4 A public consultation was carried out from 22 May 2 July 2014 on the Surrey County Council website. Following this, revisions were made to the Woking Borough Local Transport Strategy and Forward Programme and a finalised version was produced. Details of the consultation and engagement carried out can be found in the Consultation Report (Annex 2).

2. ANALYSIS:

- 2.1 The strategy aims to identify current problems and issues on the borough's transport network and where possible, list possible solutions to these problems and issues.
- 2.2 The strategy will become part of the Surrey Transport Plan.

3. OPTIONS:

3.1 As and when schemes are developed possible options will be investigated and evaluated.

4. CONSULTATIONS:

- 4.1 Following extensive engagement, outlined in section 1 above and including the Woking Borough Informal Joint Committee on 22 July 2014, the draft Local Transport Strategy and Forward Programme has been subject to a 6 week online public consultation, including close working with the Borough Council and officers at Surrey County Council.
- 4.2 As a result of the public consultation some changes have been made to the Local Transport Strategy and a summary of these can be found in a full consultation report in Annex 2 to this report.

5. FINANCIAL AND VALUE FOR MONEY IMPLICATIONS:

5.1This report only provides estimated costs of possible schemes scheduled within the Forward Programme.

6. RISK MANAGEMENT:

6.1 There are no foreseeable risks in this strategy as the scheme specifics from the Forward Programme are unknown.

7. LOCALISM:

7.1 The Woking Borough Local Transport Strategy is a borough wide document which seeks to address transport issues and opportunities across the entire borough area. Specific schemes will have local impacts in their specified areas, and these will be assessed when a scheme is brought forward. The Forward Programme will be updated on an annual basis and will offer the opportunity for local input to be included in the programme during these revisions.

8. EQUALITIES AND DIVERSITY IMPLICATIONS:

- 8.1 An Equalities Impact Assessment (EIA) has been drafted for the Woking Borough Local Transport Strategy and Forward Programme.
- 8.2 No negative impacts on any protected characteristic group were identified.
- 8.3 No changes have been made to the Local Transport Strategy and Forward Programme as a result of the EIA.

9.1 Sustainability and Public Health implications

Increased walking and cycling, where it replaces motorised forms of transport such as the car, will improve air quality and reduce carbon emission levels, which is a key objective of the Local Transport Strategy.

Transport is responsible for one third of carbon emissions in Surrey. Surrey's Local Transport Plan has a target to reduce carbon emissions from (non-motorway) transport by 10% (absolute emissions) by 2020, increasing to 25% reduction by 2035 from 2007 baseline of 2,114k tonnes.

Increased walking and cycling has a positive impact on personal health. The NHS identifies cycling as an activity which provides significant health benefits.

It is expected that increased levels of walking and cycling to and around the town centre will have a positive effect on the local economy with recent studies suggesting that pedestrians and cyclists actually spend more on a trip into a town than motorist.

10. CONCLUSION AND RECOMMENDATIONS:

- 10.1 The Woking Borough Local Transport Strategy and Forward Programme has been produced to support the development set out within the borough local plan and provides a programme of transport infrastructure. It also provides an evidence base for future funding bids.
- 10.2 It is recommended that the strategy is approved by the committee.

11. WHAT HAPPENS NEXT:

11.1 The Woking Borough Local Transport Strategy will be taken to a Surrey County Council Cabinet and Full Council. Subject to approval it will then be a public document on the SCC website as part of the Surrey Transport Plan. The Local Transport Strategy will be updated at regular intervals, and the Forward Programme will be updated annually.
