<p><b>Executive Director Health, Wellbeing and Adult Social Care</b> <b>Name:</b> Helen Atkinson</p>	<p>Jointly responsible with the Chief Executive and other Executive Directors for the overall performance of the paid service</p> <p>The statutory Director of Adult Social Services under "Guidance on the Statutory Chief Officer Post of the Director of Adult Social Services" (2006), with overall responsibility for services to older people, people with learning, physical and sensory disabilities, people with mental health problems and substance abuse</p> <p>The statutory Director of Public Health as defined under "Directors of Public Health in Local Government – roles, responsibilities and context" (2012), and as defined under the National Health Service Act 2006 and the Health and</p>

<b>Executive Director for Highways, Transport and Environment</b> <b>Name:</b> Jason Russell	Jointly responsible with the Chief Executive and other Executive Directors for the overall performance of the paid service.  Overall responsibility for the Council's highways and infrastructure..
<b>Executive Director Economy, Growth and Commercial</b> <b>Name:</b> Tracie Evans	Jointly responsible with the Chief Executive and other Executive Directors for the overall performance of the paid service.  Overall responsibility for leading the Council's asset and property programmes and developing working opportunities to drive income generation.
<b>Director of Finance</b> <b>Name:</b> Sheila Little	The Council's S151 officer, responsible for managing the Council's Finance Service, for determining the Council's administration and financial management framework, and for providing lending, borrowing, investment, insurance, corporate governance and risk management services to the Council.
