What policy, function or service change are you assessing?	Stamford Green Primary School is a three-form entry primary school in the borough of Epsom & Ewell, rated Outstanding by Ofsted in 2015. The school currently also offers childcare for 2 – 4 year olds under section 27 of the Education Act 2002 which enables Governing bodies of maintained schools to set up and run facilities and services, whose provision furthers any charitable purpose for the benefit of (a) pupils at the school or their families, or (b) people who live and work in the area in which the school is situated.

A virtual public consultation meeting was offered on the 2 nd March 2021 A survey was published on the Surrey County Council consultation website 'Surrey Says' between 22 nd February 2021 and 19 th April 2021. A total of 9			



	<p>responses were received, most responders (89%) agreed with the proposal to lower the school age at Stamford Green Primary School.</p> <p>Consultation packs detailing the proposal were distributed to all staff at Stamford Green Primary School. Parents of pupils could have obtained a copy of the consultation from the school or online.</p> <p>Statutory notices were published the 13th May 2021 and ran for a period of 4 weeks. These were posted on the school gate/noticeboard, published in the local press, and on the 'Surrey Says' website.</p> <p>There were no responses to the consultation during the statutory notice period.</p> <p>The following data has also been used:</p> <ul style="list-style-type: none">• School census records of children currently on roll at Stamford Green Primary Infant School (October 2020)• English indices of deprivation 2019
