Key Issue

To inform Members of the current liability to maintain bridges over the canal and the condition of bridges as at the last condition assessment in January 2010.

Summary

That the condition of bridges was last thoroughly assessed in 2010, with the condition then being in "fair" condition and remedial works having since been carried out.

1 Introduction & background

- 1.1 Most Canals authorised under an Act of Parliament require that the company authorised to run the Canal were liable for the maintenance of bridges carrying private roads, public rights of way or public roads over or under their canal – that was indeed the case with the Basingstoke Canal under the original Basingstoke Canal Act of 1778.
- 1.2 The Basingstoke Canal Company became insolvent in 1869 and was wound up in 1878; the Receiver selling the assets of the company in 1874 to a single private individual – William St Aubyn. Through the latter years of the C19th the Canal went through a succession of private owners and limited companies who managed with decreasing success to make the Canal profitable.
- By 1910 the condition of the bridges carrying public highways over the Canal was causing 1.3 Woking Urban District Council¹ such concern that they independently sought an Act of Parliament to enable them to repair the bridges and recover the cost of any works carried out from the Basingstoke Canal Company or their successors.
- 1.4 In 1912 Woking UDC carried out works to the bridges and sought to recover their costs from mortgagee of the Canal, William Carter, as the owning company was insolvent². That civil case never reached trial with Woking UDC and Carter reaching agreement. The Canal Company however took a summons against Woking UDC on the basis they were not the successor to the original company and were not liable for the bridges. In the High Court their case failed. However the Canal Company appealed, resulting in a landmark Appeal Court decision - which affected the history of the Canal.

- 1.5 The Court of Appeal held that the owners of the Canal were not the successor to the original Canal company, as they only had title to the land through possession of the land since 1874 and further that they could not be carrying on a public undertaking under the Canal Act as the waterway had become a private property on the cessation of the original company. They ruled that the original Act was still in force, but spent as the original company had been wound up and assets sold *ultra vires* by the Receiver. The powers and duties of the original company had not been transferred to any successor, as a further Act would have been required to do this, which had not been sought.
- 1.6 As far as bridges were concerned the Court therefore ruled that the then current and any subsequent owners of the Canal deriving their ownership through the possessory title obtained by William St Aubyn had no liability to maintain them. They went on to suggest that Surrey and Southampton [*sic*] County Councils as the Highway Authority were liable to repair bridges "of public utility" built before 1803 unless someone else was liable to maintain them.
- 1.7 Successive legal opinions obtained by Surrey County Council since it took ownership of its part of the Canal in 1976 have agreed with the 1913 case.

2 Liabilities to maintain

- **2.1** The County Councils who now own the Canal find themselves in an unusual position. As the owners of the Canal they have no liability to maintain any of the original canal bridges.
- 2.2 As the Highway Authority for public roads and rights of way however they are liable to maintain any of the bridges carrying public rights which were erected before 1803 (i.e. any of the original canal bridges). Any road bridges erected subsequently would also be the responsibility of the County Councils as Highway Authority under later statutory duties.
- 2.3 There is some uncertainty over who precisely is liable to maintain any of the original bridges solely carrying private rights. It is likely that no-one is now responsible for their maintenance; but both those who have rights to use the bridge and the County Councils as owner of the Canal are both likely to have a duty of care to stop the bridge from becoming dangerous to persons using the private right of way, or the public using the Canal. More recent private bridges such as the Bedser Bridge at Woking have a legal agreement between the Canal and bridge owners governing maintenance.
- 2.4 Rail bridges were all constructed after the Canal and are therefore responsibility of the rail company to repair under the various enabling Acts for the railways those liabilities currently rest with Network Rail.
- 2.5 The County Councils as owners of the Canal are liable for are those bridges which were erected subsequent to the purchase of the Canal. These are principally the lock tail bridges and the swing bridge at the Canal Centre which are designed for Canal users only. These are the responsibility of the BCA to maintain on an operational level on behalf of the owning Countryside Departments, who would currently be liable for capital renewals.

3 Bridge Stock

3.1 In January 2010 Surrey County Council compiled an Asset Condition report during the preparation of the 4th Edition of the Canal's Asset Management Plan. This report concluded that there were 108 bridges over the Canal (including the remains of

several now demolished bridges), and three aqueducts carrying the Canal over other features. Of these the BCA, on behalf of the owning Countryside Departments, are liable for 30 bridges (29 smaller mainly pedestrian lock tail bridges maintained as part of the adjacent lock, plus 1 swing bridge), there are 30 bridges registered for structural inspection in each County by the Highways / Structures Departments (i.e. a total of 60 bridges). The remainder are mainly rail bridges which are the responsibility of Network Rail.

- 3.2 A complete asset inventory of canal over-bridges are appended as Annexe 1.
- 3.3 One aqueduct is the responsibility of Network Rail, one the responsibility of Surrey County Council's Highways Department, and one the responsibility of the BCA / Hampshire County Council's Countryside Department.
- 3.4 Inspection data for six registered bridges and all of the aqueducts and was identified as inadequate and requiring further investigation.
- 3.5 The report considered the condition of each structure registered with the Highways / Structures Departments of each County Council using the County Surveyor's Society Bridge Condition Index. It found that the bridge stock in each county was overall in "fair" condition with an estimated £226,000 of outstanding work in Surrey and £41,700 in Hampshire. This work was added to the bridge programmes of each of the County Councils, and is gradually being carried out.
- 3.6 Despite the bridge stock being in overall very similar condition the difference in values of outstanding work appears to be in a difference of interpretation between the two County Councils, with Surrey estimating the work required to bring each bridge back to "as new" condition, whereas Hampshire only estimating the work to keep the bridge serviceable.
- 3.7 This report has not been subsequently updated to reflect any works carried out in the intervening three years.
