<b>Interim Section 151 Officer and Director of Finance – Corporate and Commercial</b> <b>Name:</b> Anna D'Alessandro	The Council's S151 officer, responsible for managing the Council's Finance Service, for determining the Council's administration and financial management framework, and for providing lending, borrowing, investment, insurance, corporate governance and risk management services to the Council.
<b>Executive Director for Children, Families and Lifelong Learning</b> <b>Name:</b> Rachael Wardell	Jointly responsible with the Chief Executive and the Executive Directors for the overall performance of the paid service.  The Statutory Director of Children's Services under section 18 of the Children Act 2004 with overall responsibility for these services.
<b>Executive Director for Adult Social Care &amp; Integrated Commissioning</b> <b>Name:</b> Helen Coombes (interim)	Jointly responsible with the Chief Executive and other Executive Directors for the overall performance of the paid service  The statutory Director of Adult Social Services under "Guidance on the Statutory Chief Officer Post of the Director of Adult Social Services" (2006), with overall responsibility for services to older people, people with learning, physical and sensory disabilities, people with mental health problems and substance abuse
