		school gate and this causes havoc. Since the St Joseph's parents have been using Whitehorse Drive, things have become even worse. I understand that there is a dire need for something to change – but this needs
		to be done in a way that is not to the detriment of the residents of these three roads.
		'Residents only' parking would be a solution. This cannot become a money-making scheme for the Council – we give enough – free residents badges need to be given to each household to enable us to park outside
		our houses as and when we need to.

Safe and sustainable transport to school is a priority for any school and Council, the proposal for White Horse Drive will only have the opposite effect by encouraging more car journeys to the school and be detrimental to the safety of students walk along the lane past St Josephs and Rosebery School therefore the flow of people must be considered to be in both directions at the end of White Horse Drive namely pedestrians from Epsom Centre / Station side and cars dropping off for St Josephs. Remove some of those parked cars and vehicles travel a lot faster. Despite being parents and concerned for their own childrens well being many people seem to be in a hurry particularly when dropping off their children first thing and collecting them later. My experience of living here for 18 years would suggest that less legitimately parked cars mean cars will be more likely to speed down the road causing all manner of safety concern. If however the primary school parents were able to park on Margarets Drive then this would be less of an issue. I say this because the primary school parents are the ones who need to get to the end of Whitehorse drive to drop off their offspring. Indeed if the primary school parents used that suggested alternative we would have much fewer issues anyway.  Additional tax - I have paid my council tax always and object to facing an additional 'residents parking tax' because Epsom cannot police its roads correctly. The current proposal would mean I would need to purchase tickets in order to park next to my own home as nobody is in a position to remove a vehicle for the restricted times if they are at home. 		The premise that these proposals would assist in drop off and pick up from local schools is totally miss-founded. Spaces on Elm Grove are taken within minutes of becoming available throughout the working day, from about 6am to 7pm. The road was completely closed to parking recently while street cleaning was taking place. Within 5 minutes of the parking ban being lifted, every parking space was taken and remained
		so until the evening. There is a constant stream of traffic along our cul-de-sac by drivers looking for somewhere to park, and space is not determined by all-day parkers. Since the proposed no parking times are
		not co-incident with school collection or pick up times, there would be just as few places available with these proposals for school traffic, which in any event should not be encouraged to use our very congested local roads.

		Not only the parking but the congestion in Whitehorse Drive during the morning and afternoon school runs has always been terrible. Despite letters to the parents/carers of the Rosebery pupils (speaking as past
		parents to a pupil of Rosebery) they continue to drive down the full length of this cul-de-sac, unable to judge the gaps and size of their cars and unable to keep the flow of traffic moving. This has now been
		exasperated by St Joseph's School telling the parents/carers to use Whitehorse Drive to park and drop off their children, although we were promised that the primary school children would not be using the road
