2	21 Sept 2018	<p>(i) Petition: improvements to roads in the vicinity of Potters Gate School, Farnham.</p> <p>A new lower 20 mph zone or limit along the whole extent of Beavers Road, Falkner Road and Potters Gate. This will be supported through the implementation of traffic calming or two vehicle activated signs on Falkner Road or Beavers Road.</p> <p>The proposals will be funded from “section 106” contributions from the developer of the nearby housing development of “Hopfields”. Note: this development is now being marketed by the developer as ‘Abbey View’.</p>	OPEN	Highways – Transport Development Planning Officer / Maintenance Engineer (Road Safety and Active Travel Team responded to the petition)	<p>The developer has advised that it is not going to pay their S106 contribution any earlier than is required by the legal agreement.</p> <p>The first instalment of S106 money for highway improvements (£111,685) has now been paid by the developer, and the package of measures to be delivered as part of the school expansion were approved by the County Council’s Planning Committee on 22 October 2020.</p> <p>The proposed package of works can now progress to the detailed design stage, and it is anticipated that work will commence on site in Spring 2021.</p>
5		<p>PETITION RESPONSE</p> <p>PETITION FOR 7.5 TONNE WEIGHT RESTRICTION, STATION LANE, SALT LANE AND MARKWICK LANE.</p>	OPEN	Area Highway Manager (SW)	<p>The Local Committee decided on 19 June 2020 that this should be added to the Decision Tracker to monitor HGVs on rural roads between Cranleigh and the A3, including Markwick Lane.</p> <p>An HGV survey has now been funded and ordered and the results will be provided to the Local Committee, when available.</p>
