SUBJECT: HIGHWAYS UPDATE

DIVISION: ALL

# **SUMMARY OF ISSUE(S):**

Officers have worked with Members to agree priorities for this Financial Year's Capital Maintenance programme of carriageways, footways and kerbs.

Preparations are progressing to implement the Kingston Road (Aldi) Puffin Crossing later this Financial Year.

A Traffic Regulation Order is needed to enable the section of Old London Road leading from Tattenham Corner Road to the Top Car Park on Epsom Downs to be closed overnight.

### **RECOMMENDATIONS:**

## The Local Committee (Epsom & Ewell) is asked to:

- (i) Agree the 2021-22 programme of Capital Maintenance schemes, as detailed in Table 2 below, and to authorise the Area Team Manager, in consultation with the Chairman, Vice Chairman and Divisional Member to amend this programme as appropriate should unforeseen circumstances arise that would put the programme at risk of delivery (paragraphs 2.3 and 2.4 refer);
- (ii) Authorise the Area Highway Manager, in consultation with the Chairman, Vice Chairman and Divisional Member, to advertise a legal notice for a new Puffin Crossing on the A240 Kingston Road, between Aldi on one side of the road and Timbercroft on the other, and to resolve any representations that are received (paragraph 2.5 and Annex A refer);
- (iii) Authorise the Area Highway Manager, in consultation with the Chairman, Vice Chairman and Divisional Member, to advertise a permanent prohibition of traffic order to prevent motor vehicles entering the section of Old London Road between Tattenham Corner Road and the Top Car Park on Epsom Downs overnight, as detailed in Table 3 below, and to resolve any objections that may arise (paragraphs 2.6 and 2.9 refer);
- (vi) Authorise the Area Highway Manager in consultation with the Chairman, Vice Chairman, and relevant Divisional Member(s) to undertake all necessary procedures to deliver the agreed programmes.

### **REASONS FOR RECOMMENDATIONS:**

A programme of capital maintenance schemes needs to be agreed to invest Committee's £217,000 allocation for this purpose. Officers have worked with Members to agree priorities. However, should unforeseen circumstances arise that

might put the programme at risk, the Area Highway Manager needs flexibility to amend the programme as appropriate.

A new Puffin Crossing is due to be implemented this Financial Year 2021-22 on the A240 Kingston Road between Aldi and Timbercroft. Before any new traffic signal controlled crossing is installed, a legal notice is necessary to inform the local community and give opportunity for representations to be made.

#### 1. INTRODUCTION AND BACKGROUND:

- 1.1 Surrey County Council's Local Transport Plan (LTP) aims to improve the highway network for all users. In general terms it aims to reduce congestion, improve accessibility, reduce the frequency and severity of road casualties, improve the environment, and maintain the network so that it is safe for public use.
- 1.2 The Local Committee in Epsom & Ewell has been delegated Highways budgets to be able to contribute to the objectives set out in Surrey County Council's LTP, according to local priorities.

#### 2. ANALYSIS:

2.1 Committee's budget allocations for 2021-22 are shown in Table 1 below:

- 2.2 Committee agreed which schemes to promote with its £247,000 for Integrated Transport Schemes (ITS schemes) in March 2021.
- 2.3 Officers have been working with Members to agree priorities for Committee's £217,000 capital maintenance allocation. Table 2 below shows the agreed priorities. These have been selected to ensure so far as is reasonably practicable that an even share of funding will be invested in each Division.
- 2.4 It is recommended that Committee agrees the programme of work shown in Table 2 below, and authorises the Area Highway Manager, in consultation with the Chairman, Vice Chairman and Divisional Member to amend this programme as appropriate, should unforeseen circumstances arise that puts the delivery of the programme at risk.

- 2.5 One of the schemes in Committee's programme of ITS schemes for 2021-22 is a new Puffin Crossing on the A240 Kingston Road, between Aldi and TImbercroft. Annex A shows the location and layout of the proposed new crossing. Before any controlled crossing can be installed including traffic signal controlled crossings a legal notice must be advertised. This enables residents and other road users to make representations in response to the design of the crossing. It is recommended to authorise the Area Highway Manager, in consultation with the Chairman, Vice Chairman and Divisional Member, to advertise the legal notice for the new Puffin Crossing, and to resolve any representations that are received.
- 2.6 In the late 1990s Epsom & Ewell Borough Council approved the advertisement of a prohibition of traffic order for the section of Old London Road that runs between Tattenham Corner Road and the Top Car Park on Epsom Downs. At the time Epsom & Ewell Borough Council was acting as Highway Authority under an agency agreement with Surrey County Council. The prohibition of traffic order was intended to prevent motor vehicles entering this section of Old London Road overnight.
- 2.7 Unfortunately neither Epsom & Ewell Borough Council nor Surrey County Council have any record that the intended prohibition of traffic order was sealed. Nevertheless, Old London Road has been closed overnight since the late 1990s. This is generally accepted by the local community as part and parcel of the operation of the Downs. It is therefore recommended to advertise a prohibition of traffic order to prevent overnight motor vehicle access into Old London Road from Tattenham Corner towards the Top Car park, with the hours of operation and exemptions as detailed in Table 3 below.
- 2.8 The proposed hours of operation have been requested by the Epsom & Walton Downs Conservators following their meeting of 21<sup>st</sup> June 2021, and would be an extension of the hours that have been operating on the ground since the late 1990s. 2.9 Committee is asked to delegate authority to the Area Highway Manager to progress the legal process in consultation with the Chairman, Vice Chairman and Divisional Member and to resolve any representations that are received.
