1. SURREY CHOICES JOINT STRATEGIC PLAN 2019 - 2024 REVIEW AND UPDATE AUGUST 2021

RESOLVED:

2. 2021/22 BETTER CARE FUND PLANNING TEMPLATE AND NARRATIVE PLAN SUBMISSION

(i) Details of decision

The Surrey-wide Commissioning Committees noted the 2021/22 Better Care Fund Submission, noting the national planning conditions had been met; including the minimum CCG funding contribution, the minimum funding allocation to NHS Commissioned Out of Hospital Spend, and minimum funding allocation to Adult Social Care services.

(ii) Reasons for decision

Following a very tight timescale that has been set nationally, the 2021/22 Better Care Fund submission and updated narrative for Surrey has been agreed following local discussions with a wide range of stakeholders, including strategic leaders, finance colleagues, and commissioners. The areas of spend set out in the plan will support joint working to deliver integrated, holistic services that put Surrey residents at the centre of their health and social care services. Although the approval of the Commissioning Committees-in-Common is not specifically required by the Better Care Fund submission process, it is good practice to ensure partners across the Council and the relevant CCGs are sighted on the final document.

3. PART 2 REPORT: PROCUREMENT OF RESIDENTIAL AND NURSING CARE HOMES DPS SERVICES:

(i) Details of decision

The Surrey-wide Commissioning Committee/s approved the Procurement plan for Residential and Nursing Care Homes Dynamic Purchasing System services and approved the Continuing Health Care guide price.

(ii) Reasons for decision

The current Surrey CHC framework for Cares Homes with Nursing is in place to the end of March 2022. Surrey County Council currently have a Memorandum of Understanding in place for Residential Care with or without Nursing until the end of March 2022.
